2. **SHEET M4.1 (Lab Controls)**: Refer to "Specific Sequence Of Operation", Delete "Trane BAS Controls Subcontractor". (Note: Current AHU Start/Stop Schedule and Space Temperature Control will remain "as-is". In addition, the existing Exhaust Fans will remain associated with the current AHUs.)
3. **SHEET M4.1 (Lab Controls)**: Refer to "Fume Hood Exhaust Fans (Typical)", This Scope of Work will be performed by the Lab Controls Contractor. (Note: Existing exhaust fan controls and Lead/Lag Controls will remain as-is. Also See Typical Laboratory Fume Hood Exhaust Control Diagram 'Boxed' note: "Note: Lab Control Subcontractor shall complete new controls work. Existing controls shall remain.")
4. **SHEET M3.1 (Mechanical Details)**: Refer to "Lab Hood Exhaust Detail", Delete "Zero Leakage and replace with SMACNA Class 3 Leakage".
