The State of Florida, Department of Military Affairs (DMA), Construction & Facility Management Office (CFMO) requests qualifications from qualified professional services firms for Architectural-Engineering (A/E) services for DESIGN/COMMISSIONING of the Scout/REECE Gunnery Complex to be located at Camp Blanding Joint Training Center, Starke, Florida.

Request for any additional information, clarifications, or technical questions must be in writing, to the POC listed above.

Respondents to this solicitation or persons acting on their behalf may not contact, between the release of the solicitation and the end of the 72-hour period following the agency posting the notice of intended award, excluding Saturdays, Sundays, and state holidays, any employee or officer of the executive or legislative branch concerning any aspect of this solicitation, except in writing to the procurement officer or as provided in the solicitation documents. Violation of this provision may be grounds for rejecting a response.

SERVICES TO BE PROVIDED: This Agency will contract with a single entity who shall provide all services per NGR 415-5, Architectural-Engineering Services for Site Investigation, Design, Bid Phase and Construction Administration, including but not necessarily limited to, topographical and utility survey(s), soils report, attendance at user design conferences to finalize the project design, prioritize project components/additive bid items, programming, schematic and preliminary designs, preconstruction services, constructability reviews, complete design and engineering services, life cycle cost analysis, construction bid documents and technical specifications, detailed line-item construction cost estimates, general storm water permit (acquisition of permit or modification), compilation of preliminary Department of Defense (DD) Form 1354 (NGB form format to be provided by Owner), and Construction Administration services required to provide a complete facility. The A/E will also need to provide technical assistance and

signed/sealed documents to aid the General Contractor to secure the required building permits and the Florida State Fire Marshal review permit.

EXECUTIVE PROJECT SUMMARY: Provide design services for a standard designed Scout/REECE Gunnery Complex at Camp Blanding Joint Training Center (CBJTC), Starke, Florida.

This project includes automated target systems (ATS) to train and test scout vehicle crews on the skills necessary to detect, identify, engage and defeat stationary / moving infantry and stationary / moving armor targets in a tactical array. The range will be designed with automated target systems (ATS) varying controlled and scored by computer in the control tower. This facility will be designed to meet Industrial Standards as well as local, of Florida, Federal building codes and as per Public Law 90-480 and 900-400. Design will include Scout/REECE firing points, range control tower, operations storage, ammo loading dock, ammo breakdown, latrine, bleacher enclosure, covered mess, trench obstacles, AAR/small, bivouac area, unit staging area, all targets, sustainability/energy measures, parking, fencing, walks, flags and barriers, signs, all utility services, information systems, site improvements, erosion control and drainage, security lighting and anti-terrorism/force protection. Facilities will be designed to a minimum life of 50 years and energy efficiencies meeting, on average, American Society of Heating, Refrigeration and Air-conditioning Engineers (ASHRAE) 189.1 standards through improved building envelope and integrated building systems performance. Access for individuals with disabilities will be provided. Antiterrorism Measures are to be included in accordance with the DOD Minimum Antiterrorism for building standards will be provided.

Camp Blanding Joint Training Center is a 72,000-acre Maneuver Training Center. Camp Blanding is centrally located in Florida, and has the capacity to receive units by air, rail, or roadway. The electrical, sewage, water, telecommunication, and transportation infrastructure can support the addition of the Scout/REECE Gunnery Complex. The Scout/REECE consists of a two lane course road. It will include audio/video capture instrumentation, three-dimensional precision targetry and a large interactive command / control / AAR facility.

Building Criteria requirements:

The criteria which will be used for construction is the Training Circular (TC)25-8, Training Ranges; TC 90-1, Urban Operations; and the Huntsville Design Manual (COE)HNDM-1110-1-23.

EXCEPTIONS TO CRITERIA:

Incorporation of a standard Camp Blanding latrine design. This will provide added value to training by the reduction of training time lost to using units' maintenance of the facility and the provision of potable water availability.

Operations/Storage Building to be increased to 2600 sf to provide a remote operations and maintenance facility to serve multiple ranges in this training area. It is approximately 40 min drive to cantonment area. This will help minimize maintenance man-hours, range support time gas and

vehicle wear.

Partially covered Ammo Loading Dock to protect soldiers from extreme heat and rainfall. The avg high temperatures exceed 90 degrees F during June through August time period. Camp Blanding received approximately 20" of rain during that time period. Camp Blanding responded to 130 medical heat casualties in 2009 alone.

Overflow parking area for civilian vehicle parking. Personnel travelling to the range in Privately Owned Vehicles (POV) are not authorized to park in the main range complex or on the range complex side of the road.

Enlarged Target Operations and Storage Building (2600 s.f.) to accommodate larger targetry associated with a Scout/REECE Gunnery Range.

Design Criteria:

Florida Building Code (FBC); latest version at the time the design contract is awarded. Applicable Local Building Code. NOTE: Designs must meet current Florida Building Codes and ADA requirements. All structures will be engineered to meet applicable wind load requirements for the area. Unified Facilities

Criteria (UFC) DoD Minimum Antiterrorism Standards for Buildings UFC 4-010-01 (8 OCT 2003) requirements will also have to be met.

SELECTION INFORMATION: Selection of applicants for consideration will be made on the basis of relative design experience of the firm and their ability to perform based on, but not limited to, the information submitted on FNG Form 5112 for licensed and/or professional personnel; professional services qualifications, financial capability, recent, current, and projected workloads of the Professional Services firm and location of office in relation to project site. The qualifications packages will be reviewed and three semi-finalists will be interviewed to determine the best qualified firm for this project. The three semi-finalists may or may not be required to make oral presentations (in person or by telephone conference) and the selection committee may reject all submissions and stop the selection process at any time. Additional requirements and information may be provided to short-listed firms at the Mandatory Site Visit (if required). Order of Negotiations for the selected shortlisted firms will be made on the basis of past performance references, knowledge of site and local conditions, proposed project staff, ability to meet budget, ability to meet project schedule, understanding program, requirements, approach, and methodology.

CONTINGENCY STATEMENT: "The Architect (or registered land surveyor or professional engineer, as applicable) warrants that he has not employed or retained any company or person, other than a bona fide employee working solely for the architect (or registered land surveyor or professional engineer, as applicable) to solicit or secure this agreement and that he has not paid or agreed to pay any person, company, corporation, individual or firm other than a bona fide employee working solely for the architect (or registered land surveyor or professional engineer, as applicable) any fee, commission, percentage, gift, or any other consideration contingent upon or resulting from the award or making of this Agreement. If no protest is filed, a contract will be negotiated with the firm which the Agency considers the most qualified for the intended project. If an agreement for compensation which the Agency determines is fair, competitive, and reasonable cannot be reached and the Agency is unable to negotiate a satisfactory contract, negotiations will be formally ceased and negotiations shall be undertaken with the firm the Agency has determined is the second most qualified after Departmental review of the submissions.

The DMA reserves the right to accept or reject any or all proposals received and reserves the right to make an award with or without further discussion of the proposals submitted or accept minor informalities or irregularities in the best interest of the State of Florida, which are considered a matter of form and not substance, and the correction or waiver of which is not prejudicial to other Proposers. Minor irregularities are defined as those that will not have an adverse effect on the Department's interest and will not affect the price of the proposal by giving a Proposer an advantage or benefit not enjoyed by all other proposers. It is understood the proposal will become a part of the Departments'

file, without obligation to the Department. Proposals may be rejected if found to be irregular or not in conformance with the requirements and instructions contained herein. A proposal may be found to be irregular or non-responsive by reasons that include, but are not limited to failure to utilize or complete in their entirety prescribed forms, conditional proposals, and improper, missing and/or undated signatures.
