Written notices, formal requests and proceedings must conform with the requirements set forth in Chapter 28-110, Florida Administrative Code (F.A.C.). Protests must be filed with the Purchasing Office, Fish and Wildlife Conservation Commission, 2590 Executive Center Circle, Suite 100, Tallahassee, Florida 32301 within the time prescribed in Section 120.57(3), F.S. and Chapter 28-110, F.A.C.

BEGIN ADDENDUM

Item 1: Responses to Written Questions

QUESTION #1

Will this project require a temporary Boiler System during the change out?

ANSWER #1

If the boiler down time is two weeks or less, and the ambient temperature is above 60 degrees, no temporary heating is required.

QUESTION #2

Core drilling noise – is there a specific time it needs to be done? Daytime hours? Will you know ahead of time when you can do it?

ANSWER #2

The contractor will be allowed to do this coring during daytime hours. We will need a 7-day notice to inform the staff.

QUESTION #3

In regard to the office area [as toured during the pre-bid] work for reheat pipes: Since we're going to be working in those office areas, are we going to be able to interrupt them?

ANSWER #3

See answer #2 above.

QUESTION #4

Do you require union labor?

ANSWER #4

No.
