The Department of Management Services has issued this new solicitation for Information Technology Staff Augmentation Services, **RFP #15-80101507-SA-D, Information Technology Staff Augmentation Services – 3rd Bid.**

The Department previously cancelled and rejected all bids for **RFP #14-80101507-SA-D, Information Technology Staff Augmentation Services.** The Department also previously cancelled and rejected all bids for **#5-80101507-SA-D, Information Technology Staff Augmentation Services – Re-Bid.** These two previous solicitations, and all proposals submitted in response to the solicitations, are no longer active. Proposals that vendors have previously submitted in response to the two inactive requests for proposals will not be considered proposals in response to this new solicitation, **RFP #15-80101507-SA-D, Information Technology Staff Augmentation Services – 3rd Bid.**

In order to be considered for an award of an Information Technology Staff Augmentation contract, vendors must now submit a Proposal in accordance with the specifications and instructions provided in **RFP #15-80101507-SA-D, Information Technology Staff Augmentation Services – 3rd Bid.**

Vendors interested in bidding for a staff augmentation contract are to carefully read the entire new solicitation and respond as instructed in the **RFP #15-80101507-SA-D, Information Technology Staff Augmentation Services – 3rd Bid.**

NOTICE PURSUANT TO SECTION 287.057(23), FLORIDA STATUTES

Respondents to this solicitation or persons acting on their behalf may not contact, between the release of the solicitation and the end of the 72-hour period following the agency posting the notice of intended award, excluding Saturdays, Sundays, and state holidays, any employee or officer of the executive or legislative branch concerning any aspect of this solicitation, except in writing to the procurement officer or as provided in the solicitation documents. Violation of this provision may be grounds for rejecting a response.
