1. Question: During site prep and before pouring of concrete the plans mention these must be done in the presence of a Geotech engineer. Is that someone we hire independently, or do you provide this person and we just give notice when we do this work?

Answer: The contractor is responsible to hire this Engineer. Please include the price in the bid.

Question: Is there any chance this bid can be pushed back one week due to issues with sourcing subs during this COVID-19 disruption.
Answer: Please see revised bid submittal due date below.

Question: In the attached COVID addendum it mentions a teleconference but does not give a date and time. Has this already taken place?
Answer: All public meetings will be held via teleconference, meaning that the bid opening for this project will have a teleconference line available for any contractors wishing to take part in the meeting. This will take place on the date of the bid opening.
