NOTICE TO APPLICANTS ADDENDUM NO. TWO (2)

HONEYMOON ISLAND STATE PARK – ROADWAY REPAIR AND POND MODIFICATION Dep Bid NO. BDC36-17/18

Failure to do so may be grounds for rejection of the Bid.

The Following statements supersede & supplement the corresponding items in the specifications & drawings:

The attached documents are hereby incorporated into the bid documents:

- Relocation of Bathhouses #3 & #4
1. **Question:** What kind of license does a contractor need to hold to be eligible to bid on the project? Is a GC license required?
Response: A GC license is the only required licensed for a contractor to possess.
 2. **Question:** Is this project expected to occur at the same time as the Spur Trail project?
Response: Construction for the Spur Trail project is expected to begin in August. Construction for the Roadway Repair and Pond Modification project cannot begin

- until after Labor Day, however there is expected to be some overlap of the two projects. This project was scheduled to start after Labor Day when park attendance and traffic generally decrease significantly.
3. **Question:** When traffic is light in the Roadway Repair project area can the project be completely coned off?
Response: One traffic lane must remain open at all times.
 4. **Question:** Can the Roadway Repair work be done during night?
Response: Night working hours are acceptable to the park. Lights would need to be positioned so that they are functional for construction, but minimize any impacts to turtles. Should night working hours be proposed by a contractor, contractor must coordinate with Florida Park Service staff for approval of lighting plan. During the officially designated turtle nesting season proposed lighting would need to be assessed from the beach by Park Service staff.
 5. **Question:** Is the overburden to be excavated out of the existing pond expected to remain onsite?
Response: Contractors should include in their bid the cost to remove all fill material from the pond. The SOV must contain a detailed breakdown for excavation hauling, and a detailed breakdown for suitable fill screening and placing on dune or beach
 6. **Question:** Would overburden approved for beach use need to be stockpiled or graded down?
Response: Acceptable fill must be graded down by the contractor and adhere to the requirements in the notes on sheet C107 of the Pond Modification plans.
 7. **Question:** Will we be allowed to submit an FDOT Pre-Qualification Certificate in lieu of filling out the bid document financial information?
Response: Yes, a FDOT pre-qualification certificate will be acceptable in lieu of the financial information requested in the bid documents, but a bidder must still complete the Experience portions of the Form. The Department does reserve the right to request additional financial documentation if it deems it pertinent to the evaluation of the bid, and may request those documents after the bid opening but prior to the bid award.
 8. **Question:** Is everything on the Schedule Of Values page in the bid document required?
Response: This is a boilerplate document. Fill in everything that is applicable to this project.
 9. **Question:** Is there any proposed asphalt overlay on the project?
Response: There is no asphalt overlay proposed for the project. The proposed asphalt on the plans is all new asphalt.

10. **Question:** There is a patch in the road southeast of the intersection. Is it the contractor's responsibility to locate all utilities?
Response: All available utility information has been included in the plans or in this addendum. An old set of plans show a proposed forcemain running to the Nature Center in the area. See sheet C108 of Honeymoon Island - Relocation of Bathhouses #3 & #4 (2004).
The park dug a test pit on the north side of the patch and located an approximately 2" PVC line that was estimated to be 22" below ground level. It is the contractor's responsibility to verify the existing site conditions and utilities. If utilities are believed to be in the area and do not appear on the plans or documents provided then additional utility locates to verify the site conditions should be included in the bid price. Contractor is responsible for all utilities in the project area.
11. **Question:** Are there any cores available for the Roadway Repair?
Response: Geotech was performed for the project, which included cores on the existing roadway. The Geotech report was provided in the bid documents.
12. **Question:** What is expected to happen to the existing fencing southwest of the intersection?
Response: Existing fencing is proposed to be removed per the plans. Although not called out for in the plans, contractor must replace to match existing fence once complete with the roadway work.
13. **Question:** What about signage?
Response: Proposed signage is visibly depicted on sheet C103.
14. **Question:** Can the acceptable overburden be used to only build up the dune?
Response: The dune should be graded as shown on the planes. Any additional suitable material is to be graded out on the beach immediately adjacent to the dune between the pond and beach.
15. **Question:** Was this meeting mandatory?
Response: Attending the meeting was mandatory to be eligible to bid.
