2. ALL WORK TO CONFORM TO THE LATEST EDITION OF THE FLORIDA BUILDING CODE AND OTHER CODES HAVING JURISDICTION, INCLUDING REVISIONS AND SUPPLEMENTS TO SUCH CODES, WHETHER REFERRED TO IN THE CONSTRUCTION DOCUMENTS OR NOT.
3. GENERAL CONTRACTOR TO BE RESPONSIBLE FOR VERIFYING ALL EXISTING CONDITIONS. ANY DISCREPANCIES WITH THE DRAWINGS, DIMENSIONS, ROOM NAMES AND NUMBERS, OR OTHERWISE TO BE BROUGHT TO THE ARCHITECT'S/ENGINEER'S ATTENTION PRIOR TO CONSTRUCTION.
4. MEN/WOMEN BATHROOM RENOVATION OF NEW FLOOR / WALL TILES AND REPLACEMENT OF PLUMBING FIXTURES AND ACCESSORIES.

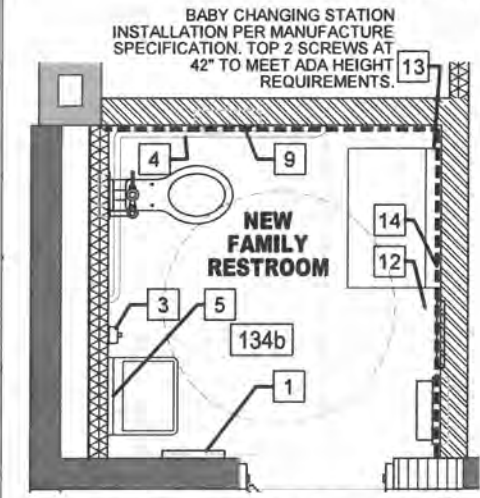
**1 EXISTING/DEMOLITION FLOOR PLAN**

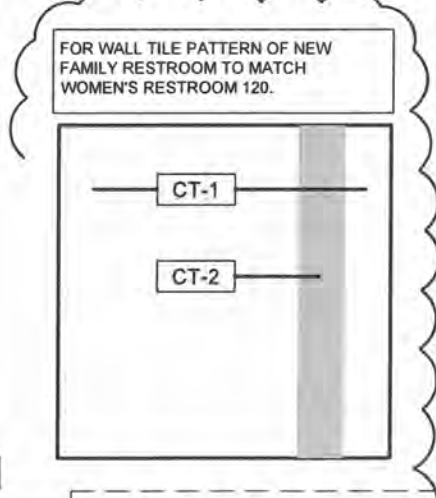
**2 FLOOR PLAN**
