Password: 2020022</i></p> <p><i>Section 3.03 a) of the ITB states: The Contractor shall remove all tires from the Site located at 15533 State Road 29 S., Immokalee, Florida 34142, to a permitted waste tire processing/disposal facility. Therefore, identification of the permitted waste tire processing/disposal facility is the responsibility of the contractor, and these facilities can be obtained from the Department's website at <a href="https://floridadep.gov/waste/permitting-compliance-assistance/content/solid-waste-section">https://floridadep.gov/waste/permitting-compliance-assistance/content/solid-waste-section</a>.</i></p>
2.	3.03 (a)	14	<p>Do cypress trees or any other vegetation have to be protected?</p> <p><i>Answer #2: Based on site conditions, it is not anticipated that any vegetation will be impacted by the removal of the tires. Section 3.03 b) of the ITB states the Contractor shall practice safe and efficient methods of loading trailers and lacing tires to maximize hauling efficiency. In addition, Section 3.03. g) states the Contractor must adhere to general county requirements when performing the required work as outlined in the Scope of Work.</i></p>
3.	3.03 (b)	14	<p>Debris other than tires were noted during site walk. Should unit pricing for C&amp;D disposal be provided?</p>

			<i>Answer #3: These items are not required to be removed from the site and pricing for C&amp;D disposal is not needed.</i>
4.	3.03 (d)	14	Is application of Larvacide still required if all water and debris is removed from within tires? <i>Answer #4: Yes, item 3.03 d) ITB specifies all tires must be treated for mosquitoes with Larvacide before they are transported off the Site.</i>
5.	N/A	N/A	The site is described as the Weeks/Dyer site, during the site walk we were only granted access to the property at 15533 SR 29. Will any tires need to be removed from the adjacent property and if so how many can be expected on that property? <i>Answer #5: Section 3.03 a) of the ITB states the Contractor shall remove all tires from the Site located at 15533 State Road 29 S., Immokalee, Florida 34142, to a permitted waste tire processing/disposal facility. There are approximately 11,500 passenger tire equivalents (PTE) on the Site. No other tires than specified in 3.03 a) will be required to be removed.</i>
6.	N/A	N/A	During the site walk we were shown the general location of tires but it was said that tires could be anywhere on the property. Many parts of the property are overgrown with vegetation. What is the expectation of collecting every possible tire on the property and how will it be determined that the tire collection is complete? <i>Answer #6: Please refer to Question 5 above and Section 3.03 a) of the ITB. Tire collection is complete once all tires have been removed from the site, as verified by DEP's onsite project manager.</i>
7.	N/A	N/A	To access some of the tires trees will need to be removed. a. Will tree removal be permitted? b. Will there be any type of trees that cannot be removed and if so do those tires remain on property? c. If trees are removed are they to be hauled off or left on site? <i>Answer #5: Tree removal will not be required to access the tires. There may be minimal vegetation that will need to be removed. Section 3.03 c) of the ITB states the Contractor is responsible for bringing any equipment onto the Site necessary for removing vegetation from the tires and loading the tires into trailers.</i>
8.	N/A	N/A	Are any parts of the property deemed off limits due to wetland restrictions? <i>Answer #8: No.</i>
9.	N/A	N/A	If there are access restrictions is the expectation to remove the tires manually?
