Justification for single source acquisition (what is necessary and unique about the product, service or source; steps taken to confirm unavailability of competition, as appropriate): **BOSCH Security Systems verified Express Supply was the sole source distributor for the VG5 Cameras Per E-Mail sent to the Florida Department of Transportation.** Several of District 1 maintaining agencies have requested the Bosch VG5 line of dome CCTV cameras to monitor traffic at their local Traffic Management Centers (TMC). The current APL purchasing contract (ITB-DOT-15/16-9005-GH) has the Bosch cameras listed but without a price and vendor listed. With the absence of an official vendor for these cameras it has become necessary to set up an ITB because the current and future commodity purchases will exceed the \$35,000 threshold. While contacting approved vendors for price quotes, one vendor known as Express Supply in Orlando FL, sent a letter stating they are the sole source for the BOSCH VG5 cameras listed on the APL. In an effort to verify the claim, a search on the Florida APL web site listed Bosch Security Systems as a supplier.
