Isolite dental products incorporate isolation of the working area, high and low volume suction, bite block, cheek retractor, oral illumination while maintaining a dry field. It enables the provider to administer quality services with greater efficiency resulting in increased number of patients seen to meet the State's needs. Isolite Systems is the sole manufacturer and distributor of Isolite Systems dental products, maintenance and services.

Currently, these dental products and services are used statewide by Department of Health offices throughout the State of Florida.
