The State of Florida, Department of Military Affairs (DMA), Construction & Facility Management Office (CFMO) requests qualifications from Professional Services Firms for Architectural-Engineering (A/E) services for DESIGN and Development of Construction Documents for the Construction of a new National Guard Readiness Center at Panama City, Florida.

Request for private meetings by individual firms will not be granted. No individual verbal communication shall take place between any applicants and the Owners, or Owners' representatives. Request for any additional information, clarifications, or technical questions must be requested in writing via email to the POC listed above no later than January 28, 2020 at 5:00 PM.

Respondents to this solicitation or persons acting on their behalf may not contact, between the release of the solicitation and the end of the 72-hour period following the agency posting the notice of intended award, excluding Saturdays, Sundays, and state holidays, any employee or officer of the executive or legislative branch concerning any aspect of this solicitation, except in writing to the procurement officer or as provided in the solicitation documents. Violation of this provision may be grounds for rejecting a response.

SERVICES TO BE PROVIDED:

This Agency will contract with a single entity who shall provide all services per ARNG Design Guides 415-1 & 415-5, the Unified Facilities Criteria, Army Regulations as well as satisfying the criteria programmed on the DD Form 1390/1391 Military Construction Project Data. Entity shall furnish Architect-Engineer services for all phases of the design and construction during the project life cycle including site investigation, design, procurement & bidding, construction administration and administrative closeout.

Services are to include but are not limited to:

On site visits and investigation reviews; boundary, topographical and utility surveys along with tree surveys indicating any protected species; geotechnical & subsurface soil investigation with building foundation recommendations and percolation tests required for drainage calculations; determination of utility capabilities and wetland delineation; attendance at user design conferences to finalize the design; prioritize project components, additive bid items and programming; conceptual, preliminary and construction design submittals; constructability reviews; research of State and local code requirements along with applicable regulations; application and acquisition of general storm water permit, environmental permit or permit modification; complete design and engineering with technical specifications and O&M manuals; life cycle cost analysis, detailed line-item construction cost estimates, DD form1354 and construction administration (CA) services required to provide a complete and functional facility.

Total project will be designed to current Florida Building Codes (FBC), current local building codes, current Florida Energy codes, American Disability Act criteria, and to achieve LEED SILVER Certification.

The A/E will also need to provide technical assistance and signed/sealed documents to aid the General Contractor to secure the required building permitting to include the preparation, submittal, payment and review coordination of the State Fire Marshall, Water Management District, Environmental Resource Permit (including permit fees), Florida Department of Environmental Protection (FDEP) Notice of Intent (including filing fees), Bay County Review Permit Fee, and any other permits and fees required by other county, local or state authorities. All structures will be engineered to meet applicable wind load requirements for the area.

A/E services for this project will include, but are not limited to:

All necessary site improvements such as clearing; grubbing; grading; drainage and storm water management; landscaping; essential utility services as well as geothermal and solar photovoltaic renewable energy systems; private and military organizational vehicle parking areas with loading ramp; all required roads & sidewalks; 72 hour emergency power generator with automatic transfer switch; Antiterrorism Force Protection Standards; Electronic Security Systems; voice and data communications with structured cabling network systems; fire protection system with alarm and integrated mass notification capabilities; all interior finishes to include furniture with power as well as voice and data capabilities and exterior finishes with ballistic entryways for a complete and functional facility.

Compliance with all applicable CSI Master Format Divisions, Army Regulations, Unified Facilities Criteria (UFC) and Army National Guard Design Guides shall be required from A/E for delivery of turn-key facilities to the FLARNG. These new facilities will require utilization of construction materials and equipment offering the greatest degree of maintenance-free longevity and operational energy efficiency. Facility to be designed for a minimum life of fifty (50) years in accordance with DoD's Unified Facilities Code 1-200-02.

SELECTION INFORMATION:

Selection of applicants for consideration will be made on the basis of relative design experience of the firm and their ability to perform based on, but not limited to, the information submitted on FNG Form 5112 for licensed and/or professional personnel; professional services qualifications, financial capability, recent, current, and projected workloads of the Professional Services firm and location of office in relation to project site. The firm's project team's primary office where they report to on a daily basis must be located within 300 miles of the project location to allow for weekly review of site progress with plans, specifications, and code compliance.

The awarded A/E firm may be requested to have a full time staff member on-site daily during all construction phases until project is completed and closed out as part of CA services.

The qualifications packages will be reviewed and a minimum of three finalists will be interviewed to determine the best qualified firm for this project. The finalists may or may not be required to make oral presentations, in person or by telephone conference, and the selection committee may reject all submissions and stop the selection process at any time. Additional requirements and information may be provided to finalists at a later time.

Order of Negotiations for the selected finalists will be made on the basis of past performance references, knowledge of site and local conditions, proposed project staff, ability to meet budget, ability to meet project schedule, understanding program requirements, approach, and methodology.

CONTINGENCY STATEMENT:

"The Architect (or registered land surveyor or professional engineer, as applicable) warrants that he/she has not employed or retained any company or person, other than a bona fide employee working solely for the architect (or registered land surveyor or professional engineer, as applicable) to solicit or secure this agreement and that he/she has not paid or agreed to pay any person, company, corporation, individual or firm other than a bona fide employee working solely for the architect (or registered land surveyor or professional engineer, as applicable) any fee, commission, percentage, gift, or any other

consideration contingent upon or resulting from the award or making of this Agreement. For the breach or violation of this provision, the Owner shall have the right to terminate this Agreement without liability and, at his discretion, to deduct from the Basic Services Compensation, or otherwise recover, the full amount of such fee, commission, percentage, gift, or consideration."

CONTRACT AWARD:

The short list for interviews and the final order of negotiations with the short listed firms will be posted on the MyFlorida website http://vbs.dms.state.fl.us/vbs/main_menu. Failure to file a protest within the time prescribed in Section 120.57(3), Florida Statutes, shall constitute a waiver of proceedings under Chapter 120, Florida Statutes. If no protest is filed, a contract will be negotiated with the firm which the Agency considers the most qualified for the intended project. If an agreement for compensation which the Agency determines is fair, competitive, and reasonable cannot be reached and the Agency is unable to negotiate a satisfactory contract, negotiations will be formally ceased and negotiations shall be undertaken with the firm the Agency has determined is the second most qualified after Departmental review of the submissions.

The DMA reserves the right to accept or reject any or all proposals received and reserves the right to make an award with or without further discussion of the proposals submitted or accept minor informalities or irregularities in the best interest of the State of Florida, which are considered a matter of form and not substance, and the correction or waiver of which is not prejudicial to other Proposers. Minor irregularities are defined as those that will not have an adverse effect on the Department's interest and will not affect the price of the proposal by giving a Proposer an advantage or benefit not enjoyed by all other proposers. It is understood the proposal will become a part of the Department's file, without obligation to the Department. Proposals may be rejected if found to be irregular or not in conformance with the requirements and instructions contained herein. A proposal may be found to be irregular or non-responsive by reasons that include, but are not limited to failure to utilize or complete in their entirety prescribed forms, conditional proposals, and improper, missing and/or undated signatures.

Submitted as part of PQS (item 2 above): Verification A/E Firm has completed design and construction administration services for a minimum of two (2) projects of similar magnitude, scope and complexity where the construction costs were equal to or greater than 20 million dollars; building sizes which were a minimum of 50,000 square feet; and projects were completed within the previous ten (10) years to be considered qualified.

- 7. Resume of Experience for A/E firm's Lead Architect and Engineer, LEED AP Staff Member and all other major team members. - 8. Any previous knowledge or experience regarding Bay County Builder's Services Division and any associated consultants who could enhance the firm's ability to provide timely responses or special expertise to project requirements.
- 9. Project Team's experience and reference of past projects completed that included designing buildings for hurricane resilience, survivability and hazard/risk mitigation to include building envelope rehabilitation and re-roofing scopes of work.

- 10. A/E firm's experience and any previous projects completed utilizing Building Information Modeling (BIM) with Clash Detection throughout the project life cycle which added value for the owner and benefited the end user.

Faxed or E-Mailed submittals are not acceptable and will not be considered. All instructions must be complied with and requested data must be included in order for your firm to be considered for this project. All information received will be maintained with the Department and will not be returned. The State of Florida's performance and obligation to pay under any contract is contingent upon availability of funding and an annual appropriation by the Legislature.

MYFLORIDA REGISTRATION:

INABILITY TO POST ELECTRONICALLY:

If the Department is unable to post an Intent to Award or Intent to Negotiate (due to technical difficulties) as defined above, the Department will notify all firms via the Point of Contact and electronic address provided to the Department. Notice will be posted as defined above once the technical difficulties have been rectified; however, the official posting time will be that time at which the last firm was electronically notified.

DISCRIMINATION and PUBLIC ENTITY CRIME INFORMATION STATEMENT:

A person or affiliate who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a bid on a contract to provide any goods or services to a public entity, may not submit a bid on a contract with a public entity for the construction or repair of a public building or public work, may not submit bids on leases of real property to a public entity, may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity, and may not transact business with any public entity in excess of the threshold amount provided in Section 287.017, for Category Two for a period of 36 months from the date of being placed on the convicted vendor list.

The DMA will not be responsible for submittals/bids presented on forms, or information obtained from sources other than DMA, CFMO, Contract Management Branch, or solicitations posted to the Vendor Bid System.

REQUIREMENT UNDER COOPERATIVE AGREEMENT:

Contractors are subject to the non-procurement debarment and suspension regulations implementing Executive Orders 12549 and 12689, 2 CFR part 180. These regulations restrict awards, subawards, and contracts with certain parties that are debarred, suspended, or otherwise excluded from or ineligible for participation in Federal assistance programs or activities. The Department of Military Affairs (DMA) shall comply with the DOD implementation of 2 CFR Part 180 (at 2 CFR Part 1125) by checking the Excluded Parties List System (EPLS) through the System for Award Management (SAM) at https://www.sam.gov. DMA shall not solicit offers from, nor award contracts to contractors listed in EPLS. This verification shall be documented in the contract files, and shall be subject to audit by the grantor and Federal/State audit agencies.

By submitting a bid in response to this solicitation, the contractor covenants and agrees that it will comply with Office of Management and Budget guidance on nonprocurement suspension and debarment in 2 CFR Part 180, Subpart C, as implemented by Department of Defense (DOD) at 2 CFR Part 1125 by checking the EPLS at https://www.sam.gov to verify eligibility of subcontractors.

HOMELAND SECURITY:

Pursuant to the State of Florida, Office of the Governor, Executive Order Number 11-02 entered on January 4, 2011, A/E and Contractor will utilize the U.S. Department of Homeland Security's E-Verify system to verify the employment eligibility of: (a) all persons employed during the term of the Contract by A/E and Contractor to perform employment duties within Florida within 3 business days after the date of hire; and (b) all persons (including subcontractors) assigned by A/E and Contractor to perform work pursuant to the Contract with the Department within 90 calendar days after the date the Contract is executed or within 30 days after such persons are assigned to perform work pursuant to the Contract, whichever is later.
