- The Department of Health, Bureau of Public Health Pharmacy owns (4) MTS 400 machines, (1) MTS 500 machine, and (3) MTS Autobond machines. These machines require MTS blisters and cards in order to function properly.
- Omnicell Inc. is the sole provider of MTS blisters and cards for its MTS 400, 500, and Autobond machines.
