All existing conventional devices (ceiling smoke detectors and mounting bases, duct smoke detectors with complete housing and sampling tubes, heat detectors and mounting bases, and manual pull stations) must be removed and replaced with new addressable (intelligent) devices (ceiling smoke detectors and mounting bases, duct smoke detectors with complete housing and sampling tubes, heat detectors and mounting bases, and manual pull stations). The new addressable (intelligent) devices shall be able to be disabled from the control panel, so entire "areas" are not disabled. Existing Simplex Grinnell 4100 control panel includes an addressable (intelligent) control board which utilizes existing zone wiring, as addressable circuits, throughout the entire Facility.
