## Summary of Work:

All work to be performed shall be located on Building #6, with Alternate Buildings #5 and #7, at North Florida Evaluation and Treatment Center, 1200 Northeast 55<sup>th</sup> Blvd. Gainesville, Fl. 32641.

The work shall consist of removal of all dirt deposits, leaves and other debris from the roof using broom or air broomer. There will need to be a thorough inspection of the entire roof surface and flashings for any damage including open seams, tears, cuts, etc. Repairs of any damaged areas must be completed so water will not penetrate any membrane or flashing surface during the cleaning process. A pressure wash cleaning with water of all roof surfaces is required with adequate time for a complete drying before any coating is applied. The application of an acceptable elastomeric silicone coating will be per the product manufacturer specifications for restoring of the roof. A 20 year Warranty must be supplied by the product manufacturer.
