The attached documents are hereby incorporated into the bid documents:

- Pre-Bid Meeting Sign in Sheet
 - 1. Question: Do you have specs for the signage?

Response: The restroom signs shall be 60 mil thick weather resistant plastic with precision engraved characters on a textured outdoor rated acrylic plate. Sign shall have UV inhibitors to prevent fading. Sign shall have adhesive strips for quick installation.

2. Question: Coordination with Duke energy will that be on the contractor and how will that fall into the final completion date and duke power and having an entity like duke power relying on them for final completion date?

Response: Delays outside of the contractors control will be looked at on a case by case basis.

3. Question: Regards to the water line, what is the impact of the new bike path on the water line route?

Response: A FDOT Utility Placement Permit will be obtained that entails installation of the 2" water main within the eastern right-of-way of SR300 by means of directional boring the entire length of the water main with HDPE pipe under the bike path and any wetlands.

4. Question: Simpson anchors to be Z-Max. If it's not Simpson it needs to stainless steel?

Response: All Simpson Connectors shall be Z-Max coated; all other exposed hardware shall be stainless steel.

5. Question: On the plans, sheet A1-14, 7 and 12 on sheet A103 its 6 and 12 which one should we do?

Response: The roof slopes are per the plans on Sheet A103 for the restroom building and on Sheet 114 for the kiosk.

6. Question: The graphics for the kiosk, is that part of the contract?

Response: No, that is at the pleasure of the county.

7. Question: On the tile base, do you want us to use tile base on the edge and the walls.

Response: Please provide a 6" high tiles around the perimeter of interior walls. Tiles and grout shall be as specified.

8. Question: Budget?

Response: The Department's estimate for this project is \$218,000.00. This number is strictly an estimate, each Bidder's bid price should be based on their firm's assessment of the project.

In all other respects, the contract documents of which this is an Addendum, and attachments relative thereto, shall remain in full force and effect.
