Written notices, formal requests and proceedings must conform with the requirements set forth in Chapter 28-110, Florida Administrative Code (F.A.C.). Protests must be filed with the Purchasing Office, Fish and Wildlife Conservation Commission, 2590 Executive Center Circle, Tallahassee, Florida 32301 within the time prescribed in Section 120.57(3), F.S. and Chapter 28-110, F.A.C.

BEGIN ADDENDUM

QUESTION #1

Is there somewhere to get project plans? I saw the typical drawings in the project documents, but it would be helpful to know the specifics like the length of each pipe and the width of the road at each location.

ANSWER #1

Culvert lengths can be found in Section 4. JOB SPECIFICATIONS & FIGURES beginning on page 17. Road widths are not included but are less than 30', typically 20'-25'.

NOTE: culvert specifications for job 2 are missing from the ITB document. It is attached below and associated with the locations on the map in Figure 4 on page 18.
