Protests must be filed with the Purchasing Office, Fish and Wildlife Conservation Commission, Suite 100, 2590 Executive Center Circle, Tallahassee, Florida 32301 within the time prescribed in Section 120.57(3), Florida Statutes and Chapter 28-110, Florida Administrative Code.

**Item #1 REVISED PRE-BID CONFERENCE LOCATION DIRECTIONS:**

**Non-Mandatory pre-bid meeting will be conducted at Spirit Of The Wild WMA check station located in Hendry County, about 12 miles south of LaBelle; 15 miles north of Immokalee.**

**From Sebring: Take U.S. 27 south to S.R. 29 south to LaBelle. From LaBelle take SR. 29 south and turn left on C.R. 832. The main entrance is approximately 2 miles down C.R. 832 on the left. Follow the main road approximately 1 mile to the [log cabin] check station.**

**From Ft. Myers: Take S.R. 80 east to LaBelle. From LaBelle take SR. 29 south and turn left on C.R. 832. The entrance is approximately 2 miles down C.R. 832 on the left. Follow the main road approximately 1 mile to the [log cabin] check station**
