Q1) Is there any start date or any completion date for this job?

A1) The start date is mid-October and the ITB states in Scope of Services paragraph D completion by November 25, 2017.

Q2) Is there a budget for the job.

A2) Yes

Q3) What about painting the scuppers downspouts and flashing?

A3) Please see Attachment A Scope of Services

Q4) The Palm trees - do we trim them or do you have someone doing it?

A4) DOH has a company who will trim those trees.

Q5) Question is about unforeseen stucco damage. Is there a square footage amount in the bid or how do we figure that?
