Written notices, formal requests and proceedings must conform with the requirements set forth in Chapter 28-110, Florida Administrative Code (F.A.C.). Protests must be filed with the Purchasing Office, Fish and Wildlife Conservation Commission, 2590 Executive Center Circle, Suite 100, Tallahassee, Florida 32301 within the time prescribed in Section 120.57(3), F.S. and Chapter 28-110, F.A.C.

### **BEGIN ADDENDUM**

# **QUESTION #1**

We came across the above referenced project and were hoping to obtain the landscape / irrigation plans so we may submit a proposal.

#### ANSWER#1

There are no specific planting or irrigation plans for this project. All plant material is to be planted within +/- 10' from the perimeter of our project as part of a Palm Beach County required perimeter planting buffer. Understory material is to be used below existing power lines along the East and West property lines, and canopy trees to be planted in all other areas. Contractor is responsible for temporary irrigation up to project acceptance / final completion. Water for irrigation is available from one of (4) internal lakes, or from a withdraw point for the fire department. FWC shall meet with the contractor on-site to assist in laying out all plant material.

# **QUESTION #2**

On page 4, it mentions a completed by date of August 30th for install. The next paragraph states that the delivery shall be complete by July 15th. Can you please explain what the delivery portion means?

#### ANSWER #2

This is a typographical error. The originally conceived date was July 15<sup>th</sup>, however it was recognized as being unrealistic and the date was moved to August 30<sup>th</sup>.

### **QUESTION #3**

Regarding Simpson Stopper, would you consider multi stem as opposed to standard?

#### ANSWER #3

Multi-stem is acceptable per conversation with Palm Beach County building department
