This addendum and the listed attachments forms a part of the contract documents and modifies the original bidding documents. Acknowledgement of this addendum in Exhibit 4 - Bid Proposal form is required.

Addendum #2 incorporates Questions and Answers and five (5) attachments. As a result of attachments, previous versions of Exhibits 1 and 3 have been removed and replaced with amended versions. The date for opening of bids has been changed to March 3, 2020. Reference to the "Advertisement End Date/Time" on VBS does not reflect the date and time established for public bid opening.

Addendum #2 Questions and Answers:

Q1. "Proof Contractor has successfully completed no less than two (2) fencing and force protection projects of similar size, scope, & complexity within the last three (3) years". If the General Contractor has this experience via one project and the fencing subcontractor scheduled for this project has over 20 projects of similar scope and size - will this meet the requirement set forth in Exhibit 3 and listed above? A1. Yes

Q2. Is there a temporary fencing requirement while the project is ongoing? If so, what is required?

A2. The existing MOV parking area (south end of site) is currently secured by fencing, which shall remain. No alterations are indicated for this fencing, and this area shall remain secured. Temporary fencing is not required on the unsecured parking areas in the northern portion of the property where the privately-owned vehicle (POV) parking occurs. General Contractor may utilize temporary fencing as required to secure the designated Contractor Lay down area, and the construction work areas as needed.

Q3. Can we suggest an alternate gate operator if the specs meet or exceed the requirements set forth in the bid documents?

A3. Yes. The specification lists a Basis-of-Design product, however, other products meeting the salient design and performance characteristics specified may also be submitted.

Q4. Is there access to water and power for construction use? If there is, is there a cost share the contractor will be responsible for? A4. Share costs if a spike in utility bills.

Q5. Please provide details on Aiphone system that the gate access panels need to communicate with? A5. Detail on E-702

Q6. Please confirm the pre-bid site meeting was not mandatory.

A6. Confirmed. Pre-bid site meeting was not mandatory.

Q7. Must the contractor be a licensed general contractor?

A7. No. Exhibit 1 is updated. Exhibit 3 is updated to clarify inclusion of contractor license (if applicable) or registration as required under Florida Statutes. Additionally, the contractor must be licensed by Hernando County in order to pull permit.
