## **ITEM #2 QUESTION AND ANSWERS:**

**Question #1.** Will The New pavilions be built by another contractor? Would the awarded contractor just have to pour the pads for each pavilion?

**Answer #1:** No, all pavilions are to be furnished and installed by the awarded vendor.

**Question #2**. The plans in the files attached to the project are different. Page C105 differ between SFWMD attached file and the plans on FWC website. for example, the hungryland trail details on C105 of the SFWMD PDF. Do we widen that trial with shellrock?

**Answer #2:** The construction plan set dated 03/29/17 are to be used during construction. The plan set submitted to the SFWMD dated 02/25/17 encompassed a larger scope than what is included in this bid.

**Question #3**. If we do widen the hungryland trail, What is the length of that trail needing widening?

**Answer #3:** The widening of the Hungryland trail is not included in this bid.

**Question #4.** Are we responsible for the concrete pad under the double Vault Toilet? **Answer #4:** No, all work under the foot print of the vault toilet is by others. All sidewalk adjacent and connected to the vault toilet is the responsibility of the awarded vendor.

**Question #5.** On sheet C103 the proposed grade by the match line are 23.30 at the edge of the road and 23.50 on the centerline of the road, on sheet C100 the same proposed elevations are 23.52 & 23.70. Which elevations are we using?

**Answer #5:** The elevations shown on sheets C101 and C102 are the existing grades. Proposed and existing grades are shown on sheet C103.

**Question #6.** The slabs are showing 4 #5 rebar's in the footer and showing a cross bar in the 4" slab. The detail does not call out what spacing the cross bars will be, please clarify. **Answer #6:** The rebar is to be spaced equally along the slab.

Question #7:What type of roofing on the RCP shelters? Shingle or Metal?Answer #7:See note on sheet C102 for clarity. Metal roof is to be supplied.
