3.1 Delivery

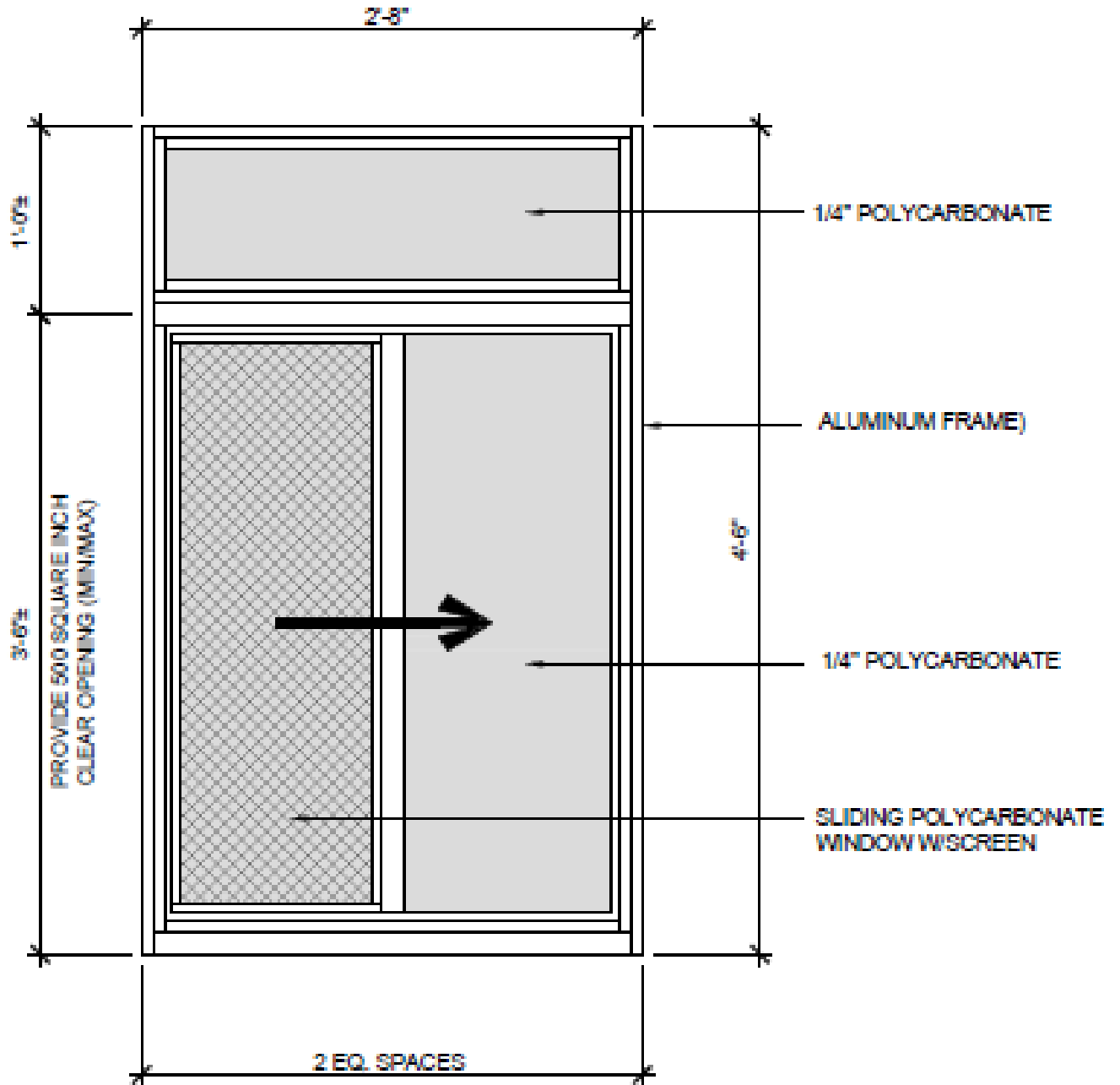
Product(s) shall be shipped as Free on Board (FOB) and arrive within 45 calendar days after FDC approves the submittals and mockup(s) referenced in Section 2.1.6, Action Submittals, Section 2.1.7, Informational Submittals, and Section 2.1.8, Quality Assurance, of PO issuance unless a different time is mutually agreed upon by the Contract parties and documented in the subject PO. Deliveries must be made between 8:30 a.m. and 4:00 p.m., local time, Monday through Friday, excluding State holidays, unless otherwise stated herein or in the Contract. The Bidder shall be solely responsible for the shipment until delivery at the designated facility.

2	<p>Do you have measurements for the sizes you're looking for?</p>	<p>Attachment I – Price Page, provides the sizes and quantities of the windows to be provided upon award of this solicitation.</p>
3	<p>Can Window Frames made from Stainless Steel be an acceptable alternate to Aluminum Window Frames specified on this project?</p>	<p>Yes, as long as they meet all specifications, to include but not be limited to material thickness, Florida Building Code requirements and certification by a Structural Engineer licensed in the State of Florida, in accordance with Section 2.1.7 of the ITB.</p>
4	<p>Are Window Frames manufactured by Hope's Windows, Inc., Jamestown, NY acceptable to be used on this project?</p>	<p>Products from any manufacturer are acceptable provided they meet all specifications, terms, and conditions of this ITB.</p>
5	<p>In FDC-ITB-20-049, Section 3.1, Delivery states that products shall arrive within 45 calendar days of PO issuance. When you take into account Submittal Generation, Submittal Review and Approval, Mailing Time, Window Frame manufacturing Time and delivery, it will be very difficult if not impossible for all of this to occur within 45 calendar days. Is it possible to extend the delivery time more than 45 calendar days?
