- A1) 1115 E. Kennedy Blvd., Tampa, FL 33602
- Q2) I looked thru the ITB and I didn't not see a link for Drawings or Specifications, is there a link for this or are drawings and spec available at this time?
- A2) Yes, see Section 3.8
- Q3) Will a copy of the mandatory pre-bid meeting sign-up sheet be made available to the bidders?
- A3) Yes
- Q4) Will only those companies who appear on the sign-up sheet be permitted to submit a bid for this project?
- A4) Yes
- Q5) Specifications call for a non proprietary Edwards System Technology – EST Io500 series fire alarm system. Will Hillsborough County Health Department accept an Edwards E-FSA250 Addressable Fire Alarm panel as an equivalent Equipment (Compatible UL Approved/Listed) from approved/listed manufacture's?
- A5) No
- Q6) Lock box at North Entrance is it currently monitored by Fire Alarm?
- A6) Yes
- Q7) Doors at corridor ends with magnetic hold open. Are these doors on Fire Smoke walls will they require Smoke detectors?
- A7) Yes
- Q8) Does Elevator have current recall and shunt trip connections to Fire Alarm system? If not will these be required to be added?
- A8) Yes

- Q9) Will we be able to utilize space beside old panel for temporary location of new panel until time comes to switch over?
- A9) Yes
- Q10) Keeping old panel operational; who would pay for Fire watch if we are unable to keep old zones operational, while new panel goes in, and or failure of old panel during install?
- A10) Contractor
- Q11) Testing with AHJ, will this need to be requested for non-occupied times, and who will pay extra costs?
- A11) No, Contractor
- Q12) Backflow is located outside west side of building, and is currently chained. Will this need switches and connected to fire alarm for local AHJ?
- A12) No
- Q13) Work must be performed during closed hours and some areas require that a person be on site with us, for us to access these areas. Who is paying this person to be on site?
- A13) Florida Department of Health in Hillsborough County will pay for our employee that is required to be onsite for identified areas.

- A14) Conventional
