The meeting will provide awareness and also provide for the regulatory consultation requirement for Southeastern Army National Guard (ARNG) Programs from AL, GA, LA, MS, NC, SC, and TN, their environmental and Joint

Forces Headquarters Staff, as well as representatives of affiliated Federally-recognized Tribal governments.
