UPDATE: QUESTION AND ANSWER (ITEM #1).

Written notices, formal requests and proceedings must conform with the requirements set forth in Chapter 28-110, Florida Administrative Code (F.A.C.). Protests must be filed with the Purchasing Office, Fish and Wildlife Conservation Commission, Suite 100, 2590 Executive Center Circle, Tallahassee, Florida 32301 within the time prescribed in Section 120.57(3), Florida Statutes and Chapter 28-110, Florida Administrative Code.

ITEM 1 –QUESTION AND ANSWER:

QUESTION #1: Is there an engineer's estimate or budget value or this project?

ANSWER #1: No engineer's estimate. PASO estimated \$40k for the construction.

QUESTION #2: There is no direct transition piece for the change from the SG225 Sheets to the SG750 sheets (I've attached and highlighted the are in question). CMI recommends a Shoreguard 550 corner as the best option for transition between the two different profiles. The SG225 sheet will be slightly loose in the connector while the SG750 sheet will need to have its connection trimmed down to fit. The caps will not line up either as they are also a different profile. Please see the following from the CMI Rep Jim Kanuch:

"It seems the best solution we can come up with would be to use our SG550 corner for this situation. The SG225 & SG750 are on completely different spectrums of our vinyl sheet pile portfolio. You will more than likely need to use a sealant of some kind to fill the gap in attaching the SG550 corner to the SG225 sheet pile. You will also likely need to trim the SG750 sheet pile male lock to insert into this corner piece."
