### **CLARIFICATION OF TECHNICAL SPECIFICATIONS**

The Department herby notifies vendors of the following amendment to the technical specifications for the Flag Banners.

### <u>Technical Specifications-Item 2: Flag/Feather Banners (include stand)</u>

Quantity: 200 flags with stands

Material: Polyester Lightweight Material – 4 oz. Polyester Knit Mesh Fabric (110gm

Polyester Fabric)

Size: Height (including stand) Minimum 8.5' to Maximum 10.5'

Width Approximately 2.5'

Printing: Double sided. Printed image clearly visible from both sides with blockout liner in

the middle. No bleed throughs.

Color: Full Color, 4/4, CMYK, both sides

Graphics: Graphics to be provided by FNW at the time of order

Stand: "X" steel cross base model

- 6. The shipping address was not provided on the paperwork. Is the correct shipping address listed for Joley Owens in Tallahassee, FL 32399? If not please advise as to the shipping location(s) + quantity per location if split shipping.

  Shipping to schools state-wide. A Maximum of three banners per location. Information will be provided to the awarded vendor
- 7. Would additional quantities be in increments of 200 or above or would these be smaller quantities?

There are two items. Item 1 is a hanging banner and Item 2 is a feather banner style

19. The stand shown in Appendix II is for an indoor flag. Will these banners be indoors or outdoors?

Schools will have them indoors and outdoors

20. Is this an all or nothing bid?

- 22. Does this bid include shipping if so we would need the address or addresses to where these items are going to be shipped to?

24. Regarding the TECHNICAL SPECIFICATIONS- ITEM 1: HANGING BANNERS. Are these banners going to be hung inside or outside? If outside, the 10 oz. Ultraflex Jetflex pvc vinyl, hemmed that was stated as a requirement may not be durable enough for exterior conditions and we would suggest an alternative.

The banners will be used indoor and out. Hanging banners will be the 10 oz. vinyl banner material

- 25. The flag material specified is 10 oz. Ultraflex Jetflex pvc vinyl, hemmed. Based on the example shown for the type of flag needed, the material typically is not a vinyl material but an outdoor fabric material. The finish is usually very specific for the frame and will need to be finished according to a graphic template. Can you provide your feedback? Please see new technical specifications above for this bid
- 26. We are interested in submitting a proposal and have a question in regard to item # 2. It is calling for the same material as item # 1 but the example in appendix 2 appears to be fabric. Please confirm which material should be used.

27. On item 2 of the above referenced bid, it says to include the banner stand in the price. Two questions, is there a specification for the stand itself or can we quote any stand as long as it holds the banner size specified? Question # 2, is the quote requiring one banner stand for each flag banner, so a total of 200 stands?

28. Will these banners and flags be for interior or exterior use? The material that is spec'd is for interior use.

Hanging to be indoor/outdoor. Standing Flag to be indoor/outdoor

29. Where will these be hung? On light poles, wall, etc...

For Item 1, hanging banners will be hung up by the schools they are shipped to

30. How will they be hung? Do you need hardware?

We require the flag feather banner to have a base, hanging banners do not require any additional hardware other than specified (i.e. grommets).

31. How did you determine what the fabric should be? If these are pole banners standard fabric would be an 18 oz vinyl

32. What type of stand are you referring to? Depending on the type of flag banner the stand could be different

- 34. What type of flag banners are these? Retractable Banners, Framed display

  Hanging banners will have no frame, flag feather banners will have a flag stand and base.
- 35. ITEM 2: FLAG BANNERS (INLCUDE STAND) Stand can be a Cross Base for hard floor surfaces or ground spike that is most popular.

- 36. Size: 102" X 30" Is this the size of the flag alone or the total size in height? Please see new technical specifications above for this bid.
- 37. Printing: Double Sided 2 types of "double sided" 1. Is 2 flags back to back with blockout liner in the middle and 2 is a flag that is printed one side and the visual is visible in the back as it bleeds through the fabric.

- 38. Will entire production be expected to ship at once or are their tiered delivery dates? Ship in accordance to departments purchase order
- 39. Shipping cost should not be included in the proposal, correct? <u>Please see answer number twenty-two</u>
- **40.** Does the size on flag banners with stand have to be exact? Or, can it be 102x40? Please see new technical specifications above for this bid.
- 41. Does the material have to be Ultraflex jetflex? Or, can it be equivalent?

  For item 1 Hanging Banners, the material can be Ultraflex jetflex or an approved equivalent.

  The department reserves the right to accept or reject proposed equivalent items.
