A. Answers to bidders' questions taken from the Pre-Bid Meeting on August 16, 2013 and questions submitted to CFMO Contracting by August 22, 2013:

- 1. Contractors can bid on multiple projects, but each bid must be submitted separately. Envelopes must be clearly marked for the project you are bidding on.
- 2. Revised Scope Project 212049 -- Remove existing shingles from buildings: 3600, 3610, 3611, 3612, 3660, 3662, 3672, 3673, 3674, 3675, 3676 and 3677 and replace with metal roofs to Kynar Sierra Tan color, 24 gauge commercial Berridge Cee-Lock or Gulf Coast Supply Gulf Seam are acceptable roofs for this project. (12 buildings). Contractor is to furnish all necessary labor, equipment and materials to complete the project, including removal of any debris from Camp Blanding Joint Training Center. All buildings have "hip roofs". Fascia and Soffits will remain. No Fascia and Soffit work required.

Revised Scope Project 212050 -- Remove existing shingles from buildings: 4600, 4620, 4630, 4640, 4645, 4650, 4655, 4661, 4663, 4665, 4667, 4673, 4675, 4677, 4683, 4685, 4691, 4693, 4695 and 4697 and replace with metal roofs to **Kynar Sierra Tan color** (20 buildings). **24 gauge commercial Berridge Cee-Lock or Gulf Coast Supply Gulf Seam**

- **are acceptable roofs for this project.** Gable ends are to be replaced with aluminum siding. Contractor is to furnish all necessary labor, equipment and materials to complete the project, including removal of any debris from Camp Blanding Joint Training Center.
- 4. Revised Scope Project 212051 -- Remove existing shingles from buildings: , 4851, 4853, 4855, 4887 and 4830 and replace with metal roofs to Kynar Sierra Tan color. (5 buildings). 24 gauge commercial Berridge Cee-Lock or Gulf Coast Supply Gulf Seam are acceptable roofs for this project. Gable ends are to be replaced with aluminum siding. Contractor is to furnish all necessary labor, equipment and materials to complete the project, including removal of any debris from Camp Blanding Joint Training Center. Note: Buildings 4801, 4807 and 4808 have been deleted from the project. Building 4830 has been added to the project.
- 5. What are the colors of the roofs and sidings? **Answer: Roof is Kynar Sierra Tan.** Siding is 8" Aluminum, Chocolate brown
- 6. Will the roof be a Kynar product? **Answer: Yes, Sierra Tan**
- 7. Is 26 gauge acceptable for the roof? **Answer: No, 26 gauge is not acceptable for the roof. 24 gauge commercial Berridge Cee-Lock or Gulf Coast Supply Gulf Seam are acceptable for the roofs.**
- 8. What products / materials are "equal to or better than Gulf Coast Supply snap lock roofing system"? **Answer: See above question**
- 9. What are the specs on the drying sheets? **Answer: Synthetic felt**.
- 10. What are the fascia board requirements? Answer: Cut 3" off of the overhang and add 2" x 4" pressure treated fascia board and paint to match Sierra Tan.
- 11. During the 3600 series you mentioned to delete the fascia work from these projects. Is this correct? **Answer: Yes. See Item #1 Revised Scope Project 212049.**
- 12. Where can the bidders store their equipment and/or materials? **Answer: Contractor can** store materials and equipment in each area of work. The contractor is responsible for the security of the materials and equipment.
- 13. Please confirm that you want to delete 4801 because it has been reroofed and replace it with another building? Which building? Answer: Building 4801, 4807 and 4808 have been deleted from the project. Building 4830 which was shown during the Pre-Bid / Site visit tour has been added to the project. See Item #3 Revised Scope Project 212051
- 14. There is no permit allowance? **Answer: No. Contractors are to determine the permits** required and costs are to be included with the base bid price.

- 15. Contractors are to return grass/landscaping to current conditions at the start of the project.
- 16. Are there any limitations to the work schedule? **Answer: Currently there are no limitations to the work schedule.**
- 17. Is there a manufacturer and/or contractor warranty required? If so, what is the length and type (NDL, standard, material only)? **Answer: 20 year Standard Kynar warrantee**.
- 18. What type of underlayment will be required? 30# felt, synthetic felt or Peel & Stick. **Answer: Synthetic**
- 19. What type of gable end siding will be required for this project? **Answer: Aluminum 8", Chocolate Brown**
- 20. Will the existing plywood roof sheathing require re-nailing? **Answer: Only if the permit requires.**

- 33. Please confirm requirements for personnel background checks. Answer: Government issued photo identification required. Background checks will be performed by the Provost Marshall prior to receiving pass to work on the post.
- 34. Are plans available for the existing buildings? **Answer: No**
- 35. Reference Exhibit 3-FNG 5085, Section 64, Additional Requirements/ Instructions. Item number 5, indicates a requirement for submittal of a resume for a staff LEED AP. Please confirm that this is required for the project. **Answer: There are no LEED requirements for this project.**

15. PERFORMANCE BOND AND LABOR AND MATERIAL PAYMENT BONDS:

Performance and Labor and Material Bonds are required from any persons or parties entering into a formal contract with the State of Florida for contracts in total excess of \$100,000.00 for

construction, additions, renovations, repairs, or demolition of any public building pursuant to Florida Statute 255.05(1)(a). These must be supplied to our office within 10 days of contract award. No work may commence, or Notice to Proceed be issued in connection with the contract until the bonds have been submitted to the CFMO-Contract Management Branch.

16. CONTRACTORS INSURANCE:

- a. The contractor must provide the owner with proof of insurance within 10 days of contract award. No work may commence in connection with the contract until he has obtained all insurance as specified in the Non-Technical Specifications, Section C and such insurance has been approved by the Owner, nor shall the contractor allow any subcontractor to commence work on his subcontract until all similar insurance required of the subcontractor has been so obtained and approved by Owner.
- b. All insurance policies shall be with insurers qualified and doing business in Florida through an authorized licensed Florida Resident Agent.
- **17. DAVIS BACON ACT:** Davis Bacon Act does not apply to this solicitation. Maintenance of the payroll records are the sole responsibility of the contractor. Do not send payroll records to the Department of Military Affairs, Construction & Facility Management Office.
- **18. ACTUAL DAMAGES**: Amount based on actual loss to government. Contract will be modified (by Change Order) to reflect actual losses to the government in lieu of daily amount (liquidated damages).
- **19. CONTRACT AWARD**: Per Florida Administrative Code 60D-5.007, the project will be awarded to the responsive and responsible bidder that has submitted the lowest price for the base bid or base bid plus alternate bid items. NOTE: Award of this contract is contingent upon funding from the State of Florida.
- **20. MY FLORIDA MARKET PLACE**: Registration in the MyFloridaMarketPlace (MFMP) Vendor Bid System (VBS) is a requirement for award of any state contract or purchase order.
