The following shall address questions, responses, additions, clarifications, and/or changes relative to **FDVA-ITB-20-016B**. The below questions, responses, additions, clarifications, changes, and/or attachment(s) shall amend **FDVA-ITB-20-016B**.

1) **Vendor Question:** Is it possible to get the drawings in PDF,

FDVA Response: Drawings in PDF were emailed to the Vendors who attended the mandatory pre-bid meeting and on-site visit on Thursday, February 13th, 2020.

2) **Vendor Question:** Drawing states to reuse existing breaker and wire, does not state replacing disconnects would they like to replace four disconnects with stainless steel enclosures?

FDVA Response: Baldomero Lopez would like to replace four (4) disconnects but they are not required to be stainless steel enclosures.

3) **Vendor Question:** Who is the preferred controls contractor?

FDVA Response: Siemens.

4) **Vendor Question:** Who is the preferred water treatment company?

FDVA Response: ATS – Associated Technical Services.

5) **Vendor Question:** Are we free to choose our own controls and water treatment provider (following the guidelines of the bid packet) that will tie in to the new system we install?

FDVA Response: No, use the current contracted vendors.
