The Department of Environmental Protection, Bureau of Design and Construction is soliciting formal, competitive, sealed bids from Contractors licensed to work in the jurisdiction for the project listed below.

**PROJECT NAME: Faver-Dykes State Park – Upgrade Fishing Dock**

**SCOPE OF WORK:**

**Base Bid:**

Contractor shall provide all labor, materials, equipment, supervision and permitting to repair and upgrade the existing fishing dock per the contract documents.

**Alternate #1:**

The contractor shall substitute composite 2"x6" decking material per specification section 06730 in place of the 2"x6" pressure treated decking. (Note that this price should be an add or deduct cost.)

**Installation Floater and Longshoreman's Insurance is required for this project and must be included in bid price.**

**Note:** Bidder Prequalification is required for all bids. Each bidder shall provide a copy of its biennial pre-qualification letter from FDEP's Bureau of Design and Construction. If not pre-qualified, the bidder must submit a current State Contractor license certification or registration and current Corporate Charter registration with the bid.

Pursuant to Executive Order 07-126 and Section 255.252(3), F.S. the Department requires the proposed project be designed and constructed in accordance with green building standards where applicable.

Failure to file a Notice of Intent to Protest or a formal, written Protest in accordance with Rule 28-110, F.A.C., within ten days after the 72-hour period ends, as prescribed in Section 120.57(3), Florida Statutes, shall constitute a waiver of your right to an administrative hearing on the Bid Specifications under Chapter 120, Florida Statutes. Rules for bid protests can be found in sections 120.569 and 120.57, F.S., and Chapter 28-110, Florida Administrative Code. A bid protester shall comply with these statutes and rules.
