SCOPE OF WORK:

Base Bid:

Contractor shall provide all labor, materials, equipment, supervision and permitting to construct a "living shoreline" along approximately 1,400-ft of Apalachicola Bay shoreline in Eastpoint, Franklin County, FL. The primary component of the project includes construction of two segmented low-crested breakwaters extending to the north and south from an existing rock breakwater. The proposed breakwater shall be comprised of stone-filled high-density poly ethylene (HDPE) marine mattresses. Additional project components include installation of waterway warning signs per the contract documents.

Longshoreman's Insurance is required for this project and must be included in bid price.

Note: Bidder Prequalification is required for all bids. Each bidder shall provide a copy of its biennial pre-qualification letter from FDEP's Bureau of Design and Construction. If not pre-qualified, the bidder must submit a current State Contractor license certification or registration and current Corporate Charter registration with the bid.
