## SCOPE OF WORK:

## **Base Bid:**

Contractor shall provide all labor, materials, equipment, supervision and permitting to successfully install approximately 577 linear feet of new sheet pilings and associated work per the construction documents. Work to begin at approximately station 9+00 and to end at approximately station 14+77.

Longshoreman's Insurance and an Installation Floater are required for this project and must be included in bid price.
