You had asked if I could send responses to your earlier questions in a letter format.

Questions;

1.) Is the transmission agreement that Duke Energy Florida has with the City of Tallahassee eligible for assignment.

Yes, by executing a SERVICE AGREEMENT FOR THE RESALE, REASSIGNMENT ORTRANSFER OF POINT-TO-POINT TRANSMISSION SERVICE that is Attachment A-1 to the Joint OATT.

- 2.) What is the transmission capability of the City of Tallahassee transmission agreement that is eligible for assignment.
 - 11 MW of capability is assignable.
- 3.) Does DEF want to have Jackson Bluff Hydro back for its own operation?

No.

4.) When the City is no longer the operator of the plant would the new operator be able to negotiate a new agreement?
