UPDATE: QUESTIONS & ANSWERS

The enclosed addendum has been issued for consideration in the preparation of your response to the Florida Fish and Wildlife Conservation Commission's (FWC) Solicitation No. FWC 17/18-15 "Invitation to Bid (ITB) for Tenoroc Parking Area Maintenance."

**All responses to the subject solicitation must be received no later than 2:00 P.M. (ET) on Tuesday, September 19, 2017.** A response received after the exact time specified will not be considered. Failure to file a protest within the time prescribed in Section 120.57(3), Florida Statutes, or failure to post the bond or other security required by law within the time allowed for filing a bond shall constitute a waiver of proceedings under Chapter 120, Florida Statutes (F.S.). Written notices, formal requests and proceedings must conform with the requirements set forth in Chapter 28-110, Florida Administrative Code (F.A.C.). Protests must be filed with the Purchasing Office, Fish and Wildlife Conservation Commission, Suite 100, 2590 Executive Center Circle, Tallahassee, Florida 32301 within the time prescribed in Section 120.57(3), Florida Statutes and Chapter 28-110, Florida Administrative Code.

## ADDENDUM NO. 1

### **Item #1: Questions and Answers**

- Question #1:** The bid pack indicates that a P&P Bond will be required for this project. Is the face value of the bond to be total potential cost of the contract (assuming renewal) or the annual cost of the contract, renewed each year in the event the contract is renewed? Using the Estimated Budget this would be a bond renewed annually in the amount of approximately \$70k or a 4 year bond in the amount of approximately \$280k. Please advise which will be required of the successful bidder
- Answer #1:** **The value of the Performance Bond required would be the value of the Purchase Order issued annually.**
- Question #2:** Approximately how many total miles?
- Answer #2:** **Approximately 15 miles of roads and 76,510 square feet (ft<sup>2</sup>) of parking areas.**
- Question #3:** How many miles of road?
- Answer #3:** **Approximately 15 miles of roads.**
- Question #4:** When mobilized, will entirety of project be performed?
- Answer #4:** **Yes.**
- Question #5:** Will it be 2 or 3 times?
- Answer #5:** **Two times each year.**
- Question #6:** Can you send me the sign-in sheet from the pre-bid meeting?
- Answer #6:** **A copy of the Sign-In Sheet has been uploaded as a separate document in the Vendor Bid System.**
