#### ITB revisions:

**1.** The bid due date on the cover page of the Transportation of Vehicles and Equipment ITB is amended as shown below:

- **3.** Section 2., Contractor Deliverables, sub-section 2.1.3 is amended as shown below:
  - 2.1.3 The Contractor shall transport vehicles/equipment to the specified auction site by the delivery date listed in the Move Order using the most direct and economical route. The Contractor shall determine the most direct and economical route by using previous delivery routes and online mapping tools to take road closures into consideration. At the time of invoice submission, the Department will review each invoice against the DOT mileage calculator to ensure compliance with this section.

Section 3.1, Pricing is amended as shown below:
