- The incident management software system subscription is the only platform that combines all emergency management functions consolidated to one system which allows the expediting of emergency response functions, maintain all documentation necessary for public records and reimbursement in a single location. This system is the only system compatible with the Department's existing AudioMate 360 gateways.
- ReadyOp is the sole provider of its proprietary system.
