### Planar Video Wall

#### Technical Questions:

- 1) Will there be a Scheduled site visit?

- 2) Is this project being federally funded?

- 3) What are the dimensions of the space? L=\_\_\_\_\_ W=\_\_\_\_\_ H=\_\_\_\_\_  
**The mounting wall dimensions are 16' W x 7' 11"H**
- 4) What is the lighting situation? (i.e. Windows? Recessed Lighting? Fluorescent?)  
**Fluorescent**
- 5) What is the mounting surface and what is behind it? (i.e. Block? Drywall furred out from block? Drywall with stud framing etc.)  
**Mounting wall is 2X4 covered by plywood, and finished with black Formica**
- 6) In no block, is there backing in the wall for the installation of the 8 displays? If no, are you prepared to install some (or have awarded contractor install) or would you prefer backing to be surface mounted? \*Note- Surface mounting backing would cause the video all to stand further off of the wall's surface.  
**Surface mount**
- 7) Where in the room will the video wall be located? (i.e. common area and easily accessible or employee area behind desks or counter and not easily accessible)  
**Common area**
- 8) Are there special work conditions or special work times outside of the normal operational business hours of the TMC?  
**No. Standard times of operation are Mon – Fri 7am to 5pm. At no time will the TMC open or close outside this to accommodate installation**
- 9) What headend will be driving this video wall?  
**Existing Sense VMS will remain**
- 10) Do they have an existing piece or do we need to provide the Planar Matrix?

- 11) We are considered a foreign corporation on Sunbiz however we do conduct business in the state of Florida and have local tax certificates as well. Is the written opinion of attorney still needed in this case?

12) No reference is given in any of the bid documents regarding equipment tax or if City is exempt. We assume the city is exempt but we need to verify. If the City is not tax exempt, the contractor supplying this equipment or the City will need to pay tax on this equipment. Is the City tax exempt for this equipment procurement? If not, should our equipment costs include tax in each line item of the EXHIBIT C Bid sheet? If so, what percentage should be added to each line item? And will this tax detail be advertised to other bidders to ensure we are all bidding equally?

**The items listed on the Bid Sheet are being purchased by the Department of Transportation and installed at the Naples Traffic Management Center. The Department of Transportation is tax exempt, however our tax exemption certificate is not transferrable to contractors even if they are working on behalf of the Department. We cannot provide you any information on how you formulate your bid sheet.**

13) If we are considered a foreign corporation on Sunbiz however we do conduct business in the state of Florida and have local tax certificates as well. Is the written opinion of attorney still needed in this case?
