Question Number	Question	Answer
1	Question #2 in the first round of questions asked for the Department's population projection for each of the potential 10 years of the proposed contract. Although the response indicated that projections have been provided in the Section 2.8 resources, we did not see this projection in a search through these resources. Could the Department please identify the resource location and document containing this projection?	The requested information was inadvertently not included in the initial posting of resources. It has been added in the resources titled, "CJEC Results."
2	Question #28 in the first round of questions requested the amounts relating to staffing withholds incurred by the incumbent for the last three years. The response indicated that this information is provided in the Section 2.8 resources. Our search of these resources did not discover this information. Could the Department please identify the resource location and document containing this information?	The Department interpreted "staffing withholds" as the imposition of liquidated damages. These damages are listed in two files titled, "Contract C2757 Monthly Cost Information-past 24 months" and "C2758 Monthly Cost Information-past 24 months." Liquidated damages were imposed per Amendment 5 of Contracts C2757 and C2758.
3	Question #33 in the first round of questions requested a series of reports including quarterly cost reports, data cost analysis reports, and cost per day reports. The response indicated that the information is included in the Section 2.8 resources. Our review of these resources only disclosed cost information for non-formulary medications and not for other services. Could the Department please identify the resource location and document containing this information?	The Quarterly Cost Reports have been provided with the resources available per Section 2.8 of the ITN. They are titled, "C2757-Quarterly Cost Report- <date>" and "C2758-Quarterly Cost Report-<date>." The Data Cost Analysis and Cost per Day reports are considered confidential and proprietary by our current Contractors.</date></date>

4	Question #37 in the first round of questions requested information including total cost of OBIS and total liquidated damages assessed. The response indicated that this specific information was available in the Section 2.8 resources. Our review of these resources did not disclose this data. Could the Department please identify the resource location and document containing this information?	Please see the answer to Question #2. OBIS charges are also included in the files referenced in the answer to Question #2.
5	In the answer to first round question #4, the Department responded when asked about Hepatitis C medications and treatment, that "it is not feasible to predict how many will meet the criteria". Since it is also not possible for a vendor to know how many inmates will meet the criteria for treatment with very costly Hepatitis C medications, the Department will likely receive bid responses with significant variations in Hepatitis C cost projections – the significance of which could have a critical impact on bid scoring. Will the Department consider carving out treatment of Hepatitis C in this ITN, adding the current known Hepatitis C medications to the formulary, or providing vendors with a projection so that vendor bids can be prepared, compared and evaluated on equal terms?	Vendors are encouraged to utilize their prior experience in providing health care services, including treatment of Hepatitis C, when developing their Reply. Vendors are encouraged to respond with ideas for improvement, cost reduction, and other supplemental materials, per Section 4.9, TAB G of the ITN.
