## SOLICITATION INTRODUCTION

### The 10 Most Critical Things to Keep in Mind When Responding to a Solicitation for the Florida Department of Highway Safety and Motor Vehicles

1. **Read the entire document.** Note critical items such as: mandatory requirements; bond(s) requirements (proposal, performance and/or damages) sample(s) required, supplies/services required; submittal dates; number of copies required for submittal; funding amount and source; contract requirements (i.e., contract performance security, insurance requirements, performance and/or reporting requirements, etc.).
2. **Note the Procurement Officer's name, address, phone numbers and e-mail address.** This is the only person you are allowed to communicate with regarding the Solicitation and is an excellent source of information for any questions you may have.
3. **Attend the pre-proposal conference.** (If applicable)
4. **Take advantage of the “question and answer” period.** Submit your questions to the Procurement Officer by the due date listed in the Calendar of Events and view the answers given in the formal “addenda” issued for the Solicitation. All addenda issued for a Solicitation are posted on the Vendor Bid System’s website (<http://vbs.dms.state.fl.us/vbs/search.criteria form>) and will include all questions asked and answered concerning the Solicitation.
5. **Follow the format required in the Solicitation** when preparing your response. Provide point-by-point responses to the required sections in a clear and concise manner.
6. **Provide complete answers/descriptions.** Read and answer **all** questions and requirements. Don’t assume the Department or evaluation committee will know what your company capabilities are or what items/services you can provide, even if you have previously contracted with the Department. The proposals are evaluated based solely on the information and materials provided in your response.
7. **Use the forms provided: for example;** Bid List Registration page, Site Survey forms, Certification forms, Price Proposal forms, Certificate of Drug Free Workplace, Savings / Discount / Price Reduction, Customer References, etc.
8. **Check the Vendor Bid System website for Solicitation addenda.** Before submitting your response, check the Vendor Bid System website to see whether any addenda were issued for the Solicitation, some addenda require that you sign and return them with the bid.
9. **Review and read the Solicitation document again** to make sure that you have addressed all requirements. Your original response and the requested copies must be identical and be complete. ## 1.0 PURPOSE AND GENERAL INFORMATION

**1.1 PURPOSE:** The Department of Highway Safety and Motor Vehicles, hereinafter called the Department or the Customer, requests written offers from qualified firms for the procurement of the Javelin advanced emergency warning system and parts for the Florida Highway Patrol (FHP) and Commercial Vehicle Enforcement (CVE) standard police vehicles model year 2013 and newer. The proposed system must comprise of both audio and visual components. The price per unit must include delivery as well as any pricing per packages.

**1.2 GLOSSARY:** See attached PUR 1000, Paragraph 1, and PUR 1001, Paragraph 1 for further definitions.

**Contractor:** The proposer who is awarded a contract by the Department as a result of this solicitation.

**Cd-S:** Candela Seconds. Standard units of measure for light or flash energy output.

**CVE:** Commercial Vehicle Enforcement

**Day:** A Calendar day.

**Department:** Department of Highway Safety and Motor Vehicles.

**Equipment Failure:** A malfunction in equipment maintained by the contractor that delays or prevents the State's productive use of said equipment for the purpose for which said equipment was installed.

**FHP:** Florida Highway Patrol.

**G Force:** Gravity Force.

**LED:** Light Emitting Diode.

**ISA:** Information Systems Administration of the Department of Highway Safety and Motor Vehicles.

**ITB:** Invitation to Bid.

**Machine(s):** Equipment, components and/or their features, model conversions, equipment elements and accessories submitted by the contractor in response to this solicitation.

**Number of Verbs or Nouns:** Throughout this solicitation, the singular may be read as the plural and the plural as the singular.

**Packing:** Tangible product shall be securely and properly packed for shipment, storage, and stocking in appropriate, clearly labeled, shipping containers and according to accepted commercial practice, without extra charge for packing materials, cases or other types of containers. All containers and packing shall become and remain Department property.

**Proposer:** Any firm or person who submits a proposal to the Department in response to this solicitation.

**Proposal:** All information and materials submitted by a proposer in response to this solicitation.

**Purchase Order:** A Purchase Order is issued via the eProcurement system. See attached PUR Form 1000, paragraph 2.

**SAE:** Society of Automotive Engineers.

**State:** State shall be synonymous with the Department of Highway Safety and Motor Vehicles.

**Subcontractor:** Any person other than an employee of the contractor who performs any of the services listed in this solicitation for compensation paid by the contractor.

**Vendor:** Any firm or person who submits a proposal to the Department in response to this solicitation.

**1.3 PROCUREMENT OFFICER:** The Procurement Officer, acting on the behalf of the Department, is the sole point of contact outside of official conferences and meetings with the agency's team, with regard to all procurement matters relating to this solicitation, from the date of release of the solicitation until the Department's Notice of Intended Award or Decision is posted. Florida Statute Section 287.057(23) requires that respondents to this solicitation or persons acting on their behalf may not contact, between the release of the solicitation and the end of the 72-hour period following the agency posting the notice of intended award, excluding Saturdays, Sundays, and state holidays, any employee or officer of the executive or legislative branch concerning any aspect of this solicitation, except in writing to the procurement officer or as provided in the solicitation documents. Violation of this provision may be grounds for rejecting a response.

**1.5 MANDATORY REQUIREMENTS:** The Department has established certain mandatory requirements which must be included as part of any proposal. The use of the terms "shall", "must", or "will" (except to indicate simple futurity) in this solicitation indicates a mandatory requirement or condition.

The words "should" or "may" in this solicitation indicate desirable attributes or conditions, but are permissive in nature. Deviation from, or omission of, such a desirable feature will not itself cause rejection of a proposal.

**1.6 NON – RESPONSIVE PROPOSALS, NON – RESPONSIBLE RESPONDENTS:** Proposals which do not meet all requirements of this solicitation or which fail to provide all required information, documents, or materials will be rejected as non-responsive. Material requirements of the solicitation are those set forth as mandatory or without which an adequate analysis and comparison of proposals are impossible, or those which affect the competitiveness of proposals or the cost to the Department. Proposers whose proposals, past performance or current status do not reflect the capability, integrity or reliability to fully and in good faith perform the requirements of

the Contract may be rejected as non – responsible. The Department reserves the right to determine which proposals meets the material requirements of the solicitation, and which proposers are responsible.

Responsible or qualified proposer means a person or firm with the capability in all respects to perform fully the contract requirements and the integrity and reliability to assure good faith performance. Failure to provide information to determine responsibility in response to a condition of a proposal requiring information may be cause for such proposal to be rejected.

**NOTE:** Solicitations will be considered only from respondents who are regularly engaged in the subject service/products business, are financially responsible, and who have the necessary equipment and personnel to provide the services and goods required by the solicitation.

**1.7 COSTS OF DEVELOPING AND SUBMITTING PROPOSAL, OWNERSHIP:** Neither the Department nor the State is liable for any of the costs incurred by proposers in preparing and submitting a proposal. All proposals become the property of the Department upon receipt and will not be returned to the proposer once opened. The Department shall have the right to use any and all ideas or adaptations of ideas contained in any proposal received in response to this solicitation. Selection or rejection of the proposal will not affect this right.

**1.8 AUTHORIZED REPRESENTATIVE:** A representative who is authorized to contractually bind the proposer shall sign the proposal and any addenda. Only written inquires from proposers, which are signed by persons authorized to contractually bind that company, will be recognized by the Department as duly authorized expressions on behalf of the proposer. See attached Form PUR 1001, paragraph 5.

**1.9 ADDENDA:** Any and all addenda to this solicitation will be issued in writing and posted on the Florida Vendor Bid System at: [http://vbs.dms.state.fl.us/vbs/search.criteria\\_form](http://vbs.dms.state.fl.us/vbs/search.criteria_form) , and on the Department's web site at [http://www.flhsmv.gov/purchasing/html/bid\\_log.html](http://www.flhsmv.gov/purchasing/html/bid_log.html). Proposers may be required to acknowledge receipt of addenda in writing.

**Any addenda or written answers supplied by the Department Procurement Officer to participating proposer's written questions become part of this solicitation.**

**1.10 EMPLOYMENT OF UNAUTHORIZED ALIENS:** The Department shall consider the employment by any proposer of unauthorized aliens a violation of the Immigration and Nationalization Act. Such violation shall be cause for unilateral cancellation of the contract.

**1.11 DRUG FREE WORKPLACE PROGRAM:** The proposer agrees to implement a drug free workplace program as defined in 287.087, Florida Statutes.

**1.12 PUBLIC ACCESS TO DOCUMENTS:** This contract may be unilaterally canceled by the Department for refusal by the proposer to allow public access to all documents, papers, letters, or other material made or received by the proposer in conjunction with this contract, unless the records are exempt from Section 24(A) of Article 1 of the State constitution and Section 119.07(1), Florida Statutes.

**1.13 PUBLIC ENTITY CRIMES:** See attached Form PUR 1001, Paragraph 7.

**1.14 DIVERSITY:** This contract shall be interpreted with diversity in mind to unite Floridians behind a shared vision of opportunity and diversity in state contracting without discriminating against one racial group or another.

**1.15 DISCRIMINATION:** See attached Form PUR 1001, Paragraph 8.

**1.16 TAXES:** See attached Form PUR 1000, Paragraph 16. The Department shall have no responsibility for the payment of taxes which become payable by the contractor or its subcontractor in performance of the contract.

**1.17 EXTRANEIOUS TERMS AND CONDITIONS:** See attached Form PUR 1000 Paragraph 42, and PUR 1001, Paragraph 4.

**1.18 CANCELLATION:** This contract shall be subject to cancellation by DHSMV should DHSMV determine that either one of the following events has occurred:

1. The contractor has failed to comply with the terms and conditions contained herein, or
2. The contract has become the subject of a cause of action or challenge in any State or Federal Court or administrative forum.

**1.19 TERMINATION FOR CAUSE:** The Department reserves the right to terminate the contract by providing written notice to the contractor(s) in accordance with the attached Form PUR 1000, Paragraph 23.

**1.20 TERMINATION BY MUTUAL AGREEMENT:** With the mutual agreement of both parties, the contract or any part of the contract may be terminated on an agreed date prior to the end of the contract period without penalty to either party.

**1.21 TERMINATION IN THE BEST INTERESTS OF THE STATE:** See Form PUR 1000, Paragraph 22.

**1.22 CONTRACTOR'S RESPONSIBILITIES UPON TERMINATION:** After receipt of notice of termination, and except as otherwise specified by the Department, the contractor(s) shall:

- a. Stop work under this contract on the date, and to the extent specified, in the notice.
- b. Place no further order(s) or subcontract(s) for materials, services, or facilities except as may be necessary for completion of such portion of the work under this contract that is not terminated.
- c. Complete performance of such part of the work as shall not have been terminated by the Department; and
- d. Take such action as may be necessary, or as the Department may specify, to protect and preserve any property related to this contract which is in the possession of the contractor(s) and in the Department has or may acquire an interest.

Upon the effective date of termination of the contract, the Contractor shall transfer, assign, and make available to the Department of Highway Safety and Motor Vehicles all property and materials belonging to the Contractor, all rights and claims to any and all reservations, contracts and arrangements with subcontractors, or others, and shall make available to the Department all written information regarding the performance of the contract. No extra compensation will be paid to the Contractor for its services in connection with such transfer or assignment. The Department concurrently with such transfer or assignment shall assume the obligations of the Contractor if any, on all non-cancelable contracts with third parties.

Upon termination of the contract by the Department of Highway Safety and Motor Vehicles, the Contractor shall be deemed to have released and relinquished to the Department of Highway Safety and Motor Vehicles any and all claims or rights it may otherwise have to common law or statutory copyright with respect to all or any part of material prepared or created by the Contractor in the course of its performance, except as otherwise provided in this solicitation.

**1.23 DELIVERY:** All prices shall be freight on board (FOB) destination in accordance with 672.319(1)(b), Florida Statutes. The Department will not pay freight charges. Delivery shall be to:

Installation and/or delivery dates and destinations may be changed by mutual consent of the contractor and the Department. Such mutual consent must be in writing and signed by the contractor and the Department.



**1.24 CONTRACTUAL SUBMISSIONS:** A proposer's response to this solicitation shall be considered as the proposer's formal offer. There will be no separate contract other than the purchase order.

**1.25 CONTRACTOR RESPONSIBILITY:** The Department will consider the contractor to be the sole point of contact with regard to contractual matters. The contractor will assume sole responsibility for providing the commodities and services offered in its proposal whether or not the contractor is the supplier of said commodities and services or any component.

**1.26 DISCUSSIONS:** Prior to the Department determining whether proposals have been submitted in accordance with the requirements of this solicitation, any discussion by the proposer with an employee or authorized representative of the State involving cost information will result in rejection of said proposer's response.

No negotiations, decisions, or actions shall be initiated or executed by a proposer as a result of any discussion with any state employee. Only those communications which are in writing from the Bureau of Purchasing and Contracts may be considered as a duly authorized expression on behalf of the Department. Any inquiries from proposers shall be submitted in writing as required in Section 1.3 or in accordance with the attached PUR 1001, Paragraph 5.

**1.27 NON – EXCLUSIVE RIGHTS:** The right to provide the commodities/services, which will be granted under the contract shall not be exclusive. The Department reserves the right to contract for and purchase commodities and services from as many firms as it deems necessary without infringing upon or terminating the contract.

**1.28 ASSIGNMENT OF THE CONTRACT:** See attached Form PUR 1000, Paragraph 29. The contract is not assignable except with prior written approval of the Department.

**1.29 BENEFIT:** The contract is for the benefit of the Department and the contractor and not for the benefit of any third party or person.

**1.30 INTENTIONS:** It is the intent of the State to acquire a complete working system. Any incidental items omitted from these specifications shall be provided as part of the proposer's price proposal in order to deliver a working system and be in compliance with the specifications and requirements of this solicitation.

**1.31 MINOR BID EXCEPTIONS:** This Department reserves the right to waive minor deviations or exceptions in proposals providing such actions are in the best interest of the State of Florida. Minor deviations/exceptions are defined as those that have no adverse effect upon the State's interest and would not affect the outcome of the award by giving a proposer an advantage or benefit not enjoyed by other proposers.

**1.32 SILENCE OF SPECIFICATIONS:** The apparent silence of specifications set forth in the solicitation and contract to any details or the omission from it of a detailed description, concerning any point shall be regarded as meaning that only the best commercial practices are to prevail and that only materials and workmanship of first quality is to be used. All interpretations of this solicitation shall be made upon the basis of this statement.

**1.33 SMALL BUSINESS PARTICIPATION:** Florida is a state rich in its diversity. The Department of Highway Safety & Motor Vehicles is dedicated to fostering the continued development and economic growth of small and minority and women-owned businesses. Central to this is the participation of a diverse group of vendors doing business with the state.

To this end, it is vital that minority and women-owned business enterprises participate in the State's procurement process as both prime contractors and subcontractors under prime contracts. Small and minority and women-owned businesses are strongly encouraged to submit replies to this solicitation.

**1.34 CONTRACT:** The contract resulting from this solicitation process shall consist solely of the purchase order issued by the Department to the successful proposer, this solicitation and any addenda thereto, and the proposal, including any license/use agreement submitted by the successful proposer as part of its proposal except to the extent of any conflict with Florida law or terms and conditions of the proposal. In the event of a conflict among any of the documents referenced herein, the following priority shall apply, with the language of each listed document governing the documents listed below it:

- a. The purchase order
- b. Any addenda to the solicitation
- c. The solicitation
- d. The awarded proposal

**1.35 DEFAULT:** Failure of the contractor to perform according to the contract shall be cause for the contractor to be found in default. In the event of default, any and all reprocurement costs, along with any other remedies provided in the solicitation, contract and/or by rule or law, may be charged against the contractor.

**1.36 PRIDE: Prison Rehabilitative Industries and Diversified Enterprises, Inc. (PRIDE):** The State supports and encourages the use of Florida Correctional work programs. See attached Form PUR 1000, Paragraph 40. Suppliers will use PRIDE commodities/services where applicable.

**1.37 RESPECT:** The State Supports and encourages the gainful employment of citizens with disabilities. See attached Form PUR 1000, Paragraph 41. Suppliers will use RESPECT commodities/services where applicable.

**1.38 ADDITIONS/UPGRADES/DELETIONS:** During the term of the contract resulting from this solicitation, the Department shall have the right to add/delete services/products upon mutual written agreement of both parties. **2.2 TERM OF CONTRACT:** Refer to attached Form PUR 1000, Paragraph 27. The contract shall be in effect upon issuance of a purchase order or a contract signed by both parties. The term shall be as specified on the Purchase Order issued pursuant to this contract, with a three (3) year initial contract term and two (2) One (1) year renewal options at Department discretion contingent upon satisfactory service, unless terminated earlier by the Department under the terms provided herein, subject to an annual appropriation by the State Legislature. If at any time the contract is canceled, terminated, or expires, and a contract is subsequently executed with a firm other than contractor, contractor has the affirmative obligation to assist in the smooth transition of contract services to the subsequent contractor. **2.3 PROPOSAL GUARANTEE:** The original response must be accompanied by a proposal guarantee payable to the State of Florida in the amount of 5% of the cost for the initial contract term; the respondent must be the guarantor. If responding as a joint venture/legal partnership, at least one party of the joint venture/legal partnership shall be the guarantor. **2.4 PROPOSER'S INQUIRIES:** The proposer shall examine the solicitation to determine if the State's requirements are clearly stated. If there are any requirements that restrict competition, the proposer may request, in writing, to the State that the specifications be changed. The proposer who requests changes to the State's specifications must identify and describe the proposer's difficulty in meeting the State's specifications, must provide detailed justification for a change, and must provide recommended changes to the specifications. **2.5 INDEPENDENT CAPACITY OF CONTRACTOR:** The parties hereto agree that the proposer, its officers, agents and employees, in the performance of this Contract, shall act in the capacity of an independent contractor and not as an officer, employee or agent of the State. Proposer agrees to take such steps as may be necessary to ensure that each sub-contractor of proposer will be deemed to be an independent contractor and will not be considered or permitted to be an agent, servant, joint venturer, or partner of State. All persons furnished, used, retained, or hired or on behalf of proposer or such sub-contractor, and proposer shall be responsible for payment of any and all unemployment, social security, and other payroll taxes for such persons, including any related assessments or contributions required by law.

**2.6 TECHNICAL DOCUMENTATION:** All products bid must meet or exceed all conditions and specifications of the solicitation. When technical documentation is required by this solicitation, its purpose is to demonstrate compliance of the product bid with applicable technical requirements of the solicitation and to allow a technical evaluation of the product. **2.8 BID OPENING:** Bids will be opened in Room B409, Neil Kirkman Building, at the date and time shown in the Calendar of Events (Section 2.1 of the solicitation).

**2.9 VALUE ANALYSIS AND CHANGES TO SPECIFICATIONS:** The agency is always interested in reducing product/service costs while preserving or improving the usefulness of the product/service for its intended purpose. Proposers are encouraged but not required to perform a process of value analysis of the item(s) of bid, in cooperation with agency representatives, and offer suggestions for changes to product/service specifications or contract terms and conditions. In analyzing an item or service, the following steps are suggested: List the materials and processes involved in manufacture, packaging and delivery.

**2.10 CONTRACTOR'S INSURANCE:** See attached Form PUR 1000, Paragraph 35. The contractor shall not commence any work in connection with the contract until he has obtained all of the following types of insurance and such insurance has been approved by the purchaser, nor shall the contractor allow any subcontractor to commence work on a subcontract until all similar insurance required of the subcontractor has been so obtained and approved.

- a. **WORKERS COMPENSATION INSURANCE:** The contractor shall take out and maintain during the life of this agreement, Worker's Compensation Insurance for all of his employees connected with the work of this project and, in case any work is sublet, the contractor shall require the Subcontractor similarly to provide Worker's Compensation Insurance for all of the latter's employees unless such employees are covered by the protection afforded by the contractor. Such insurance shall comply fully with the Florida Worker's Compensation law. In case any class of employees engaged in hazardous work under this contract at the site of the project is not protected under the Workman's Compensation statute, the contractor shall provide, and cause each Subcontractor to provide, adequate insurance, satisfactory to the purchaser, for the protection of his employees not otherwise protected.
- b. **CONTRACTOR'S PUBLIC LIABILITY AND PROPERTY DAMAGE INSURANCE:** The contractor shall take out and maintain during the life of this agreement Comprehensive General Liability and Comprehensive Automobile Liability insurance that will protect the proposer from claims for damage for personal injury, including accidental death, as well as claims for property damages which may arise from operating under this agreement whether such operations are by the proposer or by anyone directly or indirectly employed by the proposer, and the amount of such insurance shall be the minimum limits as follows:
  1. Contractor's Comprehensive General Liability Coverage, Bodily Injury & Property Damage: \$100,000.00 Each Occurrence, Combined Single Limit.
  2. Automobile Liability Coverage, Bodily Injury & Property Damage: \$ 50,000.00 Each Occurrence, Combined Single Limit Insuring clause for both Bodily Injury & Property Damage shall be amended to provide coverage on an occurrence basis.
- c. **SUBCONTRACTOR'S PUBLIC LIABILITY AND PROPERTY DAMAGE INSURANCE:** The contractor shall require each of his subcontractors to secure and maintain during the life of the subcontract, insurance of the type specified above or insure the activities of his subcontractors in his policy as specified above.
- d. **LOSS DEDUCTIBLE CLAUSE:** The Department shall be exempt from, and in no way liable for, any sums of money, which may represent a deductible in any insurance policy. The payment of such deductible shall be the sole responsibility of the contractor providing such insurance.

**2.11 E-VERIFY REQUIREMENT:** Pursuant to the State of the Florida Executive Orders Nos.: 11-02 and 11-116, Awarded Contractor is required to utilize the U.S. Department of Homeland Security's E-Verify system to verify the employment of all new employees hired by the Contractor during the contract term. Also, the Awarded Contractor shall include in related subcontracts a requirement that subcontractors performing work or providing services pursuant to the state term contract utilize the E-Verify system to verify employment of all new employees hired by the subcontractor during the contract term.

### 3.0 TECHNICAL REQUIREMENTS/SPECIFICATIONS:

**3.1 FHP LIGHTBAR SPECIFICATION:** The light bar shall be a single level emergency warning light system. The primary warning signal shall be comprised of PriZm II™ LED reflector multi-color (MC) light heads positioned in the front, corners, and rear of the light bar. The light bar shall also contain uniquely designed LED optic heads that serve as alley and takedown lights. The light bar shall have a minimum of 12 red/blue PriZm II™ LED reflector multi-color (MC) light heads. Each PriZm II™ LED reflector multi-color (MC) light head shall contain a minimum of 22 LEDs.

The Prizm II™ light head is constructed from a durable polycarbonate specifically designed to withstand harsh environmental conditions including extremely high and low temperatures. The reflective service of the Prizm II™ light head is vacuum metalized and is finished with a polymer topcoat to maximize both the reflective ability of the surface as well as stand up much longer to the everyday environmental conditions that exist. Reflector modules that use other methods of applying and finishing the reflective surface are unacceptable.

The front facing outboard sections of the light bar shall be equipped with 2 white 5-LED Take Down (TD) lights that are configured to operate with the front facing PriZm II™ red/blue LED light heads to function as a Massive LED TD light. The TD lights shall also be capable of operating as flashing lights with multiple selectable flash patterns.

Each outboard section of the light bar shall be equipped with an outward facing white 5-LED Alley Light aligned with the longitudinal axis of the light bar. Each Alley Light shall be capable of operating independently. The Alley Lights shall also be capable of operating as flashing lights with multiple selectable flash patterns.

The TD and Alley Lights shall be capable of operating as separate and independent functions.

The light bar shall be equipped with a photocell to sense ambient light conditions and cause the light bar to switch between DAY and NIGHT mode. The light bar shall have a dedicated output that is indirectly driven by the photocell based on ambient light that may be used to cause the LEDs of an external LED directional arrow device or flashing LED light to switch to dim mode for NIGHT operation, if desired. This output shall exit the light bar in a separate pluggable 2-conductor cable and may be omitted from the installation if desired without changing the light bar configuration. This output shall be a nominal +12VDC when active (Night Mode).

**3.1.1 DAY/NIGHT MODE:** In DAY Mode Level 1 and Level 2 shall flash all Red LEDs except the Rear and Front Inboards Blue LEDs will flash. In NIGHT Mode Level 1 and Level 2 shall flash all Blue LEDs except the Rear and Front Inboard Red LEDs will flash and the Red/Blue flashing LEDs will operate in DIM mode.



**3.1.2 OPERATION:** All control inputs for the light bar shall be nominal +12VDC when active. The light bar shall have the following functionality:

The siren control's 3-Level switch shall cause the light bar to operate as follows:

Level 1 Rear & Rear Corners in Cycle Flash

Level 2 All Light Bar in Cycle Flash

**Note: Level 1 and Level 2 shall flash the LED light heads in Red and Blue except when the vehicle transmission is in PARK. When the vehicle is in PARK, the photo-cell sensor will cause Level 1 and Level 2 to operate in DAY/NIGHT mode as specified in the DAY/NIGHT Mode description above.**

Level 3	All Red and Blue light heads will flash regardless of the ambient light conditions.
Rear Cut	This mode shall disable rear facing flashing LEDs and rear corner flashing LEDs regardless of the current flashing mode.
Front Cut	This mode shall disable front facing flashing LEDs and front corner flashing LEDs regardless of the current flashing mode.
TD Lights	Takedown Lights shall operate in steady burn mode and all front Red/Blue LEDs shall operate in steady burn mode to create a Massive TD Light.
Right Alley Light	The white 5-LED Right Alley Light shall be capable of operating independently in steady burn mode.
Left Alley Light	The white 5-LED Left Alley Light shall be capable of operating independently in steady burn mode.
Takedown Flash	The white 5-LED TD Light shall be capable of operating in flashing mode to provide additional flashing lights if desired. Multiple selectable flash patterns shall be provided.
Alley Flash	The white 5-LED Alley Lights shall be capable of operating in flashing mode to provide additional flashing lights if desired. Multiple selectable flash patterns shall be provided.
NSSW Input	The Light Bar shall be equipped with an internal photocell and have the capability to switch between DAY/NIGHT Mode based on the ambient light condition and the position of the vehicles Park/Neutral switch. The internal photocell shall be enabled when the vehicle is in Park.

**3.1.3 SIZE:** The light bar shall have a nominal size of 44" L x 11.75" W x 3.5" H, excluding mounting hardware. Light bars with dimensions longer, taller, or wider than these dimensions shall be unacceptable.

**3.1.4 LENS CONSTRUCTION:** The light bar shall consist of three separate lenses: two outboard and one center lens. All three of these lenses shall be clear. These lenses shall be made of an impact-resistant, polycarbonate plastic molding and shall be of a one piece construction. Lens configurations made up of multiple pieces of plastic or polycarbonate shall not be acceptable. To achieve a weather-tight seal, the lenses shall be fitted into a specifically designed groove in the extruded aluminum light bar frame and shall employ a fixed horizontally compressed gasket system. Light bars using vertically compressed gasket sealing systems are not acceptable.

**3.1.5 MOUNTING:** Light Bar Mounting Hardware shall be provided at no extra charge and shall be designed to fit the vehicle specified with each order.

**3.1.6 OPERATIONAL SPECIFICATIONS:** The Light bar shall be suitable for installation on negative ground vehicles and operate within a voltage range of 10-16VDC. The light bar shall be capable of operating in ambient temperatures ranging from -22F to 149F. The standby power requirement shall be <0.001ma. The maximum control current shall not exceed a nominal value of 0.10ma @ 13.8VDC. The maximum input current for the Level-3 mode as described above shall not exceed a nominal value of 21A @ 13.8VDC. The maximum input current for the Level-3 with the Massive TD light enabled as described above shall not exceed a nominal value of 28.5A @ 13.8VDC. The Maximum current for the 5-LED TD/Alley Lights shall not exceed a nominal value of 1.1A ea. @ 13.8VDC.

**3.2 FHP SIREN SPECIFICATION:** The siren system shall consist of a separate control head and a siren amplifier with integral lighting controls. The amplifier shall be suitable for remote mounting inside the vehicle. The siren system shall be SAE J1849 and CA Title 13 compliant. The control head and amplifier shall be connected via a single standard network type cable with 8 conductors. All siren, lighting control, and directional arrow functions are controlled via the control head. All wiring and connections to the amplifier shall be via latching plug-in connectors. The siren system shall be capable of simultaneously using multiple control devices without special software. When so equipped, each control device with display capability shall receive and display the updated system status when another control device changes any control setting.

The siren system shall be configurable using Windows PC based software utility provided with the system. The configuration software utility shall be capable of configuring and editing all siren and lighting control functions.

**3.2.1 CONTROL HEAD:** The control head shall be no larger than 6 7/8" long x 3 3/8" tall x 1 1/4" deep. It shall have a weight of no more than 1 1/4 pound. The control head shall have the ability to be mounted in different locations in a vehicle, at the user's discretion, with no effect on its operation.

The control head shall be connected to the remote amplifier via a single standard network type cable with 8 conductors.

The control head shall consist of 3 distinct and separate areas of operation: siren functions and primary lighting, auxiliary lighting and other equipment operation, and directional arrow and flashing functions. These three distinct areas shall be color coded to make the control head operation intuitive, easy and safe.

The control head buttons shall be of different shapes and sizes to make them easy to quickly identify without having to look down. These buttons shall be backlit and change color when activated.

Siren control systems with universal sized buttons, buttons that do not change color when activated, or are all in one area with no distinctions are unacceptable.

**3.2.2 SIREN FUNCTIONS:** The siren tone generation functions shall be activated through 5 distinctive switch buttons located in the red colored siren section. Each of these buttons shall be configurable for different siren tones and air horn sounds. In compliance with SAE requirements, 1 of the 5 buttons shall be labeled "WAIL" and 1 of the 5 buttons will be labeled "YELP" to identify the default sound that will be produced by activating these buttons. Additionally, 1 of the 5 buttons shall be labeled as Air Horn to identify the default sound that will be produced when that button is activated. However, these buttons shall be programmable for other tones if desired and allowed under local laws. There shall be multiple siren tone and air horn sounds available for selection within the configuration software utility described above.

The siren functions and air horn shall also be controllable via the horn ring or a remote switch if desired. Remote switch or Horn Ring control shall allow the siren functions and air horn to be operated in a scroll mode, a hit and go mode, a scroll on/off mode, a manual wail mode, a wail stop mode, or in a minimum of two different air horn only modes. These options shall be user selectable and programmable using the configuration software utility described above.

The siren system shall have an integral Horn Ring Transfer function that will automatically transfer the vehicle's horn control circuit to the siren control circuit when the desired siren or lighting function is selected. This feature shall be configurable by the configuration software utility described above.

The polarity of the horn ring or remote switch input shall be configurable for positive or negative input without opening the amplifier case, by using the configuration software utility described above.

The siren system shall be capable of being activated directly from the vehicle's horn circuit. This feature shall be activated or deactivated by one of the 8 auxiliary switches on the control head. This feature shall be configurable through the configuration software utility.

The control head shall provide a user selectable function for Radio Rebroadcast (RRB) to allow the 2-way radios receive audio to be routed through the siren amplifier via one of the 8 auxiliary switches. The RRB volume shall be user adjustable using the control head buttons. This RRB function shall be configurable through the configuration software utility described above.

A standard noise-canceling microphone shall be provided to allow the siren amplifier to be used for Public Address. For ease of installation and service, the siren system's PA microphone shall plug into the control head using a standard RJ11 4 conductor plug. Siren systems that require the microphone to be connected to the control head internally or connected directly to the remote amplifier are unacceptable.

To prevent inadvertent restriction of the siren control head functions by the accidental closure of the PA microphone push-to-talk (PTT), the PA function shall have an integral PTT time out function which will automatically disable the PA function when the PTT switch is depressed for a period of time exceeding a predetermined interval. Releasing and re-engaging the PTT switch shall immediately restore the normal operation of the PA function. Siren systems that do not have this PTT Time-Out feature are unacceptable.

PA volume, RRB Volume and control head backlighting intensity shall be user adjustable using the control head buttons.

The siren amplifier shall be capable of driving up to two 100-watt speakers. The output sound pressure level and characteristics shall be compliant with SAE J1849. All bidders shall provide a complete test report, from an AMECA accredited test laboratory, showing SAE J1849 compliance for the siren system being offered.

The siren section shall not have an on/off switch. Choosing any siren function or keying the microphone will activate the selected function. The Instant On feature shall be designed to operate when the vehicle's ignition switch is on to prevent undesirable loading of the vehicle's battery. The siren system shall have a configurable internal timer function that allows the siren to remain on and fully functional for a selected length of time after the vehicle ignition is turned off, if desired.

The siren amplifier section shall have output short circuit protection so that in the event that the speaker driver or speaker wiring becomes shorted the amplifier will automatically switch to standby mode to protect itself from damage. The siren shall continue to test the speaker circuit and shall resume normal operation when the fault is removed.

**3.2.3 LIGHTING FUNCTIONS:** The lighting functions shall consist of the following: A three level programmable slide switch (**Warning Level #1, Warning Level #2, Warning Level #3a, & 3b**) with LED's for visual switch position indication. These outputs shall have a total capacity of 50 amperes. The operation of this slide switch shall be configurable to allow all other siren and lighting control functions to be associated with any or all of the 3 positions of the switch. The slide switch shall also be configurable to allow it to operate as a progressive, semi-progressive, independent or user selected switch. These features shall be configurable through the configuration software utility.

In addition, there shall be 8 auxiliary switch buttons. These 8 buttons shall be located within a segregated section of the control head with a color coded background in order to allow the operator to easily locate and identify the desired button. Four of these buttons shall have a current rating of not less than 5 amps each and four buttons shall have a current rating of not less than 10 amps. The total combined capacity of these buttons shall be not be less than 50 amps. Each of these buttons shall be programmable to function as a latching (push on - push off), momentary or timed switch, or as part of a hands free program that allows activation of the siren from the horn ring or to activate the RRB feature. Two of the buttons shall be programmable to provide either positive or negative output. Any of these 8 switch buttons shall be configurable to be disabled when the ignition is turned off. These features shall be configurable through the configuration software utility.

These switch buttons shall be back lighted and shall change color from red to blue when activated. A legend set allowing the user to change the marking of these auxiliary buttons shall be provided as part of the system package.

In addition to LED indication, all of the lighting functions can also have an audible indication that the function is active. This function shall be configurable using the configuration software utility described above and shall be capable of being enabled/disabled on a switch by switch based as desired.

A standard function shall also be available that automatically deactivates siren tones and deactivates Warning Level #3a and/or 3b when the vehicle is shifted into park. This function shall remain active until the vehicle is taken out of park and a siren control head button is depressed. The 8 auxiliary switch buttons described above shall be configurable to turn off automatically when the vehicle is shifted into park if required. This function shall be configurable using the configuration software described above. The siren amplifier input associated with this function shall be configurable to allow for positive or negative input when active without opening the amplifier case, by using the configuration software utility described above.

A standard function shall preclude siren tones, except air horn, from sounding until the 3-Level lighting slide switch is set to Warning Level 1, 2 or Warning Level 3. This function shall prevent use of the siren tones without the emergency warning lights being activated. This function shall be configurable using the configuration software described above and can be disabled if desired.

A standard feature shall allow the siren system to remain fully functional and active for a preset period of time after the vehicle ignition is turned off. This feature shall allow the siren controller to be set to turn off at a preset interval after the vehicle ignition power is removed. Using the configuration utility described above, this function shall be configurable to allow for a 10, 20, 30, 60, 120, or 240 minute period before the siren system turns off. For added security, any of the 8 auxiliary switch buttons shall be configurable to be disabled when the ignition is turned off but the siren system is still operating under the above described timer feature. This function may be disabled if desired.

The lighting control functions described above shall be provided with internal circuit protection fuses that are easily accessible for service via a fuse panel cover that requires the removal of not more than one screw to provide full access to the fuses. The fuse panel cover shall have a fuse map internally attached to allow for easy trouble shooting and service. Systems that require the removal of the amplifier cover to change fuses or that have fuses protruding through the top of the amplifier case are unacceptable.

When on, the lighting control functions described above shall be continuously tested by a microprocessor driven algorithm to insure that the output is functional. Each of these lighting control functions shall be provided with a visual LED indicator function at the control head that flashes when a fuse is blown or a selected lighting output is activated but has no valid output. Systems that do not provide this real time fault indication are not acceptable.

**3.2.4 DIRECTIONAL ARROW & FLASHING FUNCTIONS:** The Directional Arrow and flashing function control switches shall be located within a segregated section of the control head with a color coded background in order to allow the operator to easily locate and identify the desired button. This section shall consist of 5 buttons intended to control the directional arrow and warning flash pattern and dimming function. These buttons shall be labeled "LEFT, CENTER, RIGHT, FLASH & DIM". Three of the buttons shall control the function of the directional arrow and shall be configurable to provide different arrow patterns and speeds. The flash button is designed to provide warning flash patterns and can be programmed to provide different flash patterns and flash rates. A series of LED's located directly above the 5 buttons shall provide a visual indication that a directional arrow or flash pattern is active.

The DIM button is designed to dim the light output of the traffic direction device as well as any other warning lights connected to the system that are capable of dimmed operation. The DIM function shall be automatically deactivated any time the 3-Level switch position is changed. In any case, the DIM function may be reactivated by the operator as desired. The DIM function shall be configurable to provide Pulse Width Modulation (PWM) dimming when applicable.

The directional arrow section shall also have the ability to simultaneously operate both a traffic direction device built into a light bar and an external traffic direction device. Controllers that do not have this ability are unacceptable.

**3.2.5 LOAD MANAGEMENT:** The siren system shall be capable of performing load management functions for all of the warning equipment in and on the vehicle. This load management functionality must be configurable using the configuration software described above and shall provide the following functionality: turn off preselected groups of equipment at selected voltages and after a selected time period. To provide for the highest level of operator safety, the load management function shall provide at least three configurable load categories allowing loads to be grouped into safety critical and non-critical groups. To protect the siren speaker, the system shall provide over voltage protection in the event of vehicle electrical system over-voltage. When an over-voltage condition exists, the siren tone output shall be disabled. For emergency operation of the siren during over-voltage conditions, the system shall allow for a user over-ride of this feature.

To prevent false over-voltage sensing, the over voltage protection feature shall operate by a microprocessor driven algorithm that senses the vehicle system voltage over a period of time and mathematically determines when an over-voltage condition actually exists. All load management functionality shall be configurable and may be reconfigured or disabled if desired. Siren systems that do not provide built in Load Management Functionality are unacceptable.

**3.2.6 SYSTEM CONFIGURATION:** The siren system shall be designed to be fully programmable using a standard A-male to A-male USB cable connected to a PC utilizing Microsoft® Windows XP or Windows 7. The configuration shall be done utilizing an intuitive configuration software utility that is easily loaded onto any PC running Windows XP or Windows 7.

The configuration file shall be downloaded to the remote amplifier through the USB cable, and shall also have the ability to be saved and downloaded from the PC to multiple amplifiers as desired. The Configuration Utility shall also have the capability to extract the configuration file from a siren amplifier already in service.

Systems that do not allow editing, loading, extracting and saving of configuration files or the ability to quickly program multiple systems are not acceptable.

**3.2.7 REMOTE AMPLIFIER:** The remote amplifier shall be no larger than 9 ¾" long x 4" tall x 6 7/8" wide. It shall have a weight of no more than 4 ¼ pounds. The amplifier shall be mounted using no more than 4 screws to allow for easy installation and servicing. All of the connections shall be located on one side of the amplifier and shall be made via latching quick-disconnect connectors to allow for easy installation and servicing.

Systems that utilize screw terminals, quick slide terminals, other connection means or have connections made on more than one side of the amplifier are not acceptable.

The remote amplifier shall also come with all the necessary mounting hardware and terminated wiring set to allow for easy installation and service. All wiring shall be labeled or color coded to clearly define functionality.

The remote amplifier shall be designed to provide over current and over temperature sensing for the lighting control output devices and shall be capable of automatically disabling an output to prevent damage. The remote amplifier shall also be protected with internal mini ATO fuses to prevent damage in the event of external short circuit of the wiring. These fuses shall be easily accessible and changeable through a door located on the top of the amplifier or directly on the cable entry side of the amplifier. The lighting control fuses shall be easily accessible for service via a fuse panel cover that requires the removal of not more than one screw to provide full access to the fuses.

Systems that require the removal of the amplifier cover to change fuses or that have fuses protruding through the top of the amplifier case are unacceptable.

**3.2.8 OPERATIONAL SPECIFICATIONS:** The siren shall operate at voltages ranging from 10-15VDC, negative ground vehicles. The ambient temperatures ranging from -22F to 149F.

**3.3 REMOTE CONTROL SPECIFICATION:** The remote control interface shall be based on a Wi-Fi type interface that is compatible with commonly available Wi-Fi enabled smart phones. The minimum acceptable operating system compatibility range is IOS and Android systems. The remote control system shall have an operating range of not less than 300 feet. The overall dimensions of the remote control interface unit shall not exceed an overall size of 7.5W x 4.5D x 2.5H (including antenna). The unit weight of the remote control interface unit shall not exceed 1lb (.45 kg). The nominal input voltage for the system shall be 10 to 16VDC. The input operating current of the remote control interface unit shall not exceed 0.2 A @ 13.8VDC

The interface shall provide direct plug-in interface to the emergency warning siren system and a graphical user interface (GUI) that allows control of the siren system functions.

**3.3.1 GRAPHICAL USER INTERFACE (GUI):** The GUI shall have two pages for the control functions. Page 1 will provide a minimum of 8 control buttons with a 9<sup>th</sup> button that provides access to page 2. Page 2 will display a graphical representation of the siren system control head that depicts a working facsimile of the siren system control head.

The 8 control buttons on the GUI page 1 shall be configurable by the user to allow the switches to be associated with any of the siren system control functions and to be set to operate in latching, timed or momentary modes. The 8 control buttons on GUI page 1 shall be designed to allow the user to change the legend text on each button to better meet the labeling requirements of the application. The legend text editing feature shall support any language that is supported by the smart phone being used.

This editing feature shall be available using the capability of the smart phone with no external resources required. User access to the editing feature will be limited by disabling the access button after the GUI has been active from more than ten seconds. Systems that do not provide these features are not acceptable.

**3.3.2 POSITIVE FEEDBACK:** The remote control system shall be designed to provide positive feedback when a switch function is actuated by the user. This feature shall cause the appearance of the actuated button on the GUI to change when an acknowledgment is received from the siren system. This change in appearance shall only occur after an acknowledgment is received thus indicating a successful transmission and reception of the command. Systems that do not provide this feature are not acceptable.

**3.3.3 NETWORK SECURITY:** The remote control system shall have security features that prevent unauthorized access. The minimum acceptable security features shall be editable SSID (Network Name), User Defined Password and MAC Address recognition. Additional security features are acceptable. The system shall be capable of supporting up to 4 individual users but shall recognize only the authorized user currently connected (one user at a time). Systems that do not provide these security features are not acceptable.

**3.3.4 WIRING CONNECTIONS:** The All wiring connections to the amplifier shall be via latching plug-in connectors. The siren system shall be capable of simultaneously using multiple control devices without special software. When so equipped, each control device with display capability shall receive and display the updated system status when another control device changes any control setting.

The above warranty begins from the date of purchase, delivery, or In-Service date, whichever is later. Units demonstrated to be defective within the warranty period would be repaired or replaced (at Suppliers sole discretion) at the Factory Service Center at no cost. **All Labor Cost** and **Shipping Charges** (both ways) shall be at the expense of the manufacturer for the **First Year** after delivery of the assemblies. Thereafter, Labor Cost and Shipping Charges from the Department to the manufacturer shall be at the sole expense of the Department. Return shipping charges from the manufacturer to the Department shall be at the expense of the manufacturer during the warranty period.

Supplier/Manufacturer agrees to provide a “pool” of service parts to FHP at mutually agreed upon quantities and locations, approximately:

- 15 to 20 Siren Amps
- 15 to 20 Siren Control Heads
- 60-100 LED Light bar Modules

**1. Definitions.** The definitions contained in s. 60A-1.001, F.A.C. shall apply to this agreement. The following additional terms are also defined:

(a) "Contract" means the legally enforceable agreement that results from a successful solicitation. The parties to the Contract will be the Customer and Contractor.

(b) "Customer" means the State agency or other entity identified in a contract as the party to receive commodities or contractual services pursuant to a contract or that orders commodities or contractual services via purchase order or other contractual instrument from the Contractor under the Contract. The "Customer" may also be the "Buyer" as defined in the PUR 1001 if it meets the definition of both terms.

(c) "Product" means any deliverable under the Contract, which may include commodities, services, technology or software.

(d) "Purchase order" means the form or format a Customer uses to make a purchase under the Contract (e.g., a formal written purchase order, electronic purchase order, procurement card, contract or other authorized means).

**2. Purchase Orders.** In contracts where commodities or services are ordered by the Customer via purchase order, Contractor shall not deliver or furnish products until a Customer transmits a purchase order. All purchase orders shall bear the Contract or solicitation number, shall be placed by the Customer directly with the Contractor, and shall be deemed to incorporate by reference the Contract and solicitation terms and conditions. Any discrepancy between the Contract terms and the terms stated on the Contractor's order form, confirmation, or acknowledgement shall be resolved in favor of terms most favorable to the Customer. A purchase order for services within the ambit of section 287.058(1) of the Florida Statutes shall be deemed to incorporate by reference the requirements of subparagraphs (a) through (f) thereof. Customers shall designate a contract manager and a contract administrator as required by subsections 287.057(15) and (16) of the Florida Statutes.

**3. Product Version.** Purchase orders shall be deemed to reference a manufacturer's most recently release model or version of the product at the time of the order, unless the Customer specifically requests in writing an earlier model or version and the contractor is willing to provide such model or version.

**4. Price Changes Applicable only to Term Contracts.** If this is a term contract for commodities or services, the following provisions apply.

(a) Quantity Discounts. Contractors are urged to offer additional discounts for one time delivery of large single orders. Customers should seek to negotiate additional price concessions on quantity purchases of any products offered under the Contract. State Customers shall document their files accordingly.

(b) Best Pricing Offer. During the Contract term, if the Customer becomes aware of better pricing offered by the Contractor for substantially the same or a smaller quantity of a product outside the Contract, but upon the same or similar terms of the Contract, then at the discretion of the Customer the price under the Contract shall be immediately reduced to the lower price.

(c) Sales Promotions. In addition to decreasing prices for the balance of the Contract term due to a change in market conditions, a Contractor may conduct sales promotions involving price reductions for a specified lesser period. A Contractor shall submit to the Contract Specialist documentation identifying the proposed (1) starting and ending dates of the promotion, (2) products involved, and (3) promotional prices compared to then-authorized prices. Promotional prices shall be available to all Customers. Upon approval, the Contractor shall provide conspicuous notice of the promotion.

(d) Trade-In. Customers may trade-in equipment when making purchases from the Contract. A trade-in shall be negotiated between the Customer and the Contractor. Customers are obligated to actively seek current fair market value when trading equipment, and to keep accurate records of the process. For State agencies, it may be necessary to provide documentation to the Department of Financial Services and to the agency property custodian pursuant to Chapter 273, F.S.

(e) Equitable Adjustment. The Customer may, in its sole discretion, make an equitable adjustment in the Contract terms or pricing if pricing or availability of supply is affected by extreme and unforeseen volatility in the marketplace, that is, by circumstances that satisfy all the following criteria: (1) the volatility is due to causes wholly beyond the Contractor's control, (2) the volatility affects the marketplace or industry, not just the particular Contract source of supply, (3) the effect on pricing or availability of supply is substantial, and (4) the volatility so affects the Contractor that continued performance of the Contract would result in a substantial loss.

**5. Additional Quantities.** For a period not exceeding ninety (90) days from the date of solicitation award, the Customer reserves the right to acquire additional quantities up to the amount shown on the solicitation but not to exceed the threshold for Category Two at the prices submitted in the response to the solicitation.

**6. Packaging.** Tangible product shall be securely and properly packed for shipment, storage, and stocking in appropriate, clearly labeled, shipping containers and according to accepted commercial practice, without extra charge for packing materials, cases, or other types of containers. All containers and packaging shall become and remain Customer's property.

**7. Inspection at Contractor's Site.** The Customer reserves the right to inspect, at any reasonable time with prior notice, the equipment or product or plant or other facilities of a Contractor to assess conformity with Contract requirements and to determine whether they are adequate and suitable for proper and effective Contract performance.

**8. Safety Standards.** All manufactured items and fabricated assemblies subject to operation under pressure, operation by connection to an electric source, or operation involving connection to a manufactured, natural, or LP gas source shall be constructed and approved in a manner acceptable to the appropriate State inspector. Acceptability customarily requires, at a minimum, identification marking of the appropriate safety standard organization, where such approvals of listings have been established for the type of device offered and furnished, for example: the American Society of Mechanical Engineers for pressure vessels; the Underwriters Laboratories and/or National Electrical Manufacturers' Association for electrically operated assemblies; and the American Gas Association for gas-operated assemblies. In addition, all items furnished shall meet all applicable requirements of the Occupational Safety and Health Act and state and federal requirements relating to clean air and water pollution.

**9. Americans with Disabilities Act.** Contractors should identify any products that may be used or adapted for use by visually, hearing, or other physically impaired individuals.

**10. Literature.** Upon request, the Contractor shall furnish literature reasonably related to the product offered, for example, user manuals, price schedules, catalogs, descriptive brochures, etc.

**11. Transportation and Delivery.** Prices shall include all charges for packing, handling, freight, distribution, and inside delivery. Transportation of goods shall be FOB Destination to any point within thirty (30) days after the Customer places an Order. A Contractor, within five (5) days after receiving a purchase order, shall notify the Customer of any potential delivery delays. Evidence of inability or intentional delays shall be cause for Contract cancellation and Contractor suspension.

**12. Installation.** Where installation is required, Contractor shall be responsible for placing and installing the product in the required locations at no additional charge, unless otherwise designated on the Contract or purchase order. Contractor's authorized product and price list shall clearly and separately identify any additional installation charges. All materials used in the installation shall be of good quality and shall be free of defects that would diminish the appearance of the product or render it structurally or operationally unsound. Installation includes the furnishing of any equipment, rigging, and materials required to install or replace the product in the proper location. Contractor shall protect the site from damage and shall repair damages or injury caused during installation by Contractor or its employees or agents. If any alteration, dismantling, excavation, etc., is required to achieve installation, the Contractor shall promptly restore the structure or site to its original condition. Contractor shall perform installation work so as to cause the least inconvenience and interference with Customers and with proper consideration of others on site. Upon completion of the installation, the location and surrounding area of work shall be left clean and in a neat and unobstructed condition, with everything in satisfactory repair and order.



**13. Risk of Loss.** Matters of inspection and acceptance are addressed in s. 215.422, F.S. Until acceptance, risk of loss or damage shall remain with the Contractor. The Contractor shall be responsible for filing, processing, and collecting all damage claims. To assist the Contractor with damage claims, the Customer shall: record any evidence of visible damage on all copies of the delivering carrier's Bill of Lading; report damages to the carrier and the Contractor; and provide the Contractor with a copy of the carrier's Bill of Lading and damage inspection report. When a Customer rejects a product, Contractor shall remove it from the premises within ten days after notification or rejection. Upon rejection notification, the risk of loss of rejected or non-conforming product shall remain with the Contractor. Rejected product not removed by the Contractor within ten days shall be deemed abandoned by the Contractor, and the Customer shall have the right to dispose of it as its own property. Contractor shall reimburse the Customer for costs and expenses incurred in storing or effecting removal or disposition of rejected product.

**14. Transaction Fee.** The State of Florida has instituted MyFloridaMarketPlace, a statewide eProcurement System ("System"). Pursuant to section 287.057(23), Florida Statutes (2002), all payments shall be assessed a Transaction Fee of one percent (1.0%), which the Contractor shall pay to the State, unless exempt pursuant to 60A-1.032, F.A.C.

**For payments within the State accounting system (FLAIR or its successor), the Transaction Fee shall, when possible, be automatically deducted from payments to the Contractor. If automatic deduction is not possible, the Contractor shall pay the Transaction Fee pursuant to Rule 60A-1.031(2), F.A.C. By submission of these reports and corresponding payments, Contractor certifies their correctness. All such reports and payments shall be subject to audit by the State or its designee.**

**Contractor shall receive a credit for any Transaction Fee paid by the Contractor for the purchase of any item(s) if such item(s) are returned to the Contractor through no fault, act, or omission of the Contractor. Notwithstanding the foregoing, a Transaction Fee is non-refundable when an item is rejected or returned, or declined, due to the Contractor's failure to perform or comply with specifications or requirements of the agreement.**

Failure to comply with these requirements shall constitute grounds for declaring the Contractor in default and recovering reprocurement costs from the Contractor in addition to all outstanding fees. **CONTRACTORS DELINQUENT IN PAYING TRANSACTION FEES MAY BE SUBJECT TO BEING REMOVED FROM THE DEPARTMENT OF MANAGEMENT SERVICES' VENDOR LIST AS PROVIDED IN RULE 60A-1.006, F.A.C.**

**15. Invoicing and Payment.** Invoices shall contain the Contract number, purchase order number if applicable, and the appropriate vendor identification number. The State may require any other information from the Contractor that the State deems necessary to verify any purchase order placed under the Contract.

At the State's option, Contractors may be required to invoice electronically pursuant to guidelines of the Department of Management Services. Current guidelines require that Contractor supply electronic invoices in lieu of paper-based invoices for those transactions processed through the system. Electronic invoices shall be submitted to the Customer through the Ariba Supplier Network (ASN) in one of the following mechanisms – EDI 810, cXML, or web-based invoice entry within the ASN.

Payment shall be made in accordance with sections 215.422 and 287.0585 of the Florida Statutes, which govern time limits for payment of invoices. Invoices that must be returned to a Contractor due to preparation errors will result in a delay in payment. Contractors may call (850) 413-7269 Monday through Friday to inquire about the status of payments by State Agencies. The Customer is responsible for all payments under the Contract. A Customer's failure to pay, or delay in payment, shall not constitute a breach of the Contract and shall not relieve the Contractor of its obligations to the Department or to other Customers.

**16. Taxes.** The State does not pay Federal excise or sales taxes on direct purchases of tangible personal property. The State will not pay for any personal property taxes levied on the Contractor or for any taxes levied on employees' wages. Any exceptions to this paragraph shall be explicitly noted by the Customer in the special contract conditions section of the solicitation or in the Contract or purchase order.

**17. Governmental Restrictions.** If the Contractor believes that any governmental restrictions have been imposed that require alteration of the material, quality, workmanship or performance of the products offered under the Contract, the Contractor shall immediately notify the Customer in writing, indicating the specific restriction. The Customer reserves the right and the complete discretion to accept any such alteration or to cancel the Contract at no further expense to the Customer.

**18. Lobbying and Integrity.** Customers shall ensure compliance with Section 11.062, FS and Section 216.347, FS. The Contractor shall not, in connection with this or any other agreement with the State, directly or indirectly (1) offer, confer, or agree to confer any pecuniary benefit on anyone as consideration for any State officer or employee's decision, opinion, recommendation, vote, other exercise of discretion, or violation of a known legal duty, or (2) offer, give, or agree to give to anyone any gratuity for the benefit of, or at the direction or request of, any State officer or employee. For purposes of clause (2), "gratuity" means any payment of more than nominal monetary value in the form of cash, travel, entertainment, gifts, meals, lodging, loans, subscriptions, advances, deposits of money, services, employment, or contracts of any kind. Upon request of the Customer's Inspector General, or other authorized State official, the Contractor shall provide any type of information the Inspector General deems relevant to the Contractor's integrity or responsibility. Such information may include, but shall not be limited to, the Contractor's business or financial records, documents, or files of any type or form that refer to or relate to the Contract. The Contractor shall retain such records for the longer of (1) three years after the expiration of the Contract or (2) the period required by the General Records Schedules maintained by the Florida Department of State (available at: <http://dls.dos.state.fl.us/barm/genschedules/gensched.htm>). The Contractor agrees to reimburse the State for the reasonable costs of investigation incurred by the Inspector General or other authorized State official for investigations of the Contractor's compliance with the terms of this or any other agreement between the Contractor and the State which results in the suspension or debarment of the Contractor. Such costs shall include, but shall not be limited to: salaries of investigators, including overtime; travel and lodging expenses; and expert witness and documentary fees. The Contractor shall not be responsible for any costs of investigations that do not result in the Contractor's suspension or debarment.

**19. Indemnification.** The Contractor shall be fully liable for the actions of its agents, employees, partners, or subcontractors and shall fully indemnify, defend, and hold harmless the State and Customers, and their officers, agents, and employees, from suits, actions, damages, and costs of every name and description, including attorneys' fees, arising from or relating to personal injury and damage to real or personal tangible property alleged to be caused in whole or in part by Contractor, its agents, employees, partners, or subcontractors, provided, however, that the Contractor shall not indemnify for that portion of any loss or damages proximately caused by the negligent act or omission of the State or a Customer.

Further, the Contractor shall fully indemnify, defend, and hold harmless the State and Customers from any suits, actions, damages, and costs of every name and description, including attorneys' fees, arising from or relating to violation or infringement of a trademark, copyright, patent, trade secret or intellectual property right, provided, however, that the foregoing obligation shall not apply to a Customer's misuse or modification of Contractor's products or a Customer's operation or use of Contractor's products in a manner not contemplated by the Contract or the purchase order. If any product is the subject of an infringement suit, or in the Contractor's opinion is likely to become the subject of such a suit, the Contractor may at its sole expense procure for the Customer the right to continue using the product or to modify it to become non-infringing. If the Contractor is not reasonably able to modify or otherwise secure the Customer the right to continue using the product, the Contractor shall remove the product and refund the Customer the amounts paid in excess of a reasonable rental for past use. The customer shall not be liable for any royalties.

The Contractor's obligations under the preceding two paragraphs with respect to any legal action are contingent upon the State or Customer giving the Contractor (1) written notice of any action or threatened action, (2) the opportunity to take over and settle or defend any such action at Contractor's sole expense, and (3) assistance in defending the action at Contractor's sole expense. The Contractor shall not be liable for any cost, expense, or compromise incurred or made by the State or Customer in any legal action without the Contractor's prior written consent, which shall not be unreasonably withheld.

**20. Limitation of Liability.** For all claims against the Contractor under any contract or purchase order, and regardless of the basis on which the claim is made, the Contractor's liability under a contract or purchase order for direct damages shall be limited to the greater of \$100,000, the dollar amount of the contract or purchase order, or two times the charges rendered by the Contractor under the purchase order. This limitation shall not apply to claims arising under the Indemnity paragraph contain in this agreement.

Unless otherwise specifically enumerated in the Contract or in the purchase order, no party shall be liable to another for special, indirect, punitive, or consequential damages, including lost data or records (unless the contract or purchase order requires the Contractor to back-up data or records), even if the party has been advised that such damages are possible. No party shall be liable for lost profits, lost revenue, or lost institutional operating savings. The State and Customer may, in addition to other remedies available to them at law or equity and upon notice to the Contractor, retain such monies from amounts due Contractor as may be necessary to satisfy any claim for damages, penalties, costs and the like asserted by or against them. The State may set off any liability or other obligation of the Contractor or its affiliates to the State against any payments due the Contractor under any contract with the State.

**21. Suspension of Work.** The Customer may in its sole discretion suspend any or all activities under the Contract or purchase order, at any time, when in the best interests of the State to do so. The Customer shall provide the Contractor written notice outlining the particulars of suspension. Examples of the reason for suspension include, but are not limited to, budgetary constraints, declaration of emergency, or other such circumstances. After receiving a suspension notice, the Contractor shall comply with the notice and shall not accept any purchase orders. Within ninety days, or any longer period agreed to by the Contractor, the Customer shall either (1) issue a notice authorizing resumption of work, at which time activity shall resume, or (2) terminate the Contract or purchase order. Suspension of work shall not entitle the Contractor to any additional compensation.

**22. Termination for Convenience.** The Customer, by written notice to the Contractor, may terminate the Contract in whole or in part when the Customer determines in its sole discretion that it is in the State's interest to do so. The Contractor shall not furnish any product after it receives the notice of termination, except as necessary to complete the continued portion of the Contract, if any. The Contractor shall not be entitled to recover any cancellation charges or lost profits.

**23. Termination for Cause.** The Customer may terminate the Contract if the Contractor fails to (1) deliver the product within the time specified in the Contract or any extension, (2) maintain adequate progress, thus endangering performance of the Contract, (3) honor any term of the Contract, or (4) abide by any statutory, regulatory, or licensing requirement. Rule 60A-1.006(3), F.A.C., governs the procedure and consequences of default. The Contractor shall continue work on any work not terminated. Except for defaults of subcontractors at any tier, the Contractor shall not be liable for any excess costs if the failure to perform the Contract arises from events completely beyond the control, and without the fault or negligence, of the Contractor. If the failure to perform is caused by the default of a subcontractor at any tier, and if the cause of the default is completely beyond the control of both the Contractor and the subcontractor, and without the fault or negligence of either, the Contractor shall not be liable for any excess costs for failure to perform, unless the subcontracted products were obtainable from other sources in sufficient time for the Contractor to meet the required delivery schedule. If, after termination, it is determined that the Contractor was not in default, or that the default was excusable, the rights and obligations of the parties shall be the same as if the termination had been issued for the convenience of the Customer. The rights and remedies of the Customer in this clause are in addition to any other rights and remedies provided by law or under the Contract.

**24. Force Majeure, Notice of Delay, and No Damages for Delay.** The Contractor shall not be responsible for delay resulting from its failure to perform if neither the fault nor the negligence of the Contractor or its employees or agents contributed to the delay and the delay is due directly to acts of God, wars, acts of public enemies, strikes, fires, floods, or other similar cause wholly beyond the Contractor's control, or for any of the foregoing that affect subcontractors or suppliers if no alternate source of supply is available to the Contractor. In case of any delay the Contractor believes is excusable, the Contractor shall notify the Customer in writing of the delay or potential delay and describe the cause of the delay either (1) within ten (10) days after the cause that creates or will create the delay first arose, if the Contractor could reasonably foresee that a delay could occur as a result, or (2) if delay is not reasonably foreseeable, within five (5) days after the date the Contractor first had reason to believe that a delay could result. **THE FOREGOING SHALL CONSTITUTE THE CONTRACTOR'S SOLE REMEDY OR EXCUSE WITH RESPECT TO DELAY.** Providing notice in strict accordance with this paragraph is a condition precedent to such remedy. No claim for damages, other than for an extension of time, shall be asserted against the Customer. The Contractor shall not be entitled to an increase in the Contract price or payment of any kind from the Customer for direct, indirect, consequential, impact or other costs, expenses or damages, including but not limited to costs of acceleration or inefficiency, arising because of delay, disruption, interference, or hindrance from any cause whatsoever. If performance is suspended or delayed, in whole or in part, due to any of the causes described in this paragraph, after the causes have ceased to exist the Contractor shall perform at no increased cost, unless the Customer determines, in its sole discretion, that the delay will significantly impair the value of the Contract to the State or to Customers, in which case the Customer may (1) accept allocated performance or deliveries from the Contractor, provided that the Contractor grants preferential treatment to Customers with respect to products subjected to allocation, or (2) purchase from other sources (without recourse to and by the Contractor for the related costs and expenses) to replace all or part of the products that are the subject of the delay, which purchases may be deducted from the Contract quantity, or (3) terminate the Contract in whole or in part.

**25. Changes.** The Customer may unilaterally require, by written order, changes altering, adding to, or deducting from the Contract specifications, provided that such changes are within the general scope of the Contract. The Customer may make an equitable adjustment in the Contract price or delivery date if the change affects the cost or time of performance. Such equitable adjustments require the written consent of the Contractor, which shall not be unreasonably withheld. If unusual quantity requirements arise, the Customer may solicit separate bids to satisfy them.

**26. Renewal.** Upon mutual agreement, the Customer and the Contractor may renew the Contract, in whole or in part, for a period that may not exceed 3 years or the term of the contract, whichever period is longer. Any renewal shall specify the renewal price, as set forth in the solicitation response. The renewal must be in writing and signed by both parties, and is contingent upon satisfactory performance evaluations and subject to availability of funds.

**27. Purchase Order Duration.** Purchase orders issued pursuant to a state term or agency contract must be received by the Contractor no later than close of business on the last day of the contract's term to be considered timely. The Contractor is obliged to fill those orders in accordance with the contract's terms and conditions. Purchase orders received by the contractor after close of business on the last day of the state term or agency contract's term shall be considered void.

Purchase orders for a one-time delivery of commodities or performance of contractual services shall be valid through the performance by the Contractor, and all terms and conditions of the state term or agency contract shall apply to the single delivery/performance, and shall survive the termination of the Contract.

Contractors are required to accept purchase orders specifying delivery schedules exceeding the contracted schedule even when such extended delivery will occur after expiration of the state term or agency contract. For example, if a state term contract calls for delivery 30 days after receipt of order (ARO), and an order specifies delivery will occur both in excess of 30 days ARO and after expiration of the state term contract, the Contractor will accept the order. However, if the Contractor expressly and in writing notifies the ordering office within ten (10) calendar days of receipt of the purchase order that Contractor will not accept the extended delivery terms beyond the expiration of the state term contract, then the purchase order will either be amended in writing by the ordering entity within ten (10) calendar days of receipt of the contractor's notice to reflect the state term contract delivery schedule, or it shall be considered withdrawn.

The duration of purchase orders for recurring deliveries of commodities or performance of services shall not exceed the expiration of the state term or agency contract by more than twelve months. However, if an extended pricing plan offered in the state term or agency contract is selected by the ordering entity, the contract terms on pricing plans and renewals shall govern the maximum duration of purchase orders reflecting such pricing plans and renewals.

Timely purchase orders shall be valid through their specified term and performance by the Contractor, and all terms and conditions of the state term or agency contract shall apply to the recurring delivery/performance as provided herein, and shall survive the termination of the Contract.

Ordering offices shall not renew a purchase order issued pursuant to a state term or agency contract if the underlying contract expires prior to the effective date of the renewal.

**28. Advertising.** Subject to Chapter 119, Florida Statutes, the Contractor shall not publicly disseminate any information concerning the Contract without prior written approval from the Customer, including, but not limited to mentioning the Contract in a press release or other promotional material, identifying the Customer or the State as a reference, or otherwise linking the Contractor's name and either a description of the Contract or the name of the State or the Customer in any material published, either in print or electronically, to any entity that is not a party to Contract, except potential or actual authorized distributors, dealers, resellers, or service representative.

**29. Assignment.** The Contractor shall not sell, assign or transfer any of its rights, duties or obligations under the Contract, or under any purchase order issued pursuant to the Contract, without the prior written consent of the Customer. In the event of any assignment, the Contractor remains secondarily liable for performance of the contract, unless the Customer expressly waives such secondary liability. The Customer may assign the Contract with prior written notice to Contractor of its intent to do so.

**30. Antitrust Assignment.** The Contractor and the State of Florida recognize that in actual economic practice, overcharges resulting from antitrust violations are in fact usually borne by the State of Florida. Therefore, the contractor hereby assigns to the State of Florida any and all claims for such overcharges as to goods, materials or services purchased in connection with the Contract.

**31. Dispute Resolution.** Any dispute concerning performance of the Contract shall be decided by the Customer's designated contract manager, who shall reduce the decision to writing and serve a copy on the Contractor. The decision shall be final and conclusive unless within twenty one (21) days from the date of receipt, the Contractor files with the Customer a petition for administrative hearing. The Customer's decision on the petition shall be final, subject to the Contractor's right to review pursuant to Chapter 120 of the Florida Statutes. Exhaustion of administrative remedies is an absolute condition precedent to the Contractor's ability to pursue any other form of dispute resolution; provided, however, that the parties may employ the alternative dispute resolution procedures outlined in Chapter 120.

Without limiting the foregoing, the exclusive venue of any legal or equitable action that arises out of or relates to the Contract shall be the appropriate state court in Leon County, Florida; in any such action, Florida law shall apply and the parties waive any right to jury trial.

**32. Employees, Subcontractors, and Agents.** All Contractor employees, subcontractors, or agents performing work under the Contract shall be properly trained technicians who meet or exceed any specified training qualifications. Upon request, Contractor shall furnish a copy of technical certification or other proof of qualification. All employees, subcontractors, or agents performing work under the Contract must comply with all security and administrative requirements of the Customer and shall comply with all controlling laws and regulations relevant to the services they are providing under the Contract. The State may conduct, and the Contractor shall cooperate in, a security background check or otherwise assess any employee, subcontractor, or agent furnished by the Contractor. The State may refuse access to, or require replacement of, any personnel for cause, including, but not limited to, technical or training qualifications, quality of work, change in security status, or non-compliance with a Customer's security or other requirements. Such approval shall not relieve the Contractor of its obligation to perform all work in compliance with the Contract. The State may reject and bar from any facility for cause any of the Contractor's employees, subcontractors, or agents.

**33. Security and Confidentiality.** The Contractor shall comply fully with all security procedures of the United States, State of Florida and Customer in performance of the Contract. The Contractor shall not divulge to third parties any confidential information obtained by the Contractor or its agents, distributors, resellers, subcontractors, officers or employees in the course of performing Contract work, including, but not limited to, security procedures, business operations information, or commercial proprietary information in the possession of the State or Customer. The Contractor shall not be required to keep confidential information or material that is publicly available through no fault of the Contractor, material that the Contractor developed independently without relying on the State's or Customer's confidential information, or material that is otherwise obtainable under State law as a public record. To insure confidentiality, the Contractor shall take appropriate steps as to its personnel, agents, and subcontractors. The warranties of this paragraph shall survive the Contract.

**34. Contractor Employees, Subcontractors, and Other Agents.** The Customer and the State shall take all actions necessary to ensure that Contractor's employees, subcontractors and other agents are not employees of the State of Florida. Such actions include, but are not limited to, ensuring that Contractor's employees, subcontractors, and other agents receive benefits and necessary insurance (health, workers' compensations, and unemployment) from an employer other than the State of Florida.

**35. Insurance Requirements.** During the Contract term, the Contractor at its sole expense shall provide commercial insurance of such a type and with such terms and limits as may be reasonably associated with the Contract. Providing and maintaining adequate insurance coverage is a material obligation of the Contractor. Upon request, the Contractor shall provide certificate of insurance. The limits of coverage under each policy maintained by the Contractor shall not be interpreted as limiting the Contractor's liability and obligations under the Contract. All insurance policies shall be through insurers authorized or eligible to write policies in Florida.

**36. Warranty of Authority.** Each person signing the Contract warrants that he or she is duly authorized to do so and to bind the respective party to the Contract.

**37. Warranty of Ability to Perform.** The Contractor warrants that, to the best of its knowledge, there is no pending or threatened action, proceeding, or investigation, or any other legal or financial condition, that would in any way prohibit, restrain, or diminish the Contractor's ability to satisfy its Contract obligations. The Contractor warrants that neither it nor any affiliate is currently on the convicted vendor list maintained pursuant to section 287.133 of the Florida Statutes, or on any similar list maintained by any other state or the federal government. The Contractor shall immediately notify the Customer in writing if its ability to perform is compromised in any manner during the term of the Contract.

**38. Notices.** All notices required under the Contract shall be delivered by certified mail, return receipt requested, by reputable air courier service, or by personal delivery to the agency designee identified in the original solicitation, or as otherwise identified by the Customer. Notices to the Contractor shall be delivered to the person who signs the Contract. Either designated recipient may notify the other, in writing, if someone else is designated to receive notice.

**39. Leases and Installment Purchases.** Prior approval of the Chief Financial Officer (as defined in Section 17.001, F.S.) is required for State agencies to enter into or to extend any lease or installment-purchase agreement in excess of the Category Two amount established by section 287.017 of the Florida Statutes.

**40. Prison Rehabilitative Industries and Diversified Enterprises, Inc. (PRIDE).** Section 946.515(2), F.S. requires the following statement to be included in the solicitation: "It is expressly understood and agreed that any articles which are the subject of, or required to carry out, the Contract shall be purchased from the corporation identified under Chapter 946 of the Florida Statutes (PRIDE) in the same manner and under the same procedures set forth in section 946.515(2) and (4) of the Florida Statutes; and for purposes of the Contract the person, firm, or other business entity carrying out the provisions of the Contract shall be deemed to be substituted for the agency insofar as dealings with such corporation are concerned." Additional information about PRIDE and the products it offers is available at <http://www.pridefl.com>.

**41. Products Available from the Blind or Other Handicapped.** Section 413.036(3), F.S. requires the following statement to be included in the solicitation: "It is expressly understood and agreed that any articles that are the subject of, or required to carry out, this contract shall be purchased from a nonprofit agency for the Blind or for the Severely Handicapped that is qualified pursuant to Chapter 413, Florida Statutes, in the same manner and under the same procedures set forth in section 413.036(1) and (2), Florida Statutes; and for purposes of this contract the person, firm, or other business entity carrying out the provisions of this contract shall be deemed to be substituted for the State agency insofar as dealings with such qualified nonprofit agency are concerned." Additional information about the designated nonprofit agency and the products it offers is available at <http://www.respectofflorida.org>.

**42. Modification of Terms.** The Contract contains all the terms and conditions agreed upon by the parties, which terms and conditions shall govern all transactions between the Customer and the Contractor. The Contract may only be modified or amended upon mutual written agreement of the Customer and the Contractor. No oral agreements or representations shall be valid or binding upon the Customer or the Contractor. No alteration or modification of the Contract terms, including substitution of product, shall be valid or binding against the Customer. The Contractor may not unilaterally modify the terms of the Contract by affixing additional terms to product upon delivery (e.g., attachment or inclusion of standard preprinted forms, product literature, "shrink wrap" terms accompanying or affixed to a product, whether written or electronic) or by incorporating such terms onto the Contractor's order or fiscal forms or other documents forwarded by the Contractor for payment. The Customer's acceptance of product or processing of documentation on forms furnished by the Contractor for approval or payment shall not constitute acceptance of the proposed modification to terms and conditions.

**43. Cooperative Purchasing.** Pursuant to their own governing laws, and subject to the agreement of the Contractor, other entities may be permitted to make purchases at the terms and conditions contained herein. Non-Customer purchases are independent of the agreement between Customer and Contractor, and Customer shall not be a party to any transaction between the Contractor and any other purchaser. State agencies wishing to make purchases from this agreement are required to follow the provisions of s. 287.042(16)(a), F.S. This statute requires the Department of Management Services to determine that the requestor's use of the contract is cost-effective and in the best interest of the State.

**44. Waiver.** The delay or failure by the Customer to exercise or enforce any of its rights under this Contract shall not constitute or be deemed a waiver of the Customer's right thereafter to enforce those rights, nor shall any single or partial exercise of any such right preclude any other or further exercise thereof or the exercise of any other right.

**45. Annual Appropriations.** The State's performance and obligation to pay under this contract are contingent upon an annual appropriation by the Legislature.

**46. Execution in Counterparts.** The Contract may be executed in counterparts, each of which shall be an original and all of which shall constitute but one and the same instrument.

**47. Severability.** If a court deems any provision of the Contract void or unenforceable, that provision shall be enforced only to the extent that it is not in violation of law or is not otherwise unenforceable and all other provisions shall remain in full force and effect.

**1. Definitions.** The definitions found in s. 60A-1.001, F.A.C. shall apply to this agreement. The following additional terms are also defined:

- (a) "Buyer" means the entity that has released the solicitation. The "Buyer" may also be the "Customer" as defined in the PUR 1000 if that entity meets the definition of both terms.
- (b) "Procurement Officer" means the Buyer's contracting personnel, as identified in the Introductory Materials.
- (c) "Respondent" means the entity that submits materials to the Buyer in accordance with these Instructions.
- (d) "Response" means the material submitted by the respondent in answering the solicitation.
- (e) "Timeline" means the list of critical dates and actions included in the Introductory Materials.

**2. General Instructions.** Potential respondents to the solicitation are encouraged to carefully review all the materials contained herein and prepare responses accordingly.

**3. Electronic Submission of Responses.** Respondents are required to submit responses electronically. For this purpose, all references herein to signatures, signing requirements, or other required acknowledgments hereby include electronic signature by means of clicking the "Submit Response" button (or other similar symbol or process) attached to or logically associated with the response created by the respondent within MyFloridaMarketPlace. The respondent agrees that the action of electronically submitting its response constitutes:

- an electronic signature on the response, generally,
- an electronic signature on any form or section specifically calling for a signature, and
- an affirmative agreement to any statement contained in the solicitation that requires a definite confirmation or acknowledgement.

**4. Terms and Conditions.** All responses are subject to the terms of the following sections of this solicitation, which, in case of conflict, shall have the order of precedence listed:

- Technical Specifications,
- Special Conditions and Instructions,
- Instructions to Respondents (PUR 1001),
- General Conditions (PUR 1000), and
- Introductory Materials.

The Buyer objects to and shall not consider any additional terms or conditions submitted by a respondent, including any appearing in documents attached as part of a respondent's response. In submitting its response, a respondent agrees that any additional terms or conditions, whether submitted intentionally or inadvertently, shall have no force or effect. Failure to comply with terms and conditions, including those specifying information that must be submitted with a response, shall be grounds for rejecting a response.

**5. Questions.** Respondents shall address all questions regarding this solicitation to the Procurement Officer. Questions must be submitted via the Q&A Board within MyFloridaMarketPlace and must be RECEIVED NO LATER THAN the time and date reflected on the Timeline. Questions shall be answered in accordance with the Timeline. All questions submitted shall be published and answered in a manner that all respondents will be able to view. Respondents shall not contact any other employee of the Buyer or the State for information with respect to this solicitation. Each respondent is responsible for monitoring the MyFloridaMarketPlace site for new or changing information. The Buyer shall not be bound by any verbal information or by any written information that is not contained within the solicitation documents or formally noticed and issued by the Buyer's contracting personnel. Questions to the Procurement Officer or to any Buyer personnel shall not constitute formal protest of the specifications or of the solicitation, a process addressed in paragraph 19 of these Instructions.

**6. Conflict of Interest.** This solicitation is subject to chapter 112 of the Florida Statutes. Respondents shall disclose with their response the name of any officer, director, employee or other agent who is also an employee of the State. Respondents shall also disclose the name of any State employee who owns, directly or indirectly, an interest of five percent (5%) or more in the respondent or its affiliates.

**7. Convicted Vendors.** A person or affiliate placed on the convicted vendor list following a conviction for a public entity crime is prohibited from doing any of the following for a period of 36 months from the date of being placed on the convicted vendor list:

- submitting a bid on a contract to provide any goods or services to a public entity;
- submitting a bid on a contract with a public entity for the construction or repair of a public building or public work;
- submitting bids on leases of real property to a public entity;
- being awarded or performing work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity; and
- transacting business with any public entity in excess of the Category Two threshold amount (\$25,000) provided in section 287.017 of the Florida Statutes.

**8. Discriminatory Vendors.** An entity or affiliate placed on the discriminatory vendor list pursuant to section 287.134 of the Florida Statutes may not:

- submit a bid on a contract to provide any goods or services to a public entity;
- submit a bid on a contract with a public entity for the construction or repair of a public building or public work;
- submit bids on leases of real property to a public entity;
- be awarded or perform work as a contractor, supplier, sub-contractor, or consultant under a contract with any public entity; or
- transact business with any public entity.

**9. Respondent's Representation and Authorization.** In submitting a response, each respondent understands, represents, and acknowledges the following (if the respondent cannot so certify to any of following, the respondent shall submit with its response a written explanation of why it cannot do so).

- The respondent is not currently under suspension or debarment by the State or any other governmental authority.
- To the best of the knowledge of the person signing the response, the respondent, its affiliates, subsidiaries, directors, officers, and employees are not currently under investigation by any governmental authority and have not in the last ten (10) years been convicted or found liable for any act prohibited by law in any jurisdiction, involving conspiracy or collusion with respect to bidding on any public contract.
- Respondent currently has no delinquent obligations to the State, including a claim by the State for liquidated damages under any other contract.
- The submission is made in good faith and not pursuant to any agreement or discussion with, or inducement from, any firm or person to submit a complementary or other noncompetitive response.
- The prices and amounts have been arrived at independently and without consultation, communication, or agreement with any other respondent or potential respondent; neither the prices nor amounts, actual or approximate, have been disclosed to any respondent or potential respondent, and they will not be disclosed before the solicitation opening.
- The respondent has fully informed the Buyer in writing of all convictions of the firm, its affiliates (as defined in section 287.133(1)(a) of the Florida Statutes), and all directors, officers, and employees of the firm and its affiliates for violation of state or federal antitrust laws with respect to a public contract for violation of any state or federal law involving fraud, bribery, collusion, conspiracy or material misrepresentation with respect to a public contract. This includes disclosure of the names of current employees who were convicted of contract crimes while in the employ of another company.
- Neither the respondent nor any person associated with it in the capacity of owner, partner, director, officer, principal, investigator, project director, manager, auditor, or position involving the administration of federal funds:
  - Has within the preceding three years been convicted of or had a civil judgment rendered against them or is presently indicted for or otherwise criminally or civilly charged for: commission of fraud or a criminal offense in connection with obtaining, attempting to obtain, or performing a federal, state, or local government transaction or public contract; violation of federal or state antitrust statutes; or commission of embezzlement, theft, forgery, bribery, falsification or destruction of records, making false statements, or receiving stolen property; or
  - Has within a three-year period preceding this certification had one or more federal, state, or local government contracts terminated for cause or default.
- The product offered by the respondent will conform to the specifications without exception.
- The respondent has read and understands the Contract terms and conditions, and the submission is made in conformance with those terms and conditions.
- If an award is made to the respondent, the respondent agrees that it intends to be legally bound to the Contract that is formed with the State.
- The respondent has made a diligent inquiry of its employees and agents responsible for preparing, approving, or submitting the response, and has been advised by each of them that he or she has not participated in any communication, consultation, discussion, agreement, collusion, act or other conduct inconsistent with any of the statements and representations made in the response.
- The respondent shall indemnify, defend, and hold harmless the Buyer and its employees against any cost, damage, or expense which may be incurred or be caused by any error in the respondent's preparation of its bid.
- All information provided by, and representations made by, the respondent are material and important and will be relied upon by the Buyer in awarding the Contract. Any misstatement shall be treated as fraudulent concealment from the Buyer of the true facts relating to submission of the bid. A misrepresentation shall be punishable under law, including, but not limited to, Chapter 817 of the Florida Statutes.

**10. Manufacturer's Name and Approved Equivalents.** Unless otherwise specified, any manufacturers' names, trade names, brand names, information or catalog numbers listed in a specification are descriptive, not restrictive. With the Buyer's prior approval, the Contractor may provide any product that meets or exceeds the applicable specifications. The Contractor shall demonstrate comparability, including appropriate catalog materials, literature, specifications, test data, etc. The Buyer shall determine in its sole discretion whether a product is acceptable as an equivalent.



**11. Performance Qualifications.** The Buyer reserves the right to investigate or inspect at any time whether the product, qualifications, or facilities offered by Respondent meet the Contract requirements. Respondent shall at all times during the Contract term remain responsive and responsible. In determining Respondent's responsibility as a vendor, the agency shall consider all information or evidence which is gathered or comes to the attention of the agency which demonstrates the Respondent's capability to fully satisfy the requirements of the solicitation and the contract.

Respondent must be prepared, if requested by the Buyer, to present evidence of experience, ability, and financial standing, as well as a statement as to plant, machinery, and capacity of the respondent for the production, distribution, and servicing of the product bid. If the Buyer determines that the conditions of the solicitation documents are not complied with, or that the product proposed to be furnished does not meet the specified requirements, or that the qualifications, financial standing, or facilities are not satisfactory, or that performance is untimely, the Buyer may reject the response or terminate the Contract. Respondent may be disqualified from receiving awards if respondent, or anyone in respondent's employment, has previously failed to perform satisfactorily in connection with public bidding or contracts. This paragraph shall not mean or imply that it is obligatory upon the Buyer to make an investigation either before or after award of the Contract, but should the Buyer elect to do so, respondent is not relieved from fulfilling all Contract requirements.

**12. Public Opening.** Responses shall be opened on the date and at the location indicated on the Timeline. Respondents may, but are not required to, attend. The Buyer may choose not to announce prices or release other materials pursuant to s. 119.071(1)(b), Florida Statutes. Any person requiring a special accommodation because of a disability should contact the Procurement Officer at least five (5) workdays prior to the solicitation opening. If you are hearing or speech impaired, please contact the Buyer by using the Florida Relay Service at (800) 955-8771 (TDD).

**13. Electronic Posting of Notice of Intended Award.** Based on the evaluation, on the date indicated on the Timeline the Buyer shall electronically post a notice of intended award at [http://vbs.dms.state.fl.us/vbs/search.criteria\\_form](http://vbs.dms.state.fl.us/vbs/search.criteria_form). If the notice of award is delayed, in lieu of posting the notice of intended award the Buyer shall post a notice of the delay and a revised date for posting the notice of intended award. Any person who is adversely affected by the decision shall file with the Buyer a notice of protest within 72 hours after the electronic posting. The Buyer shall not provide tabulations or notices of award by telephone.

**14. Firm Response.** The Buyer may make an award within sixty (60) days after the date of the opening, during which period responses shall remain firm and shall not be withdrawn. If award is not made within sixty (60) days, the response shall remain firm until either the Buyer awards the Contract or the Buyer receives from the respondent written notice that the response is withdrawn. Any response that expresses a shorter duration may, in the Buyer's sole discretion, be accepted or rejected.

**15. Clarifications/Revisions.** Before award, the Buyer reserves the right to seek clarifications or request any information deemed necessary for proper evaluation of submissions from all respondents deemed eligible for Contract award. Failure to provide requested information may result in rejection of the response.

**16. Minor Irregularities/Right to Reject.** The Buyer reserves the right to accept or reject any and all bids, or separable portions thereof, and to waive any minor irregularity, technicality, or omission if the Buyer determines that doing so will serve the State's best interests. The Buyer may reject any response not submitted in the manner specified by the solicitation documents.

**17. Contract Formation.** The Buyer shall issue a notice of award, if any, to successful respondent(s), however, no contract shall be formed between respondent and the Buyer until the Buyer signs the Contract. The Buyer shall not be liable for any costs incurred by a respondent in preparing or producing its response or for any work performed before the Contract is effective.

**18. Contract Overlap.** Respondents shall identify any products covered by this solicitation that they are currently authorized to furnish under any state term contract. By entering into the Contract, a Contractor authorizes the Buyer to eliminate duplication between agreements in the manner the Buyer deems to be in its best interest.

**19. Public Records.** Article 1, section 24, Florida Constitution, guarantees every person access to all public records, and Section 119.011, Florida Statutes, provides a broad definition of public record. As such, all responses to a competitive solicitation are public records unless exempt by law. Any respondent claiming that its response contains information that is exempt from the public records law shall clearly segregate and mark that information and provide the specific statutory citation for such exemption.

**20. Protests.** Any protest concerning this solicitation shall be made in accordance with sections 120.57(3) and 287.042(2) of the Florida Statutes and chapter 28-110 of the Florida Administrative Code. Questions to the Procurement Officer shall not constitute formal notice of a protest. It is the Buyer's intent to ensure that specifications are written to obtain the best value for the State and that specifications are written to ensure competitiveness, fairness, necessity and reasonableness in the solicitation process.

Section 120.57(3)(b), F.S. and Section 28-110.003, Fla. Admin. Code require that a notice of protest of the solicitation documents shall be made within seventy-two hours after the posting of the solicitation.

Section 120.57(3)(a), F.S. requires the following statement to be included in the solicitation: "Failure to file a protest within the time prescribed in section 120.57(3), Florida Statutes, shall constitute a waiver of proceedings under Chapter 120, Florida Statutes."

Section 28-110.005, Fla. Admin. Code requires the following statement to be included in the solicitation: "Failure to file a protest within the time prescribed in Section 120.57(3), Florida Statutes, or failure to post the bond or other security required by law within the time allowed for filing a bond shall constitute a waiver of proceedings under Chapter 120, Florida Statutes."

**21. Limitation on Vendor Contact with Agency During Solicitation Period.** Respondents to this solicitation or persons acting on their behalf may not contact, between the release of the solicitation and the end of the 72-hour period following the agency posting the notice of intended award, excluding Saturdays, Sundays, and state holidays, any employee or officer of the executive or legislative branch concerning any aspect of this solicitation, except in writing to the procurement officer or as provided in the solicitation documents. Violation of this provision may be grounds for rejecting a response.

**IDENTICAL TIE BIDS FORM**

**IDENTICAL TIE BIDS** - Preference shall be given to businesses with drug-free workplace programs. Whenever two or more bids which are equal with respect to price, quality, and service are received by the State or by any political subdivision for the procurement of commodities or contractual services, a bid received from a business that certifies that it has implemented a drug-free workplace program shall be given preference in the award process. Established procedures for processing tie bids will be followed if none of the tied vendors have a drug-free workplace program. In order to have a drug-free workplace program, a business shall:

- 1) Publish a statement notifying employees that the unlawful manufacture, distribution, dispensing, possession, or use of a controlled substance is prohibited in the workplace and specifying the actions that will be taken against employees for violations of such prohibition.
- 2) Inform employees about the dangers of drug abuse in the workplace, the business's policy of maintaining a drug-free workplace, any available drug counseling, rehabilitation, and employee assistance programs, and the penalties that may be imposed upon employees for drug abuse violations.
- 3) Give each employee engaged in providing the commodities or contractual services that are under bid a copy of the statement specified in subsection (1).
- 4) In the statement specified in subsection (1), notify the employees that, as a condition of working on the commodities or contractual services that are under bid, the employee will abide by the terms of the statement and will notify the employer of any conviction of, or plea of guilty or nolo contendere to, any violation of chapter 893 or of any controlled substance law of the United States or any state, for a violation occurring in the workplace no later than five (5) days after such conviction.
- 5) Impose a sanction on, or require the satisfactory participation in a drug abuse assistance or rehabilitation program if such is available in the employee's community, by any employee who is so convicted.
- 6) Make a good faith effort to continue to maintain a drug-free workplace through implementation of this section.

2. \_\_\_\_\_ **Note the Procurement Officer's name, address, phone numbers and e-mail address.** This is the only person you are allowed to communicate with regarding the Solicitation and is an excellent source of information for any questions you may have.
3. \_\_\_\_\_ **Attend the pre-proposal conference.** (If applicable)
4. \_\_\_\_\_ **Take advantage of the “question and answer” period.** Submit your questions to the Procurement Officer by the due date listed in the Calendar of Events and view the answers given in the formal “addenda” issued for the Solicitation. All addenda issued for a Solicitation are posted on the Vendor Bid System’s website ([http://vbs.dms.state.fl.us/vbs/search.criteria\\_form](http://vbs.dms.state.fl.us/vbs/search.criteria_form)) and will include all questions asked and answered concerning the Solicitation.
5. \_\_\_\_\_ **Follow the format required in the Solicitation** when preparing your response. Provide point-by-point responses to the required sections in a clear and concise manner.
6. \_\_\_\_\_ **Provide complete answers/descriptions.** Read and answer **all** questions and requirements. Don’t assume the Department or evaluation committee will know what your company capabilities are or what items/services you can provide, even if you have previously contracted with the Department. The proposals are evaluated based solely on the information and materials provided in your response.
7. \_\_\_\_\_ **Use the forms provided: for example;** Bid List Registration page, Site Survey forms, Certification forms, Price Proposal forms, Certificate of Drug Free Workplace, Savings / Discount / Price Reduction, Customer References, etc.
8. \_\_\_\_\_ **Check the Vendor Bid System website for Solicitation addenda.** Before submitting your response, check the Vendor Bid System website to see whether any addenda were issued for the Solicitation, some addenda require that you sign and return them with the bid.
9. \_\_\_\_\_ **Review and read the Solicitation document again** to make sure that you have addressed all requirements. Your original response and the requested copies must be identical and be complete. The copies are provided to the evaluator/evaluation committee members and will be used to score your response.
10. \_\_\_\_\_ **Submit your response on time.** Note all the dates and times listed in the Calendar of Events and within the document, and be sure to submit all required items on time. Faxed, emailed or late proposal responses are never accepted.
