The following shall address questions, responses, additions, clarifications, and/or changes relative to **FDVA-ITB-20-016B**. The below questions, responses, additions, clarifications, changes, and/or attachment(s) shall amend **FDVA-ITB-20-016B**.

- 1) **Vendor Question:** Rodrigo, addendum NO.1 was issued 2-19-20 for the subject project, during the mandatory walk thru the facilities representatives stated that temporary cooling would be required and that an addendum would be issued to addressing the sizing of the equipment to be provided. I did not see that item on addendum NO. 1. Will there be an additional notification for this information?

FDVA Response: See "General Notes, No. 1 on sheet M.100". If demolition occurs in warmer weather i.e. outdoor temperatures of 85 degree Fahrenheit or above, contractor is responsible for providing temporary fluid cooler to maintain facility's indoor temperatures for residents, in accordance with AHCA requirements.

Failure to file a protest within the time prescribed in Section 120.57(3), Florida Statutes, or failure to post the bond or other security required by law within the time allowed for filing a bond shall constitute a waiver of proceedings under Chapter 120, Florida Statutes. Any protest concerning this FDVA decision must be timely received by FDVA Agency Clerk at: Florida Department of Veterans' Affairs, Office of the General Counsel – Agency Clerk, The Capitol, Suite 2105, 400 South Monroe Street, Tallahassee, Florida 32399-0001.

REMINDER: Make sure to fully execute and include Solicitation No. FDVA-ITB-20-016B Form "4" Addendum Acknowledgment with complete bid package submission. Failure to do so may result in respondent bid being considered nonresponsive.
