FAILURE TO FILE A PROTEST WITHIN THE TIME PRESCRIBED IN SECTION 120.57(3) FLORIDA STATUTES SHALL CONSTITUTE A WAIVER OF PROCEEDINGS UNDER CHAPTER 120, FLORIDA STATUTES. EITHER FAILURE TO FILE A NOTICE OF PROTEST OR FAILURE TO FILE A PETITION SHALL CONSTITUTE SUCH WAIVER.
