**REQUEST FOR INFORMATION (RFI) from the Florida Dept. of Transportation**

The Department of Transportation, Office of Traffic Operations is requesting the following information from prospective vendors about the commodities and/or contractual services described below.

**Description of commodities/contractual services:**

The Department is considering the solicitation of electronic key system that is compatible with the electronic key system in FDOT District 2 and 5. The Office of Traffic Operations is seeking information regarding a turn-key CyberLock System for use in its ITS infrastructure deployments along the State Highway System. The system will need to accommodate various common lock types installed in microwave shelters, security fence gates, and ITS equipment cabinets using the corbin style locks, schlage lock cylinders, kwikset, long shank and short shank padlocks.

It is the intent of this RFI to gather information from prospective bidders that will reflect the most commonly purchased lock types for use in building doors, traffic cabinets, pad locks, cabinet locks, and other styles that may have not been mentioned but are recommended by the prospective bidders. In conjunction with the locks that will be proposed, a complete electronic key system capable of providing complete lock and key audits through a designated network is required. Complete compatibility with the existing electronic lock audit system located in District 2 and 5 are required.
