### **SCOPE OF WORK**:

### Base Bid:

Contractor shall provide all labor, materials, equipment, supervision and permitting to remove and dispose of existing pier lighting, light poles, conduit and wiring. New lights have been purchased by the Park, (see lighting fixture schedule on sheet E1.0). Provide electrical system per the contract documents. This wiring will be fed from the existing concession building panel.

# Installation Floater Insurance & Longshoreman's Insurance are both required for this project and must be included in bid price.

**Note:** Bidder Prequalification is required for all bids. Each bidder shall provide a copy of its biennial pre-qualification letter from FDEP's Bureau of Design and Construction. If not pre-qualified, the bidder must submit a current State Contractor license certification or registration and current Corporate Charter registration with the bid.




Figure 1: Mandatory Pre-Bid Meeting Site
