Also, I was wondering you you could provide the data sheet similar to the one provided by the Oviedo location which contained the 6 month totals for the units, as well as information about end users/ staff, number of machines/ desktops, copiers under lease, \# machines owned by FDOT, etc for each of the location covered under this bid please? The machine list was provided in the original RFP advertisement (See Exhibit 4), estimated annual totals by location are listed below. Number of staff will not be provided due to security reasons.
