#### 8.5 E-VERIFY UTILIZATION

The Florida Department of Transportation shall require the following as a condition of all contracts:

Vendor/Contractor shall utilize the U.S. Department of Homeland Security's E-Verify system, in accordance with the terms governing use of the system, to confirm the employment eligibility of;

1. all persons employed by the Vendor/Contractor during the term of the Contract to perform employment duties within Florida; and

2. all persons, including subcontractors, assigned by the Vendor/Contractor to perform work pursuant to the contract with the Department.

#### 9) WARRANTY/SUBSTITUTIONS

When performance of the services requires the supply of commodities, a warranty is required on all items provided against defective materials, workmanship, and failure to perform in accordance with required industry performance criteria, for a period of not less than ninety (90) days from the date of acceptance by the purchaser. Any deviation from this criteria must be documented in the bid response or the above statement shall prevail. Delivery of substitute commodities requires prior written approval from the ordering location.

Replacement of all materials found defective within the warranty period shall be made without cost to the purchaser, including transportation if applicable. All fees associated with restocking cancelled orders shall be the responsibility of the Vendor.

All items provided during the performance of the contract found to be poorly manufactured will not be accepted, but returned to the vendor, at their expense, for replacement. Replacement of all items found defective shall be made without cost to the Department, including transportation, if applicable. As it may be impossible for each facility to inspect all items upon arrival, a reasonable opportunity must be given to these facilities for inspection of the items, and returning those that are defective.

#### 10) LIABILITY INSURANCE

The Vendor shall not commence any work until they have obtained the following types of insurance, and certificates of such insurance has been received by the Department. Nor shall the Vendor allow any subcontractor to commence work on this project until all similar insurance required of the subcontractor has been so obtained. The Vendor shall submit the required Certificates of Insurance to the Florida Department of Transportation, Procurement Office, Florida Department of Transportation, Turnpike Enterprise, P.O. Box 613069. Ocoee, Florida 34761-3069, attention Ivette Santiago within ten (10) days after the ending date of the period for posting the intended award decision.

(x) The Vendor must carry and keep in force during the period of this Contract a general liability insurance policy or policies with a company authorized to do business in the State of Florida, affording public liability insurance with combined bodily injury limits of at least \$\\_150,000.00\\_\\_\\_\ per person and \$\\_300,000.00\\_\\_\\_\ each occurrence, and property damage insurance of at least \$\\_150,000.00\\_\\_\ each occurrence, for the services to be rendered in accordance with this Contract.

## 12) METHOD OF COMPENSATION

#### 13) CONTRACT DOCUMENT

# 14) REVIEW OF BIDDER'S FACILITIES & QUALIFICATIONS

This review will serve to verify data and representations submitted by the bidder and may be used to determine whether the bidder has adequate facilities, equipment, qualified and experienced staff, and overall management capabilities to provide the required services. The review may also serve to verify whether the bidder has financial capabilities adequate to meet the contract requirements.

**Should** the Department determine that the bid package has material misrepresentations or that the size or nature of the bidder's facilities, equipment, management capabilities, or the number of experienced personnel (including technical staff) are not adequate to ensure satisfactory contract performance, the Department has the right to reject the bid.

#### 15) PROTEST OF INVITATION TO BID SPECIFICATIONS

Any person who is adversely affected by the contents of this Invitation to Bid must file the following with the Department of Transportation, Clerk of Agency Proceedings, Office of the General Counsel, 605 Suwannee Street, Mail Station 58, Tallahassee, Florida 32399-0450:

- 1. A written notice of protest within seventy-two (72) hours after the posting of the solicitation, and
- 2. A formal written protest in compliance with Section 120.57(3), Florida Statutes, within ten (10) days of the date on which the written notice of protest is filed.

Failure to file a protest within the time prescribed in section 120.57(3), Florida Statutes, or failure to post the bond or other security required by law within the time allowed for filing a bond shall constitute a waiver of proceedings under Chapter 120, Florida Statutes.

#### 16) UNAUTHORIZED ALIENS

The employment of unauthorized aliens by any contractor is considered a violation of Section 274A(e) of the Immigration and Nationality Act. If the Contractor knowingly employs unauthorized aliens, such violation shall be cause for unilateral cancellation of the Contract.

#### 17) RESERVATIONS

The Department reserves the right to accept or reject any or all bids received and reserves the right to make an award without further discussion of the bids submitted. Therefore, the bidder should make sure that the bid package submitted is complete and accurate and submitted to ensure delivery on or before the bid opening time and date specified in this solicitation. It is possible that you may encounter Asbestos-containing materials (ACM) while working in State-owned buildings since ACM are present in many of these buildings. The presence of ACM does not necessarily mean that a hazard exists. However, a hazard may be created when ACM is disturbed and asbestos fibers become airborne. The best way to maintain a safe environment is to avoid disturbance of ACM.

Prominently posted in each building is an "Occupant Notification" which summarizes known locations of ACM in that building. An Operations and Maintenance (O & M) plan has been developed for these known locations of ACM. Since the known locations may or may not include all ACM, workers must exercise caution and be watchful for materials that might contain asbestos. You must avoid inadvertently disturbing ACM or suspected ACM as you carry out your work.

At a minimum, you must use the procedures found in the O & M Plan; comply with all federal, state and local laws governing work with asbestos; assure that your employees are medically certified, trained and equipped with the proper personal protective devices for safe handling of ACM; and ensure that all employees performing work with ACM related to State-owned buildings execute a "Certificate of Worker's Acknowledgment" prior to beginning work. Immediately upon inadvertently or before disturbing ACM in any State-owned building you must notify the designated BACPer.

- D. The bills for any travel expenses, when authorized by terms of this Agreement and by the Department's Project Manager, shall be submitted in accordance with Section 112.061, Florida Statutes, and Chapter 3- Travel, Department's Disbursement Operations Manual, 350-030-400.
- E. Vendors providing goods and services to the Department should be aware of the following time frames. Upon receipt, the Department has five (5) working days to inspect and approve the goods and services, unless otherwise specified herein. The Department has twenty (20) days to deliver a request for payment (voucher) to the Department of Financial Services. The twenty (20) days are measured from the latter of the date the invoice is received or the goods or services are received, inspected and approved.
- F. If a payment is not available within forty (40) days, a separate interest penalty as established pursuant to Section 215.422, Florida Statutes, shall be due and payable, in addition to the invoice amount, to the Vendor. Interest penalties of less than one (1) dollar shall not be enforced unless the Vendor requests payment. Invoices which have to be returned to a Vendor because of Vendor

preparation errors shall result in a delay in the payment. The invoice payment requirements do not start until a properly completed invoice is provided to the Department.

Notwithstanding the foregoing, a transaction fee is non-refundable when an item is rejected or returned, or declined, due to the Vendor's failure to perform or comply with specifications or requirements of the Agreement. Failure to comply with these requirements shall constitute grounds for declaring the Vendor in default and recovering reprocurement costs from the Vendor in addition to all outstanding fees. VENDORS DELINQUENT IN PAYING TRANSACTION FEES MAY BE EXCLUDED FROM CONDUCTING FUTURE BUSINESS WITH THE STATE.
- H. A Vendor Ombudsman has been established within the Department of Financial Services. The duties of this individual include acting as an advocate for vendors who may be experiencing problems in obtaining timely payment(s) from a state agency. The Vendor Ombudsman may be contacted at (850) 413-5516 or by calling the Consumer Hotline, 877-693-5236.
- I. Records of costs incurred under terms of this Agreement shall be maintained and made available upon request to the Department at all times during the period of this Agreement and for three (3) years after final payment for the work pursuant to this Agreement is made. Copies of these documents and records shall be furnished to the Department upon request. Records of costs incurred shall include the Vendor's general accounting records and the project records, together with supporting documents and records of the Vendor and all subcontractors performing work on the project, and all other records of the Vendor and subcontractors considered necessary by the Department for a proper audit of project costs.
- J. The Department, during any fiscal year, shall not expend money, incur any liability, or enter into any contract which, by its terms, involves the expenditure of money in excess of the amounts budgeted as available for expenditure during such fiscal year. Any contract, verbal or written, made in violation of this subsection is null and void, and no money may be paid on such contract. The Department shall require a statement from the comptroller of the Department that funds are available prior to entering into any such contract or other binding commitment of funds. Nothing herein contained shall prevent the making of contracts for periods exceeding one (1) year, but any contract so made shall be executory only for the value of the services to be rendered or agreed to be paid for in succeeding fiscal years. - The Respondent has fully informed the Buyer in writing of all convictions of the firm, its affiliates (as defined in section 287.133(1)(a) of the Florida Statutes), and all directors, officers, and employees of the firm and its affiliates for violation of state or federal antitrust laws with respect to a public contract for violation of any state or federal law involving fraud, bribery, collusion, conspiracy or material misrepresentation with respect to a public contract. This includes disclosure of the names of current employees who were convicted of contract crimes while in the employ of another company.
- Neither the Respondent nor any person associated with it in the capacity of owner, partner, director, officer, principal, investigator, project director, manager, auditor, or position involving the administration of federal funds:
  - O Has within the preceding three (3) years been convicted of or had a civil judgment rendered against them or is presently indicted for or otherwise criminally or civilly charged for: commission of fraud or a criminal offense in connection with obtaining, attempting to obtain, or performing a federal, state, or local government transaction or public contract; violation of federal or state antitrust statutes; or commission of embezzlement, theft, forgery, bribery, falsification or destruction of records, making false statements, or receiving stolen property; or
  - o Has within a three (3) year period preceding this certification had one or more federal, state, or local government contracts terminated for cause or default.
- The product offered by the Respondent will conform to the specifications without exception.
- The Respondent has read and understands the Contract terms and conditions, and the submission is made in conformance with those terms and conditions.
- If an award is made to the Respondent, the Respondent agrees that it intends to be legally bound to the Contract that is formed with the State.
- The Respondent has made a diligent inquiry of its employees and agents responsible for preparing, approving, or submitting the response, and has been advised by each of them that he or she has not participated in any communication, consultation, discussion, agreement, collusion, act or other conduct inconsistent with any of the statements and representations made in the response.
- The Respondent shall indemnify, defend, and hold harmless the Buyer and its employees against any cost, damage, or expense which may be incurred or be caused by any error in the Respondent's preparation of its bid.
- All information provided by, and representations made by, the Respondent are material and important and will be relied upon by the Buyer in awarding the Contract. Any misstatement shall be treated as fraudulent concealment from the Buyer of the true facts relating to submission of the bid. A misrepresentation shall be punishable under law, including, but not limited to, Chapter 817 of the Florida Statutes.

- **10. Manufacturer's Name and Approved Equivalents.** Unless otherwise specified, any manufacturers' names, trade names, brand names, information or catalog numbers listed in a specification are descriptive, not restrictive. With the Buyer's prior approval, the Contractor may provide any product that meets or exceeds the applicable specifications. The Contractor shall demonstrate comparability, including appropriate catalog materials, literature, specifications, test data, etc. The Buyer shall determine in its sole discretion whether a product is acceptable as an equivalent.
- 11. Performance Qualifications. The Buyer reserves the right to investigate or inspect at any time whether the product, qualifications, or facilities offered by Respondent, meet the Contract requirements. The Respondent shall at all times during the Contract term remain responsive and responsible. In determining Respondent's responsibility as a vendor, the agency shall consider all information or evidence which is gathered or comes to the attention of the agency which demonstrates the Respondent's capability to fully satisfy the requirements of the solicitation and the contract.

The Respondent must be prepared, if requested by the Buyer, to present evidence of experience, ability, and financial standing, as well as a statement as to plant, machinery, and capacity of the Respondent for the production, distribution, and servicing of the product bid. If the Buyer determines that the conditions of the solicitation documents are not complied with, or that the product proposed to be furnished does not meet the specified requirements, or that the qualifications, financial standing, or facilities are not satisfactory, or that performance is untimely, the Buyer may reject the response or terminate the Contract. The Respondent may be disqualified from receiving awards if the Respondent, or anyone in Respondent's employment, has previously failed to perform satisfactorily in connection with public bidding or contracts. This paragraph shall not mean or imply that it is obligatory upon the Buyer to make an investigation either before or after award of the Contract, but should the Buyer elect to do so, Respondent is not relieved from fulfilling all Contract requirements.

- **12. Public Opening.** Responses shall be opened on the date and at the location indicated on the Timeline. Respondents may, but are not required to, attend. The Buyer may choose not to announce prices or release other materials pursuant to s. 119.071(1)(b), Florida Statutes. Any person requiring a special accommodation because of a disability should contact the Procurement Officer at least five (5) workdays prior to the solicitation opening. If you are hearing or speech impaired, please contact the Buyer by using the Florida Relay Service at (800) 955-8771 (TDD).
- **13. Electronic Posting of Notice of Intended Award.** Based on the evaluation, on the date indicated on the Timeline the Buyer shall electronically post a notice of intended award at <a href="http://fcn.state.fl.us/owa\_vbs/owa/vbs\_www.main\_menu">http://fcn.state.fl.us/owa\_vbs/owa/vbs\_www.main\_menu</a>. If the notice of award is delayed, in lieu of posting the notice of intended award the Buyer shall post a notice of the delay and a revised date for posting the notice of intended award. Any person who is adversely affected by the decision shall file with the Buyer a notice of protest within

- seventy-two (72) hours after the electronic posting. The Buyer shall not provide tabulations or notices of award by telephone.
- **14. Firm Response.** The Buyer may make an award within sixty (60) days after the date of the opening, during which period responses shall remain firm and shall not be withdrawn. If award is not made within sixty (60) days, the response shall remain firm until either the Buyer awards the Contract or the Buyer receives from the Respondent written notice that the response is withdrawn. Any response that expresses a shorter duration may, in the Buyer's sole discretion, be accepted or rejected.
- **15.** Clarifications/Revisions. Before award, the Buyer reserves the right to seek clarifications or request any information deemed necessary for proper evaluation of submissions from all respondents deemed eligible for Contract award. Failure to provide requested information may result in rejection of the response.
- **16. Minor Irregularities/Right to Reject.** The Buyer reserves the right to accept or reject any and all bids, or separable portions thereof, and to waive any minor irregularity, technicality, or omission if the Buyer determines that doing so will serve the State's best interests. The Buyer may reject any response not submitted in the manner specified by the solicitation documents.
- **17. Contract Formation.** The Buyer shall issue a notice of award, if any, to successful respondent(s), however, no contract shall be formed between Respondent and the Buyer until the Buyer signs the Contract. The Buyer shall not be liable for any costs incurred by a Respondent in preparing or producing its response or for any work performed before the Contract is effective.
- **18. Contract Overlap.** Respondents shall identify any products covered by this solicitation that they are currently authorized to furnish under any state term contract. By entering into the Contract, a Contractor authorizes the Buyer to eliminate duplication between agreements in the manner the Buyer deems to be in its best interest.
- **19. Public Records.** Article 1, section 24, Florida Constitution, guarantees every person access to all public records, and Section 119.011, Florida Statutes, provides a broad definition of public record. As such, all responses to a competitive solicitation are public records unless exempt by law. Any respondent claiming that its response contains information that is exempt from the public records law shall clearly segregate and mark that information and provide the specific statutory citation for such exemption.
- **20. Protests.** Any protest concerning this solicitation shall be made in accordance with sections 120.57(3) and 287.042(2) of the Florida Statutes and chapter 28-110 of the Florida Administrative Code. Questions to the Procurement Officer shall not constitute formal notice of a protest. It is the Buyer's intent to ensure that specifications are written to obtain the best value for the State and that specifications are written to ensure competitiveness, fairness, necessity and reasonableness in the solicitation process.

Section 120.57(3)(b), F.S. and Section 28-110.003, Fla. Admin. Code require that a notice of protest of the solicitation documents shall be made within seventy-two (72) hours after the posting of the solicitation.

Section 120.57(3)(a), F.S. requires the following statement to be included in the solicitation: "Failure to file a protest within the time prescribed in section 120.57(3), Florida Statutes, shall constitute a waiver of proceedings under Chapter 120, Florida Statutes."

Section 28-110.005, Fla. Admin. Code requires the following statement to be included in the solicitation: "Failure to file a protest within the time prescribed in Section 120.57(3), Florida Statutes, or failure to post the bond or other security required by law within the time allowed for filing a bond shall constitute a waiver of proceedings under Chapter 120, Florida Statutes."

21. Limitation on Vendor Contact with Agency During Solicitation Period. Respondents to this solicitation or persons acting on their behalf may not contact, between the release of the solicitation and the end of the seventy-two (72) hour period following the agency posting the notice of intended award, excluding Saturdays, Sundays, and state holidays, any employee or officer of the executive or legislative branch concerning any aspect of this solicitation, except in writing to the procurement officer or as provided in the solicitation documents. Violation of this provision may be grounds for rejecting a response.

- **1. Definitions.** The definitions contained in s. 60A-1.001, F.A.C. shall apply to this Agreement. The following additional terms are also defined:
- (a) "Contract" means the legally enforceable agreement that results from a successful solicitation. The parties to the Contract will be the Customer and Contractor.
- (b) "Customer" means the State agency or other entity identified in a contract as the party to receive commodities or contractual services pursuant to a contract or that orders commodities or contractual services via purchase order or other contractual instrument from the Contractor under the Contract. The "Customer" may also be the "Buyer" as defined in the PUR 1001 if it meets the definition of both terms.
- (c) "Product" means any deliverable under the Contract, which may include commodities, services, technology or software.
- (d) "Purchase order" means the form or format a Customer uses to make a purchase under the Contract (e.g., a formal written purchase order, electronic purchase order, procurement card, contract or other authorized means).
- **2. Purchase Orders.** In contracts where commodities or services are ordered by the Customer via purchase order, Contractor shall not deliver or furnish products until a Customer transmits a purchase order. All purchase orders shall bear the Contract or solicitation number, shall be placed by the Customer directly with the Contractor, and shall be deemed to incorporate by reference the Contract and solicitation terms and conditions. Any discrepancy between the Contract terms and the terms stated on the Contractor's order form, confirmation, or acknowledgement shall be resolved in favor of terms most favorable to the Customer. A purchase order for services within the ambit of section 287.058(1) of the Florida Statutes shall be deemed to incorporate by reference the requirements of subparagraphs (a) through (f) thereof. Customers shall designate a Contract Manager and a Contract Administrator as required by subsections 287.057(15) and (16) of the Florida Statutes.
- **3. Product Version.** Purchase orders shall be deemed to reference a manufacturer's most recently release model or version of the product at the time of the order, unless the Customer specifically requests in writing an earlier model or version and the Contractor is willing to provide such model or version.

- **4. Price Changes Applicable only to Term Contracts.** If this is a term contract for commodities or services, the following provisions apply.
- (a) <u>Quantity Discounts.</u> Contractors are urged to offer additional discounts for one time delivery of large single orders. Customers should seek to negotiate additional price concessions on quantity purchases of any products offered under the Contract. State Customers shall document their files accordingly.
- (b) <u>Best Pricing Offer.</u> During the Contract term, if the Customer becomes aware of better pricing offered by the Contractor for substantially the same or a smaller quantity of a product outside the Contract, but upon the same or similar terms of the Contract, then at the discretion of the Customer the price under the Contract shall be immediately reduced to the lower price.
- (c) <u>Sales Promotions</u>. In addition to decreasing prices for the balance of the Contract term due to a change in market conditions, a Contractor may conduct sales promotions involving price reductions for a specified lesser period. A Contractor shall submit to the Contract Specialist documentation identifying the proposed (1) starting and ending dates of the promotion, (2) products involved, and (3) promotional prices compared to then-authorized prices. Promotional prices shall be available to all Customers. Upon approval, the Contractor shall provide conspicuous notice of the promotion.
- (d) <u>Trade-In.</u> Customers may trade-in equipment when making purchases from the Contract. A trade-in shall be negotiated between the Customer and the Contractor. Customers are obligated to actively seek current fair market value when trading equipment, and to keep accurate records of the process. For State agencies, it may be necessary to provide documentation to the Department of Financial Services and to the agency property custodian pursuant to Chapter 273, F.S.
- (e) Equitable Adjustment. The Customer may, in its sole discretion, make an equitable adjustment in the Contract terms or pricing if pricing or availability of supply is affected by extreme and unforeseen volatility in the marketplace, that is, by circumstances that satisfy all the following criteria: (1) the volatility is due to causes wholly beyond the Contractor's control, (2) the volatility affects the marketplace or industry, not just the particular Contract source of supply, (3) the effect on pricing or availability of supply is substantial, and (4) the volatility so affects the Contractor that continued performance of the Contract would result in a substantial loss.
- **5. Additional Quantities.** For a period not exceeding ninety (90) days from the date of solicitation award, the Customer reserves the right to acquire additional quantities up to the amount shown on the solicitation but not to exceed the threshold for Category Two at the prices submitted in the response to the solicitation.
- **6. Packaging.** Tangible product shall be securely and properly packed for shipment, storage, and stocking in appropriate, clearly labeled, shipping containers and according to

accepted commercial practice, without extra charge for packing materials, cases, or other types of containers. All containers and packaging shall become and remain Customer's property.

- **7. Inspection at Contractor's Site.** The Customer reserves the right to inspect, at any reasonable time with prior notice, the equipment or product or plant or other facilities of a Contractor to assess conformity with Contract requirements and to determine whether they are adequate and suitable for proper and effective Contract performance.
- **8. Safety Standards.** All manufactured items and fabricated assemblies subject to operation under pressure, operation by connection to an electric source, or operation involving connection to a manufactured, natural, or LP gas source shall be constructed and approved in a manner acceptable to the appropriate State inspector. Acceptability customarily requires, at a minimum, identification marking of the appropriate safety standard organization, where such approvals of listings have been established for the type of device offered and furnished, for example: the American Society of Mechanical Engineers for pressure vessels; the Underwriters Laboratories and/or National Electrical Manufacturers' Association for electrically operated assemblies; and the American Gas Association for gas-operated assemblies. In addition, all items furnished shall meet all applicable requirements of the Occupational Safety and Health Act and state and federal requirements relating to clean air and water pollution.
- **9. Americans with Disabilities Act.** Contractors should identify any products that may be used or adapted for use by visually, hearing, or other physically impaired individuals.
- **10. Literature.** Upon request, the Contractor shall furnish literature reasonably related to the product offered, for example, user manuals, price schedules, catalogs, descriptive brochures, etc.
- 11. Transportation and Delivery. Prices shall include all charges for packing, handling, freight, distribution, and inside delivery. Transportation of goods shall be FOB Destination to any point within thirty (30) days after the Customer places an Order. A Contractor, within five (5) days after receiving a purchase order, shall notify the Customer of any potential delivery delays. Evidence of inability or intentional delays shall be cause for Contract cancellation and Contractor suspension.
- **12. Installation.** Where installation is required, the Contractor shall be responsible for placing and installing the product in the required locations at no additional charge, unless otherwise designated on the Contract or purchase order. The Contractor's authorized product and price list shall clearly and separately identify any additional installation charges. All materials used in the installation shall be of good quality and shall be free of defects that would diminish the appearance of the product or render it structurally or operationally unsound. Installation includes the furnishing of any equipment, rigging, and materials required to install or replace the product in the proper location. The Contractor shall protect the site from damage and shall repair damages or injury caused during installation by The Contractor or its employees or agents. If any alteration,

dismantling, excavation, etc., is required to achieve installation, the Contractor shall promptly restore the structure or site to its original condition. The Contractor shall perform installation work so as to cause the least inconvenience and interference with Customers and with proper consideration of others on site. Upon completion of the installation, the location and surrounding area of work shall be left clean and in a neat and unobstructed condition, with everything in satisfactory repair and order.

13. Risk of Loss. Matters of inspection and acceptance are addressed in s. 215.422, F.S. Until acceptance, risk of loss or damage shall remain with the Contractor. The Contractor shall be responsible for filing, processing, and collecting all damage claims. To assist the Contractor with damage claims, the Customer shall: record any evidence of visible damage on all copies of the delivering carrier's Bill of Lading; report damages to the carrier and the Contractor; and provide the Contractor with a copy of the carrier's Bill of Lading and damage inspection report. When a Customer rejects a product, the Contractor shall remove it from the premises within ten (10) days after notification or rejection. Upon rejection notification, the risk of loss of rejected or non-conforming product shall remain with the Contractor. Rejected product not removed by the Contractor within ten (10) days shall be deemed abandoned by the Contractor, and the Customer shall have the right to dispose of it as its own property. The Contractor shall reimburse the Customer for costs and expenses incurred in storing or effecting removal or disposition of rejected product.

**14. Transaction Fee.** The State of Florida has instituted MyFloridaMarketPlace, a statewide eProcurement System ("System"). Pursuant to section 287.057(23), Florida Statutes (2002), all payments shall be assessed a Transaction Fee of one percent (1.0%), which the Contractor shall pay to the State, unless exempt pursuant to 60A-1.032, F.A.C.

For payments within the State accounting system (FLAIR or its successor), the Transaction Fee shall, when possible, be automatically deducted from payments to the Contractor. If automatic deduction is not possible, the Contractor shall pay the Transaction Fee pursuant to Rule 60A-1.031(2), F.A.C. By submission of these reports and corresponding payments, Contractor certifies their correctness. All such reports and payments shall be subject to audit by the State or its designee.

The Contractor shall receive a credit for any Transaction Fee paid by the Contractor for the purchase of any item(s) if such item(s) are returned to the Contractor through no fault, act, or omission of the Contractor. Notwithstanding the foregoing, a Transaction Fee is non-refundable when an item is rejected or returned, or declined, due to the Contractor's failure to perform or comply with specifications or requirements of the agreement.

Failure to comply with these requirements shall constitute grounds for declaring the Contractor in default and recovering reprocurement costs from the Contractor in addition to all outstanding fees. CONTRACTORS DELINQUENT IN PAYING TRANSACTION FEES MAY BE SUBJECT TO BEING REMOVED FROM THE DEPARTMENT OF MANAGEMENT SERVICES' VENDOR LIST AS PROVIDED IN RULE 60A-1.006, F.A.C.

**15. Invoicing and Payment.** Invoices shall contain the Contract number, purchase order number if applicable, and the appropriate vendor identification number. The State may require any other information from the Contractor that the State deems necessary to verify any purchase order placed under the Contract.

At the State's option, Contractors may be required to invoice electronically pursuant to guidelines of the Department of Management Services. Current guidelines require that Contractor supply electronic invoices in lieu of paper-based invoices for those transactions processed through the system. Electronic invoices shall be submitted to the Customer through the Ariba Supplier Network (ASN) in one of the following mechanisms – EDI 810, cXML, or web-based invoice entry within the ASN.

Payment shall be made in accordance with sections 215.422 and 287.0585 of the Florida Statutes, which govern time limits for payment of invoices. Invoices that must be returned to a Contractor due to preparation errors will result in a delay in payment. Contractors may call (850) 413-7269 Monday through Friday to inquire about the status of payments by State Agencies. The Customer is responsible for all payments under the Contract. A Customer's failure to pay, or delay in payment, shall not constitute a breach of the Contract and shall not relieve the Contractor of its obligations to the Department or to other Customers.

- **16. Taxes.** The State does not pay Federal excise or sales taxes on direct purchases of tangible personal property. The State will not pay for any personal property taxes levied on the Contractor or for any taxes levied on employees' wages. Any exceptions to this paragraph shall be explicitly noted by the Customer in the special contract conditions section of the solicitation or in the Contract or purchase order.
- 17. Governmental Restrictions. If the Contractor believes that any governmental restrictions have been imposed that require alteration of the material, quality, workmanship or performance of the products offered under the Contract, the Contractor shall immediately notify the Customer in writing, indicating the specific restriction. The Customer reserves the right and the complete discretion to accept any such alteration or to cancel the Contract at no further expense to the Customer.
- **18. Lobbying and Integrity.** Customers shall ensure compliance with Section 11.062, FS and Section 216.347, FS.The Contractor shall not, in connection with this or any other agreement with the State, directly or indirectly (1) offer, confer, or agree to confer any pecuniary benefit on anyone as consideration for any State officer or employee's decision, opinion, recommendation, vote, other exercise of discretion, or violation of a known legal duty, or (2) offer, give, or agree to give to anyone any gratuity for the benefit of, or at the direction or request of, any State officer or employee. For purposes of clause (2), "gratuity" means any payment of more than nominal monetary value in the form of cash, travel, entertainment, gifts, meals, lodging, loans, subscriptions, advances, deposits of money, services, employment, or contracts of any kind. Upon request of the Customer's Inspector General, or other authorized State official, the Contractor shall provide any type of information the Inspector General deems relevant to the Contractor's integrity or responsibility. Such information may include, but shall not be limited to, the

Contractor's business or financial records, documents, or files of any type or form that refer to or relate to the Contract. The Contractor shall retain such records for the longer of (1) three (3) years after the expiration of the Contract or (2) the period required by the General Records Schedules maintained by the Florida Department of State (available at: <a href="http://dlis.dos.state.fl.us/barm/genschedules/gensched.htm">http://dlis.dos.state.fl.us/barm/genschedules/gensched.htm</a>). The Contractor agrees to reimburse the State for the reasonable costs of investigation incurred by the Inspector General or other authorized State official for investigations of the Contractor's compliance with the terms of this or any other agreement between the Contractor and the State which results in the suspension or debarment of the Contractor. Such costs shall include, but shall not be limited to: salaries of investigators, including overtime; travel and lodging expenses; and expert witness and documentary fees. The Contractor shall not be responsible for any costs of investigations that do not result in the Contractor's suspension or debarment.

**19. Indemnification.** The Contractor shall be fully liable for the actions of its agents, employees, partners, or subcontractors and shall fully indemnify, defend, and hold harmless the State and Customers, and their officers, agents, and employees, from suits, actions, damages, and costs of every name and description, including attorneys' fees, arising from or relating to personal injury and damage to real or personal tangible property alleged to be caused in whole or in part by Contractor, its agents, employees, partners, or subcontractors, provided, however, that the Contractor shall not indemnify for that portion of any loss or damages proximately caused by the negligent act or omission of the State or a Customer.

Further, the Contractor shall fully indemnify, defend, and hold harmless the State and Customers from any suits, actions, damages, and costs of every name and description, including attorneys' fees, arising from or relating to violation or infringement of a trademark, copyright, patent, trade secret or intellectual property right, provided, however, that the foregoing obligation shall not apply to a Customer's misuse or modification of Contractor's products or a Customer's operation or use of Contractor's products in a manner not contemplated by the Contract or the purchase order. If any product is the subject of an infringement suit, or in the Contractor's opinion is likely to become the subject of such a suit, the Contractor may at its sole expense procure for the Customer the right to continue using the product or to modify it to become non-infringing. If the Contractor is not reasonably able to modify or otherwise secure the Customer the right to continue using the product, the Contractor shall remove the product and refund the Customer the amounts paid in excess of a reasonable rental for past use. The Customer shall not be liable for any royalties.

The Contractor's obligations under the preceding two paragraphs with respect to any legal action are contingent upon the State or Customer giving the Contractor (1) written notice of any action or threatened action, (2) the opportunity to take over and settle or defend any such action at Contractor's sole expense, and (3) assistance in defending the action at Contractor's sole expense. The Contractor shall not be liable for any cost, expense, or compromise incurred or made by the State or Customer in any legal action without the Contractor's prior written consent, which shall not be unreasonably withheld.

**20. Limitation of Liability.** For all claims against the Contractor under any contract or purchase order, and regardless of the basis on which the claim is made, the Contractor's liability under a contract or purchase order for direct damages shall be limited to the greater of \$100,000, the dollar amount of the contract or purchase order, or two times the charges rendered by the Contractor under the purchase order. This limitation shall not apply to claims arising under the Indemnity paragraph contain in this Agreement.

Unless otherwise specifically enumerated in the Contract or in the purchase order, no party shall be liable to another for special, indirect, punitive, or consequential damages, including lost data or records (unless the contract or purchase order requires the Contractor to back-up data or records), even if the party has been advised that such damages are possible. No party shall be liable for lost profits, lost revenue, or lost institutional operating savings. The State and Customer may, in addition to other remedies available to them at law or equity and upon notice to the Contractor, retain such monies from amounts due Contractor as may be necessary to satisfy any claim for damages, penalties, costs and the like asserted by or against them. The State may set off any liability or other obligation of the Contractor or its affiliates to the State against any payments due the Contractor under any contract with the State.

- 21. Suspension of Work. The Customer may in its sole discretion suspend any or all activities under the Contract or purchase order, at any time, when in the best interests of the State to do so. The Customer shall provide the Contractor written notice outlining the particulars of suspension. Examples of the reason for suspension include, but are not limited to, budgetary constraints, declaration of emergency, or other such circumstances. After receiving a suspension notice, the Contractor shall comply with the notice and shall not accept any purchase orders. Within ninety days, or any longer period agreed to by the Contractor, the Customer shall either (1) issue a notice authorizing resumption of work, at which time activity shall resume, or (2) terminate the Contract or purchase order. Suspension of work shall not entitle the Contractor to any additional compensation.
- **22. Termination for Convenience.** The Customer, by written notice to the Contractor, may terminate the Contract in whole or in part when the Customer determines in its sole discretion that it is in the State's interest to do so. The Contractor shall not furnish any product after it receives the notice of termination, except as necessary to complete the continued portion of the Contract, if any. The Contractor shall not be entitled to recover any cancellation charges or lost profits.
- 23. Termination for Cause. The Customer may terminate the Contract if the Contractor fails to (1) deliver the product within the time specified in the Contract or any extension, (2) maintain adequate progress, thus endangering performance of the Contract, (3) honor any term of the Contract, or (4) abide by any statutory, regulatory, or licensing requirement. Rule 60A-1.006(3), F.A.C., governs the procedure and consequences of default. The Contractor shall continue work on any work not terminated. Except for defaults of subcontractors at any tier, the Contractor shall not be liable for any excess costs if the failure to perform the Contract arises from events completely beyond the

control, and without the fault or negligence, of the Contractor. If the failure to perform is caused by the default of a subcontractor at any tier, and if the cause of the default is completely beyond the control of both the Contractor and the subcontractor, and without the fault or negligence of either, the Contractor shall not be liable for any excess costs for failure to perform, unless the subcontracted products were obtainable from other sources in sufficient time for the Contractor to meet the required delivery schedule. If, after termination, it is determined that the Contractor was not in default, or that the default was excusable, the rights and obligations of the parties shall be the same as if the termination had been issued for the convenience of the Customer. The rights and remedies of the Customer in this clause are in addition to any other rights and remedies provided by law or under the Contract.

24. Force Majeure, Notice of Delay, and No Damages for Delay. The Contractor shall not be responsible for delay resulting from its failure to perform if neither the fault nor the negligence of the Contractor or its employees or agents contributed to the delay and the delay is due directly to acts of God, wars, acts of public enemies, strikes, fires, floods, or other similar cause wholly beyond the Contractor's control, or for any of the foregoing that affect subcontractors or suppliers if no alternate source of supply is available to the Contractor. In case of any delay the Contractor believes is excusable, the Contractor shall notify the Customer in writing of the delay or potential delay and describe the cause of the delay either (1) within ten (10) days after the cause that creates or will create the delay first arose, if the Contractor could reasonably foresee that a delay could occur as a result, or (2) if delay is not reasonably foreseeable, within five (5) days after the date the Contractor first had reason to believe that a delay could result. THE FOREGOING SHALL CONSTITUTE THE CONTRACTOR'S SOLE REMEDY OR EXCUSE WITH RESPECT TO DELAY. Providing notice in strict accordance with this paragraph is a condition precedent to such remedy. No claim for damages, other than for an extension of time, shall be asserted against the Customer. The Contractor shall not be entitled to an increase in the Contract price or payment of any kind from the Customer for direct, indirect, consequential, impact or other costs, expenses or damages, including but not limited to costs of acceleration or inefficiency, arising because of delay, disruption, interference, or hindrance from any cause whatsoever. If performance is suspended or delayed, in whole or in part, due to any of the causes described in this paragraph, after the causes have ceased to exist the Contractor shall perform at no increased cost, unless the Customer determines, in its sole discretion, that the delay will significantly impair the value of the Contract to the State or to Customers, in which case the Customer may (1) accept allocated performance or deliveries from the Contractor, provided that the Contractor grants preferential treatment to Customers with respect to products subjected to allocation, or (2) purchase from other sources (without recourse to and by the Contractor for the related costs and expenses) to replace all or part of the products that are the subject of the delay, which purchases may be deducted from the Contract quantity, or (3) terminate the Contract in whole or in part.

**25. Changes.** The Customer may unilaterally require, by written order, changes altering, adding to, or deducting from the Contract specifications, provided that such changes are within the general scope of the Contract. The Customer may make an equitable

adjustment in the Contract price or delivery date if the change affects the cost or time of performance. Such equitable adjustments require the written consent of the Contractor, which shall not be unreasonably withheld. If unusual quantity requirements arise, the Customer may solicit separate bids to satisfy them.

- **26. Renewal.** Upon mutual agreement, the Customer and the Contractor may renew the Contract, in whole or in part, for a period that may not exceed three (3) years or the term of the contract, whichever period is longer. Any renewal shall specify the renewal price, as set forth in the solicitation response. The renewal must be in writing and signed by both parties, and is contingent upon satisfactory performance evaluations and subject to availability of funds.
- **27. Purchase Order Duration.** Purchase orders issued pursuant to a state term or agency contract must be received by the Contractor no later than close of business on the last day of the Contract's term to be considered timely. The Contractor is obliged to fill those orders in accordance with the Contract's terms and conditions. Purchase orders received by the Contractor after close of business on the last day of the state term or agency contract's term shall be considered void.

Purchase orders for a one-time delivery of commodities or performance of contractual services shall be valid through the performance by the Contractor, and all terms and conditions of the state term or agency contract shall apply to the single delivery/performance, and shall survive the termination of the Contract.

Contractors are required to accept purchase orders specifying delivery schedules exceeding the contracted schedule even when such extended delivery will occur after expiration of the state term or agency contract. For example, if a state term contract calls for delivery thirty (30) days after receipt of order (ARO), and an order specifies delivery will occur both in excess of thirty (30) days ARO and after expiration of the state term contract, the Contractor will accept the order. However, if the Contractor expressly and in writing notifies the ordering office within ten (10) calendar days of receipt of the purchase order that Contractor will not accept the extended delivery terms beyond the expiration of the state term contract, then the purchase order will either be amended in writing by the ordering entity within ten (10) calendar days of receipt of the Contractor's notice to reflect the state term contract delivery schedule, or it shall be considered withdrawn.

The duration of purchase orders for recurring deliveries of commodities or performance of services shall not exceed the expiration of the state term or agency contract by more than twelve (12) months. However, if an extended pricing plan offered in the state term or agency contract is selected by the ordering entity, the contract terms on pricing plans and renewals shall govern the maximum duration of purchase orders reflecting such pricing plans and renewals.

Timely purchase orders shall be valid through their specified term and performance by the Contractor, and all terms and conditions of the state term or agency contract shall apply to the recurring delivery/performance as provided herein, and shall survive the termination of the Contract.

Ordering offices shall not renew a purchase order issued pursuant to a state term or agency contract if the underlying contract expires prior to the effective date of the renewal.

- **28. Advertising.** Subject to Chapter 119, Florida Statutes, the Contractor shall not publicly disseminate any information concerning the Contract without prior written approval from the Customer, including, but not limited to mentioning the Contract in a press release or other promotional material, identifying the Customer or the State as a reference, or otherwise linking the Contractor's name and either a description of the Contract or the name of the State or the Customer in any material published, either in print or electronically, to any entity that is not a party to Contract, except potential or actual authorized distributors, dealers, resellers, or service representative.
- **29. Assignment.** The Contractor shall not sell, assign or transfer any of its rights, duties or obligations under the Contract, or under any purchase order issued pursuant to the Contract, without the prior written consent of the Customer. In the event of any assignment, the Contractor remains secondarily liable for performance of the Contract, unless the Customer expressly waives such secondary liability. The Customer may assign the Contract with prior written notice to Contractor of its intent to do so.
- **30. Antitrust Assignment.** The Contractor and the State of Florida recognize that in actual economic practice, overcharges resulting from antitrust violations are in fact usually borne by the State of Florida. Therefore, the Contractor hereby assigns to the State of Florida any and all claims for such overcharges as to goods, materials or services purchased in connection with the Contract.
- **31. Dispute Resolution.** Any dispute concerning performance of the Contract shall be decided by the Customer's designated contract manager, who shall reduce the decision to writing and serve a copy on the Contractor. The decision shall be final and conclusive unless within twenty one (21) days from the date of receipt, the Contractor files with the Customer a petition for administrative hearing. The Customer's decision on the petition shall be final, subject to the Contractor's right to review pursuant to Chapter 120 of the Florida Statutes. Exhaustion of administrative remedies is an absolute condition precedent to the Contractor's ability to pursue any other form of dispute resolution; provided, however, that the parties may employ the alternative dispute resolution procedures outlined in Chapter 120.

Without limiting the foregoing, the exclusive venue of any legal or equitable action that arises out of or relates to the Contract shall be the appropriate state court in Leon County, Florida; in any such action, Florida law shall apply and the parties waive any right to jury trial.

- 32. Employees, Subcontractors, and Agents. All Contractor employees, subcontractors, or agents performing work under the Contract shall be properly trained technicians who meet or exceed any specified training qualifications. Upon request, Contractor shall furnish a copy of technical certification or other proof of qualification. All employees, subcontractors, or agents performing work under the Contract must comply with all security and administrative requirements of the Customer and shall comply with all controlling laws and regulations relevant to the services they are providing under the Contract. The State may conduct, and the Contractor shall cooperate in, a security background check or otherwise assess any employee, subcontractor, or agent furnished by the Contractor. The State may refuse access to, or require replacement of, any personnel for cause, including, but not limited to, technical or training qualifications, quality of work, change in security status, or non-compliance with a Customer's security or other requirements. Such approval shall not relieve the Contractor of its obligation to perform all work in compliance with the Contract. The State may reject and bar from any facility for cause any of the Contractor's employees, subcontractors, or agents.
- 33. Security and Confidentiality. The Contractor shall comply fully with all security procedures of the United States, State of Florida and Customer in performance of the Contract. The Contractor shall not divulge to third parties any confidential information obtained by the Contractor or its agents, distributors, resellers, subcontractors, officers or employees in the course of performing contract work, including, but not limited to, security procedures, business operations information, or commercial proprietary information in the possession of the State or Customer. The Contractor shall not be required to keep confidential information or material that is publicly available through no fault of the Contractor, material that the Contractor developed independently without relying on the State's or Customer's confidential information, or material that is otherwise obtainable under State law as a public record. To insure confidentiality, the Contractor shall take appropriate steps as to its personnel, agents, and subcontractors. The warranties of this paragraph shall survive the Contract.
- **34.** Contractor Employees, Subcontractors, and Other Agents. The Customer and the State shall take all actions necessary to ensure that Contractor's employees, subcontractors and other agents are not employees of the State of Florida. Such actions include, but are not limited to, ensuring that Contractor's employees, subcontractors, and other agents receive benefits and necessary insurance (health, workers' compensations, and unemployment) from an employer other than the State of Florida.
- **35. Insurance Requirements.** During the Contract term, the Contractor at its sole expense shall provide commercial insurance of such a type and with such terms and limits as may be reasonably associated with the Contract. Providing and maintaining adequate insurance coverage is a material obligation of the Contractor. Upon request, the Contractor shall provide certificate of insurance. The limits of coverage under each policy maintained by the Contractor shall not be interpreted as limiting the Contractor's liability and obligations under the Contract. All insurance policies shall be through insurers authorized or eligible to write policies in Florida.

- **36.** Warranty of Authority. Each person signing the Contract warrants that he or she is duly authorized to do so and to bind the respective party to the Contract.
- **37. Warranty of Ability to Perform.** The Contractor warrants that, to the best of its knowledge, there is no pending or threatened action, proceeding, or investigation, or any other legal or financial condition, that would in any way prohibit, restrain, or diminish the Contractor's ability to satisfy its Contract obligations. The Contractor warrants that neither it nor any affiliate is currently on the convicted vendor list maintained pursuant to section 287.133 of the Florida Statutes, or on any similar list maintained by any other state or the federal government. The Contractor shall immediately notify the Customer in writing if its ability to perform is compromised in any manner during the term of the Contract.
- **38. Notices.** All notices required under the Contract shall be delivered by certified mail, return receipt requested, by reputable air courier service, or by personal delivery to the agency designee identified in the original solicitation, or as otherwise identified by the Customer. Notices to the Contractor shall be delivered to the person who signs the Contract. Either designated recipient may notify the other, in writing, if someone else is designated to receive notice.
- **39. Leases and Installment Purchases.** Prior approval of the Chief Financial Officer (as defined in Section 17.001, F.S.) is required for State agencies to enter into or to extend any lease or installment-purchase agreement in excess of the Category Two amount established by section 287.017 of the Florida Statutes.
- **40. Prison Rehabilitative Industries and Diversified Enterprises, Inc. (PRIDE).** Section 946.515(2), F.S. requires the following statement to be included in the solicitation: "It is expressly understood and agreed that any articles which are the subject of, or required to carry out, the Contract shall be purchased from the corporation identified under Chapter 946 of the Florida Statutes (PRIDE) in the same manner and under the same procedures set forth in section 946.515(2) and (4) of the Florida Statutes; and for purposes of the Contract the person, firm, or other business entity carrying out the provisions of the Contract shall be deemed to be substituted for the agency insofar as dealings with such corporation are concerned." Additional information about PRIDE and the products it offers is available at http://www.pridefl.com.
- **41. Products Available from the Blind or Other Handicapped.** Section 413.036(3), F.S. requires the following statement to be included in the solicitation: "It is expressly understood and agreed that any articles that are the subject of, or required to carry out, this Contract shall be purchased from a nonprofit agency for the Blind or for the Severely Handicapped that is qualified pursuant to Chapter 413, Florida Statutes, in the same manner and under the same procedures set forth in section 413.036(1) and (2), Florida Statutes; and for purposes of this Contract the person, firm, or other business entity

carrying out the provisions of this contract shall be deemed to be substituted for the State agency insofar as dealings with such qualified nonprofit agency are concerned." Additional information about the designated nonprofit agency and the products it offers is available at <a href="http://www.respectofflorida.org">http://www.respectofflorida.org</a>.

- **42. Modification of Terms.** The Contract contains all the terms and conditions agreed upon by the parties, which terms and conditions shall govern all transactions between the Customer and the Contractor. The Contract may only be modified or amended upon mutual written agreement of the Customer and the Contractor. No oral agreements or representations shall be valid or binding upon the Customer or the Contractor. No alteration or modification of the Contract terms, including substitution of product, shall be valid or binding against the Customer. The Contractor may not unilaterally modify the terms of the Contract by affixing additional terms to product upon delivery (e.g., attachment or inclusion of standard preprinted forms, product literature, "shrink wrap" terms accompanying or affixed to a product, whether written or electronic) or by incorporating such terms onto the Contractor's order or fiscal forms or other documents forwarded by the Contractor for payment. The Customer's acceptance of product or processing of documentation on forms furnished by the Contractor for approval or payment shall not constitute acceptance of the proposed modification to terms and conditions.
- **43.** Cooperative Purchasing. Pursuant to their own governing laws, and subject to the agreement of the Contractor, other entities may be permitted to make purchases at the terms and conditions contained herein. Non-Customer purchases are independent of the agreement between Customer and Contractor, and Customer shall not be a party to any transaction between the Contractor and any other purchaser.

State agencies wishing to make purchases from this agreement are required to follow the provisions of s. 287.042(16)(a), F.S. This statute requires the Department of Management Services to determine that the requestor's use of the contract is cost-effective and in the best interest of the State.

- **44. Waiver.** The delay or failure by the Customer to exercise or enforce any of its rights under this Contract shall not constitute or be deemed a waiver of the Customer's right thereafter to enforce those rights, nor shall any single or partial exercise of any such right preclude any other or further exercise thereof or the exercise of any other right.
- **45. Annual Appropriations.** The State's performance and obligation to pay under this Contract are contingent upon an annual appropriation by the Legislature.
- **46. Execution in Counterparts.** The Contract may be executed in counterparts, each of which shall be an original and all of which shall constitute but one and the same instrument.
- **47. Severability.** If a court deems any provision of the Contract void or unenforceable, that provision shall be enforced only to the extent that it is not in violation of law or is not otherwise unenforceable and all other provisions shall remain in full force and effect.

#### 1.0 Introduction

#### 1.1 Description of Services and Locations

The Florida Department of Transportation, Turnpike Enterprise hereafter referred to as the Department under this Contract, requires the Vendor to remove, dispose, furnish, deliver and install heating, ventilation and air conditioning (HVAC) equipment at various locations along Florida's Turnpike (S.R. 91) from Milepost 172.0 to Milepost 312.0, Southern Connector (S.R. 417) from Milepost 0.0 to Milepost 6.5, Veteran's Expressway (S.R. 589) from Milepost 0.0 to Milepost 16.6, the Suncoast Parkway (S.R. 589) from Milepost 16.7 to Milepost 61.0 and the Polk Parkway (S.R. 570) from Milepost 0.0 to Milepost 24.5. The Vendor shall ensure that all materials, equipment and incidentals incorporated into the work area are completely free of any type of asbestos materials.

#### 1.2 Definition of Terms

For the purpose of this Contract, whenever the following terms appear, their intent and meaning shall, unless specifically stated otherwise, be interpreted as shown here below:

- A. **Department:** Florida Department of Transportation, Florida's Turnpike Enterprise, the contracting agency.
- B. **Vendor:** The firm selected through the competitive bid process to provide the services requested herein.
- C. Department's Project/Contract Manager: The individual employee(s) of the Department responsible for the management of the Contract, scheduling and monitoring of work being performed, inspection and acceptance of services provided and approval for payment of services requested herein.
- D. **Vendor's Project Manager:** The individual employee of the Vendor responsible for the management of the Contract, scheduling and monitoring of work being performed, inspection of services provided and the submission of payment documents for all services requested herein. The Vendor's Project Manager is responsible for all communication with the Department and the Department's Contract Manager.
- E. **Supplemental Agreement:** A written Agreement between the Vendor and the Department modifying the original Contract within the limitations set forth in the original Contract and as provided for by law.

F. Work Document (Work Authorization): A work request issued to the Vendor for work required at the contract locations, which will identify the location, describe the work to be performed, and specify pay item quantities authorizing the Vendor to proceed with the work.

## 2.0 Location of Sites and Equipment

All existing locations and equipment are listed in the Attachment "B", attached hereto and hereby made a part of this Contract. Additional sites may be added to or deleted from the Contract by a Supplemental Agreement during the course of the Contract. Such additions or deletions shall not effect or impact the pay item unit prices bid by the Vendor.

#### 3.0 Vendor's Qualifications

The Vendor shall maintain and keep in force throughout the life of the Contract the requirements specified below. Failure of the Vendor to comply with these requirements will be sufficient grounds for the Department to declare the Contract in default and will be subject to the terms of Section 6, Termination and Default, of the Standard Written Agreement.

#### 3.1 Certification/Registration

The Vendor shall hold a valid and current certificate/license as an Air Conditioning Contractor (Class "A" and/or Class "B") or Mechanical Contractor, in accordance with the laws of the State of Florida, authorizing the Vendor to perform the specified work in Osceola, Orange, Polk, Lake, Hillsborough, Hernando and Pasco Counties.

#### 3.2 Business Location

The Vendor shall have a current and valid business tax receipt which states the name of the Vendor, street address of the business where all the work covered under the contract will be handled, and the type of work that the business tax receipt is issued for (which must be for the same type of services required in the contract). If awarded the contract, the vendor shall be required to provide the Department verification of a business tax receipt in the county(ies) the services are being provided prior to contract execution.

#### 3.3 Certification of Experience

The organized business enterprise (e.g., corporation, LLC or sole proprietorship) shall have been licensed and actively involved in providing heating, ventilation and air conditioning (HVAC) services for a minimum of three (3) years. Prior experience shall be specifically related to the installation/replacement of HVAC systems in commercial facilities similar in size, technical scope and volume of work specified in the scope of work for this Contract.

The Department will investigate carefully to determine the Vendor is responsive, responsible and qualified in the area of work contemplated by this Contract.

### 4.0 Scope of Work (Vendor's Responsibilities)

- 4.1 It is the intent of this Contract to replace existing heating, ventilation and air conditioning (HVAC) systems and components with new HVAC systems and components at the locations listed on the Attachment "C". The Vendor shall provide all labor, equipment, tools, materials, hoists/lifts, safety equipment, lighting, transportation, incidentals, etc. necessary to remove and dispose of the existing condensing units, air handlers, package units, metering devices, heaters, curbs, concrete pads, piping and insulation, ductwork, incidentals, etc. as required and furnish and install new HVAC equipment including all incidentals required to provide complete operational HVAC systems which meet all applicable local, state and federal code requirements. The scope shall include, but is not limited to, the following:
  - A. Furnish new HVAC equipment which is completely compatible (voltage, BTU, phase, cooling, heating, tonnage, size, performance characteristics, duct configuration, air handler mounting locations, etc.) with all existing HVAC equipment. Additional equipment requirements are specified in this scope and in the Attachment "C". Approved air conditioning equipment manufacturers for each application are as follows:
    - 1. Administration Buildings (Split Units, See Attachment "B" tonnage): Trane, Carrier and American Standard.
    - 2. Combo Buildings (2 ton Package Units): Trane, Carrier and American Standard.
    - 3. Ramp Plaza Recorder Rooms (1.5 ton Split Units): Mitsubishi, Fujitsu and Liebert.
    - 4. Toll Booths/Toll Booth Conversions (1.5 ton Package Units): Trane, Carrier and American Standard.
  - B. Equivalent manufacturers' equipment shall meet or exceed the specifications of the existing/approved manufacturers' equipment for each application. However, approval and acceptability of all equipment shall be determined by the Contract Manager.
  - C. Immediately upon issuance of the Notice to Proceed (NTP), the Vendor shall visit each site and inspect the existing HVAC systems which are to be replaced. The Vendor shall utilize the information gathered from the site visits to develop their work plan for each HVAC system listed in the Attachment "B". Should the Vendor observe any conditions which might affect the work, the conditions shall be specified in the work plan. All site visits shall be accomplished within fourteen (14) calendar days after the Notice to Proceed.
  - D. The Vendor shall submit a detailed work plan to the Contract Manager at least three (3) weeks in advance of each HVAC system replacement for review and approval. If the work plan includes lane closure(s), the lane closure request(s) shall be submitted four (4) weeks in advance of the replacement work for review and approval. The Vendor shall determine

the number of lane closures and the duration of each lane closure in accordance with the Attachment "A" requirements for each HVAC system to be replaced. The work plan shall fully explain and include the work schedule, work sequencing including Maintenance of Traffic (MOT), time durations for each work operation, method of removing existing equipment, lane closure(s) and duration(s), names of personnel, portable air conditioning requirements, hoisting requirements, all anticipated alterations, fabrications and/or modifications, hours of work, etc.

- E. All new equipment shall fit in the existing spaces, ductwork, curbs, pads, air handler stands, etc. and not cause any obstructions or code violations. The existing concrete pad sizes are listed in the Attachment "C". concrete pads shall extend no less than six (6) inches outside the new condensers. Should the Vendor submit and receive approval of equipment which requires an extension to or replacement of the existing concrete pad(s), the Vendor shall provide the extension or replacement of the concrete pad at no additional cost to the Department. Concrete pads shall be level and on firm ground. The extended or replaced concrete pad shall be Class I Reinforced Concrete installed at the same thickness as the existing concrete pad. The pad extension shall be installed with 1' long, #4 reinforcing steel dowels (epoxied in place), 12" on center, penetrating 6" into the center (thickness) of the existing pad. New pads shall be Class I Reinforced Concrete, 6" thick with #4 reinforcing steel bars at 12" center to center each way. All materials and installation of reinforcing steel, dowels, forms and all related work and techniques shall be in accordance with the applicable sections of the Standard Specifications for Road and Bridge Construction, 2010 Edition, and approved by the Contract Manager. In the event a pad is extended and the protecting bollards need to be relocated, this shall be done at no additional cost to the Department. Bollards shall not restrict access to any side of the unit(s).
  - 1. All relocations, alterations, fabrications and modifications of piping, drywall, chases, sleeves, firewalls, ductwork, air handler stands, skids, acoustical ceiling tiles and grids, hangers, grilles, duct detectors, dampers, curbs, electrical components, pads, etc. to accommodate new equipment shall be the responsibility of the Vendor. Damages to any landscaping, interior/exterior surfaces, structures or building components shall be repaired and restored to its original finish condition. Such restoration and repair services are to be approved by the Contract Manager and performed at no additional cost to the Department.
  - 2. Condensers shall have a minimum 36" clearance on all sides unless the manufacturer specifies otherwise.
  - 3. Package units shall not extend beyond the roof areas.
- F. It is intended that the new equipment be installed and made operational immediately after the removal of the existing equipment. Any preparation work shall be done prior to taking the existing HVAC system off line (i.e. delivery of new equipment and its components to the site, installation of portable air conditioning units and box fans, ductwork fabrication,

disassembling of acoustical ceilings, removal of bollards, extensions to concrete pads, additional electrical work, etc.).

- G. Administration Buildings, Combo Buildings and Ramp Plaza Recorder Rooms shall have sufficient air conditioning at all times. It is required that the Vendor provide, maintain and operate portable A/C units which will keep these areas cool during A/C change out operations. The Vendor shall have personnel available twenty-four (24) hours per day, seven (7) days per week to maintain, repair and/or replace portable A/C units to ensure A/C, as required, at all times. Upon notification of inoperative portable A/C(s), the Vendor shall immediately respond and arrive on site within three (3) hours to correct the problem.
  - 1. Portable A/C units to be used in Administration Buildings shall be 2 ton (24,000 BTU), 20 amp, 220 volts, with 12" diameter exhaust, 30' electric cord and an L6-20 plug. All required portable A/C flexible exhaust duct extensions shall be provided by the Vendor. Portable A/C units to be used in Ramp Plaza Recorder Rooms (includes Combo Building Applications) shall be 1 ton (12,000 BTU), 15/20 amp, 120 volts, with 4 ½" diameter exhausts. A minimum quantity of portable A/C units shall be installed for each application as follows:
    - a. Administration Buildings: Two (2)
    - b. Ramp Plaza Recorder Rooms: One (1)
    - c. Combo Buildings: One (1) in Recorder Room
- H. Vendor furnished A/C units for each application (Administration Buildings, Combo Buildings, Ramp Plaza Recorder Rooms and Toll Booths/Toll Booth Conversions) shall be the same manufacturer and have a minimum Seasonal Energy Efficiency Rating (SEER) of thirteen (13).
- I. Each system shall come with a new digital non-programmable thermostat with lockout capabilities for heating and cooling modes. The Contract Manager will specify the lockout settings for each site. Where applicable, thermostats for heat pump systems with auxiliary and emergency heat capabilities shall be installed.
- J. All package units shall have 5 kw electric heat installed.
- K. When heating portions are to be upgraded as detailed in this scope and in the Attachment "B", the Vendor shall be responsible for upgrading all electrical systems and components (i.e. wiring, conduits, breakers, incidentals, etc.) as per the manufacturer's specifications.
- L. Air handler auxiliary drain pans and high level float switches shall be replaced. High level float switches shall be installed in the condensate drain lines and the auxiliary drain pans.
- M. The Vendor shall furnish equipment which uses R-410A refrigerant. The existing R-22 refrigerant lines and insulation shall be removed and disposed. The Vendor shall furnish and install new refrigerant lines for R-410A refrigerant in the existing sleeves, utilizing the existing chases, hangers, struts, penetrations, etc. End of sleeve openings are to be

sealed with urethane foam; insulate suction lines separately within sleeves and up to units with  $\frac{3}{4}$ " minimum closed cell insulation; pressure test lines by use of nitrogen; evacuate lines for a minimum of two (2) hours at thirty (30) inches of a vacuum in the presence of the Contract Manager; charge refrigerant systems in accordance with the manufacturer's specifications.

- N. The Vendor shall remove and dispose of all existing equipment, materials, refrigerant, piping, curbing, pads, etc. as required. This work includes disposing of all the materials in a licensed disposal site for each type of material and/or equipment as required by law. The Federal Clean Air Act requires that refrigerants must be recovered and not vented, effective July 1, 1992. The Vendor shall have recovery units certified by the Environmental Protection Agency (EPA) to comply with said act and the EPA regulations.
- O. All exterior hardware (nuts, bolts, screws, straps, anchors, clamps, etc.) shall be stainless steel. The Vendor shall anchor all Administration Building Condensing Units in accordance with these specifications:
  - 1. Install stainless steel 1"x1"x1/4" angles at each unit corner (4 in total).
    - a. Secure each angle to concrete with ¼"x2" stainless steel tap cons (2 per angle) and secure angle to unit with #10 stainless steel screws (2 per angle).
  - 2. Install ½" stainless steel eyebolts, embedded into concrete (1 on center of each side, 4 in total).
    - a. Install 1/4" stainless steel cable to eyebolts.
    - b. Install 3/8" eye and eye stainless steel turnbuckle with minimum 6" take up for disconnection/reconnection of strap for service. Provide two (2) straps per unit.
    - c. Provide 2"x2"x½" neoprene pad at each contact point.
- P. The Vendor shall make all efforts to minimize the down time of any HVAC system. The replacement of each individual HVAC system shall be completed within two (2) consecutive twelve (12) hour periods, in accordance with an 8:00 am 8:00 pm work period, Monday thru Friday only, unless directed otherwise on the Attachment "C". No more than one (1) HVAC system shall be replaced at a time at a toll plaza.
- Q. Package Unit Curbs/Curb Adapters/Plenums
  - The Vendor shall connect and/or adapt the new package units to the existing ductwork for all Combo Building and Toll Booth applications. If applicable, the Vendor shall modify the interior supply distribution and/or return grilles, furnish and install stainless steel curbs and/or stainless steel curb adapters. The need for such modifications shall be included in the Vendor's work plan.

- 2. When performing toll booth conversions, the Vendor shall remove and dispose of the existing roof mounted curb, ductwork, brackets, etc. and furnish new stainless steel ductwork (20 gauge) for both supply openings, a new stainless steel curb/plenum (18 gauge) for supply and return use, and a new electrical disconnect to be mounted to the unit itself. The new stainless steel curb/plenum and ductwork joints shall be welded. Condensate drains shall be extended and inserted directly into the booth end roof drain. Multiple drains are available but only one drain line continues to the booth pit floor drain. The Vendor shall verify that the proper drain line is used by removing the access flooring inside the booth (stainless steel to PVC drain pipe connection).
- The Vendor shall insulate and seal curbs/curb adapters/plenums; apply silver/aluminum one hundred percent (100%) silicone at all metal to metal joints and ensure that all joints are thoroughly cleaned and sealed to prevent water from entering Combo Buildings and Toll Booths.
- R. The Vendor shall submit lane closure requests to the Contract Manager at least four (4) weeks in advance of each lane closure for review and approval. The Vendor shall furnish all Maintenance of Traffic (MOT) operations for lane closures (See Section 5.3). Allowable lane closure times and days are listed in the Attachment "A". The Vendor shall make all efforts to keep lane closure durations to a minimum.
- S. If applicable, the Vendor shall remove the existing equipment system placards (AH-1, CU-1, PU-1, etc.) and re-install on the new equipment.
- T. The Vendor shall test and balance the HVAC systems specified in the Attachment "B" in accordance with the standards and guidelines of the Associated Air Balance Council (AABC). Upon completion of each HVAC system replacement, the Vendor shall submit a complete report of the test and balance data.
- U. The Vendor shall provide three (3) Operation and Maintenance Manuals (O&M Manuals) for each type of equipment. The O&M Manuals shall be provided to the Department prior to final acceptance of the project.
- V. The Vendor shall provide a one (1) year labor, material and equipment warranty for each HVAC system furnished and installed, which shall begin from the date of final acceptance of the entire contract. The Vendor shall provide a five (5) year compressor part warranty which shall begin from the date of final acceptance of the entire contract. Three (3) copies of each warranty shall be submitted to the Department's Contract Manager. The final acceptance date will be the date on which the last system is accepted and will be the final acceptance date for all the systems.

## 4.2 General Requirements

#### A. Submittals

At the Pre-Work Conference, the Vendor shall submit a copy of the following documents to the Contract Manager for the Department's review, record, and file:

- The Vendor's licenses as a certified Vendor, authorized to perform the work covered under the contract in all counties within the contract limits, as required by state law and by county or municipal licensing ordinances.
- A list of all personnel anticipated for employment under this Contract, including a minimum of two (2) qualified journeymen or technicians with a copy of their qualifications. All technicians performing work under this Contract shall possess Type II or Universal certification from an EPA approved organization.
- Any new qualified technician to be added to the Contract shall require advanced approval by the Department's Contract Manager. Only the personnel approved by the Department are to be assigned to perform work under this Contract. Such approval shall not be unreasonably withheld.
- 4. A project work schedule which shall include a schedule of values of the services to be performed.
- 5. The Vendor shall provide a copy of all product data, performance characteristics, catalog cuts, etc., necessary to evaluate all equipment (condensers, air handlers, package units, etc.) and accessories (heating equipment, thermostats, refrigerant piping and accessories, conduit, vibration isolators, concrete pads, fire stop, waterproofing sealant, curbs, wiring, ductwork, etc.) to be furnished and installed in this Contract. The Vendor shall make a submittal for all of the above. The Contract Manager has four (4) weeks to the review the submittal from the date of receipt.

#### B. Work Schedule

Any changes, deviations, relevant problems or situations pertaining to the work schedule detailed in the Vendor's work plan or the allowable days and times in the Attachment "C", shall be immediately brought to the attention of the Contract Manager.

#### C. Sign-in and Sign-out

Prior to beginning any work, the Vendor's employees shall immediately report to the Department's Toll Plaza Manager on duty at the appropriate Administration Building and <u>sign-in</u>, completing all information in the visitor's log. All employees of the Vendor shall <u>sign-out</u> after the completion of the work.

#### D. Work Status

- 1. The Vendor shall inform the Contract Manager of the work status on a daily basis.
- 2. Upon completion of the work, the Vendor shall notify the Contract Manager that the work has been completed.

## E. Lighting and Water Source at the Jobsite

- 1. If the existing lighting at the jobsite is not adequate, additional lighting shall be provided by the Vendor. The Department will not be responsible to provide additional lighting that may be required to perform or inspect the work.
- 2. The Department commonly has a water source at each site (except at some of the communication buildings) and will supply water as necessary for the performance of the work. However, if for any reason, water is not available at the jobsite or is not of sufficient volume or pressure, the Vendor shall be responsible for transporting water to the worksite.

#### F. Cleanup

- The Vendor shall remove the existing HVAC equipment and materials from the site and properly dispose of the equipment and materials. The Vendor shall include removal and disposal costs of equipment and materials in the unit prices shown in the Exhibit "C".
- The Vendor shall maintain all work and setup areas in a neat and presentable condition. The Vendor shall collect and remove all surplus, discarded materials and any other trash caused by the work, from the Department property to a proper dumpsite, approved for the disposal of each different type of material.
- 3. No separate payment will be made for cleanup, but all costs thereof shall be included in the unit prices shown on the Exhibit "C".

#### G. Notification of Damages and Damage Repair

The Vendor shall notify the Contract Manager of any damages to the facilities as a result of the Vendor's operations. The notification shall be completed during the next business day and include, at a minimum, the type of damage, location, nature of the incident, time and date of occurrence and injury, if any. The Vendor shall repair all damages within twenty-four (24) hours of the incident or at a time approved by the Contract Manager and at no additional cost to the Department.

#### H. Uniforms

The Vendor's employees shall wear uniforms clearly identifying the company name or logo and the employee's name while at the worksite.

## I. Security

Ramp Plazas and Combo Buildings require key access. Keys are to be signed out from the Administration Buildings at the start of work and returned at the end of work each day.

 Department security doors shall not be propped open at any time. Should the Vendor foresee a need to prop a security door open to accommodate the A/C change out operation, it shall be included in the Vendor's work plan for approval.

#### 5.0 Safety and Worker Protection

- 5.1. The Vendor shall be responsible for initiating, maintaining, and supervising all safety precautions and programs in connection with the work. The Vendor shall take all necessary precautions for the safety of the workers and the public, and shall provide the necessary protection to prevent damage, injury, or loss to:
  - A. All employees on the worksite and other persons who may be affected thereby.
  - B. All work, materials, and/or equipment to be incorporated therein, whether in storage on or offsite.
  - C. Other property at the site and/or adjacent thereto, including trees, lawns, walkways, pavements, roadways, structures, and utilities.
  - D. The Vendor shall assume full liability for compliance with all federal, state, and local regulations pertaining to the protection of workers and persons occupying adjacent Turnpike property.
  - E. The safety or protection of person(s), work, or property at the site or adjacent thereto, the Vendor, without special instruction or authorization from the Contract Manager, is obligated to act to prevent threatened damages, injury or loss. The Vendor shall immediately report such incidents to the Contract Manager.
  - F. The Vendor's employees shall always wear safety glasses when needed and vests with reflective stripes when working on the Department's Right of Way. Hard hats are to be used in areas of overhead hazards.

#### 5.2 Lock-out – Tag-out

The Vendor shall comply with the requirements outlined in OSHA Rule 29 CFR 1910.147. The strict compliance with the requirements of "lock-out – tag-out" are to prevent possible employee injury that may result from unexpected energizing or start-up of equipment while conducting maintenance or repair work.

#### 5.3 Maintenance of Traffic (M.O.T.)

The Vendor's employees shall comply with all traffic regulations pertaining to Part VI of the Manual on Uniform Traffic Control Devices (MUTCD) and Index 667 (Toll Plaza Traffic Control Standards) of the Design Standards for Design, Construction, Maintenance and Utility Operations on the State Highway System, 2010 Edition, Topic No. 625-010-003 (<a href="http://www.dot.state.fl.us/mapsandpublications">http://www.dot.state.fl.us/mapsandpublications</a>) to accommodate traffic in a safe and efficient manner and for adequate protection of the work force and the motoring public. Design Standard Index 667 shall be utilized for the appropriate Index based lane closure plan. The Department's Contract Manager shall be contacted to obtain approval prior to activation.

#### A. Certified Worksite Traffic Supervisor

The Vendor shall provide an on-site Worksite Traffic Supervisor responsible for initiating temporary lane closures and monitoring the installation, maintenance, relocation and eventual removal of all traffic control devices deployed in accordance with Design Standard Index 667. The Worksite Traffic Supervisor shall be certified in the advanced training category by a Department approved training provider.

#### 5.4 U-Turns

No U-turns shall be permitted at median openings, maintenance gates, or such other openings that are intended for the use of emergency vehicles. U-turns shall only be permitted at service plazas or the nearest interchange permitted by law.

#### 5.5 Lane Closure (Short term duration between zero (0) and four (4) hours)

No work shall be conducted by the Vendor in any toll plaza traffic lane until temporary closure of lane is completed by the Vendor and approved by the Toll Plaza Manager or designee. The Vendor shall be responsible for the safety of its employees by ensuring that proper temporary lane closure is complete prior to the start of work within toll plaza traffic lanes. All temporary lane closure required to complete any maintenance or repair work by the Vendor shall be completed by the vendor in strict compliance with the Turnpike's Temporary Lane Closure Policy memorandum and the Turnpike Traffic Control Plan (TCP) see Attachment "A", both documents attached hereto and made a part of this contract. It shall be the sole responsibility of the Vendor to set-up, prior to beginning work and in strict accordance to the TCP, and remove upon completion of the work, the required traffic cones and sign. The Vendor shall use the temporary lane closure equipment stored at the toll plaza and return the equipment upon completion of the work. The Vendor shall advise the Toll Plaza Manager or designee when the work is complete and the traffic lane can be re-opened for use.

#### 6.0 The Department's Responsibilities

#### 6.1 Administration of Contract

All work under this contract will be under the administration of the Florida Department of Transportation.

#### A. Project Manager

The Department has assigned a Project Manager to administer the terms and conditions of the contract. The Project Manager will be Mr. John McAllister, the Facilities Maintenance Manager. Mr. McAllister's office is located in the Turkey Lake Turnpike Operation Center Administration Office at the address shown below:

#### В. Contract Manager

The Department's Contract Manager is Mr. Bernie Rodriguez. Rodriguez will be responsible for the day-to-day work assignments and inspections. All work shall be coordinated through the assigned Contract Manager. Mr. Rodriguez is available at (407) 264-3345.

If any changes are made to the above information during the term of the Contract, the Department will notify the Vendor.

#### 6.2 Pre-work Conference

The Project Manager or the Contract Manager will conduct a pre-work conference with the Vendor prior to the start date of the contract to review the scope of work and other requirements of the Contract.

#### 6.3 Periodic Inspection

- A. Work shall be subject to periodic inspection by the Department. The Contract Manager shall have the right to inspect and reject all work and materials, which do not meet with the requirements of the Contract. Such rejected work shall be corrected at the Vendor's expense. If the Contract Manager fails to reject defective work or materials, whether from lack of discovery of such defect or for any other reason, such initial failure to reject shall in no way prevent later rejection when such defect is discovered. The Vendor shall make no claim for losses suffered due to any necessary removal or repair of such defects.
- В. The Department shall conduct an evaluation of the Vendor's performance at the end of this agreement and any subsequent renewal(s) of this agreement. The "Contractor Field Performance Report" shall be used for this purpose. The Vendor shall have any opportunity to review the report and make comments. The Vendor shall be required to sign the report acknowledging receipt of the performance evaluation.

#### **DURATION OF CONTRACT** 7.0

Work shall commence upon the start date identified in the written Notice A. to Proceed from the Project Manager, 120 calendar days, which includes all submittal approvals, site visits, procurement, replacement work, etc.

Traffic Control Plan (TCP) for Short Duration Toll Lane Closures

Effective upon receipt of this memorandum, the described TCP shall be implemented during all maintenance activities at toll plazas that require short-term lane closures. For the purposes of this memorandum, short-term is defined as a period of time between zero (0) and four (4) hours. A maintenance vehicle may briefly stop in a closed lane, to drop off or pick up equipment only, without setting up the TCP. The layout on the attached diagram shall be the minimum acceptable actions that will be taken in the TCP to affect lane closure. The processes and requirements of this memorandum do not replace or supersede any Office of Toll Operations' policies or procedures for toll lane closures.

### Maintenance TCP Toll Lane Closure

#### A. Scheduling

- Whenever possible, routine maintenance shall not be conducted at a plaza during peak traffic hours.
- The Plaza Manager or Supervisor shall be notified twenty-four (24) hours before a lane is closed for maintenance to address operations at the toll plaza. The manager shall be told of the approximate time required to complete the work.

#### B. Closure

- To close the lane, the maintenance vehicle shall be parked in the lane for the duration of the maintenance activity. In addition, the required traffic cones and "Lane Closed" sign shall be obtained from the plaza and set in place in strict compliance with the attached Traffic Control Plan (TCP) diagram.
  - 2. The lane will be closed initially by plaza staff. This will be done by activating the red traffic light on the canopy and by placing three (3) cones across the lane. The maintenance vehicle shall then be moved into the lane and the remainder of cones and "Lane Closed" sign be put in place as outlined in the TCP.

- The maintenance vehicle shall be parked straight in the lane with the amber lights and flashers activated. The vehicle shall be parked with the wheels turned toward a lane without a booth or an unoccupied booth.
- 4. Personnel working in the lanes shall follow all FDOT safety procedures for working in a traffic lane as outlined in the FDOT Loss Prevention Manual 500-000-015 and other applicable Turnpike Enterprise or other applicable agency procedures. Safety vests shall be worn, as well as hard hats and safety goggles or shoes as required. Proper numbers of personnel when working with an aerial lift or boom truck shall be employed.

## C. Completion of Work

- Upon completion of required work, the maintenance vehicle shall be moved from the lane to an appropriate parking area.
- The "Lane Closed" sign shall be returned to the designated storage place at the plaza.
- Three cones shall be left in the lane and the traffic signal will be left red for closure until reopened by plaza personnel.
- The Plaza Manager shall be notified of the completion of work and will return the lane to service.

Approval must be obtained in advance from the appropriate Regional Toll Manager for any maintenance work that requires closure of a dedicated or express SunPass lane. The Regional Toll Manager will notify the Deputy Director of SunPass Operations. Additional lane closure safety functions are required to close a dedicated or express SunPass lane in accordance with MOT standards.

Telephone numbers for the six Regional Toll Offices and the SunPass Operations Center are as follows:



#### 1. General

The Vendor shall accept the compensation as provided in this Contract as full payment for furnishing all labor, materials and equipment, for performing all work under this Contract, and for all other costs including, but not limited to: tolls, dump fees, fuel, permits, and any documentation required in this Contract. All work specified herein, or implied in any way in the specifications, shall be done regardless of whether or not the work is specifically defined in any bid item.

This is an estimated quantities contract whereby the Vendor agrees to furnish the services specified herein during the term of the Contract. It is further agreed that the unit price bid by the Vendor shall remain unchanged, if the actual quantities used are less or greater than the unit price bid by the Vendor shall remain unchanged.

#### 2. Pay Item Definition (Basis of Payment)

The Department agrees to pay the Vendor for the services performed, an amount of compensation and method of payment as described and detailed herein and in Exhibit "C".

2.1 Remove, Dispose, Furnish, Deliver and Install HVAC Units. Remove and dispose of existing equipment and miscellaneous material, hoist/lifts, lighting, curbs, equipment pads and incidentals.

Payment for this activity shall constitute full compensation for furnishing all labor, materials, expendable supplies, equipment, tools, rented equipment, refrigerant recovery, transporting, maintenance of traffic, lockout/tagout, instruments, dump fees, and ANY other items required to be performed as specified in Exhibit "A". Payment for stored material and/or equipment will not be granted.

A. Payment will be made based on the contract unit prices as shown in Exhibit "C", under the following item numbers:

Pay Item No. 1 through 6, Per each location Remove, Dispose, Furnish, Deliver and Install HVAC Units, per each.

#### 2.2 Unforeseeable Work

When the Department requires work that is not covered by a price in the Contract and finds that such work is essential to the satisfactory completion of the work within its intended scope, the Department will make an adjustment to the Contract.

A. Payment will be made under the established no-bid pay item "Contingency Amount - Do Not Bid". The cost of unforeseen work will be a negotiated amount based on material invoices, equipment costs, labor, etc.

## 3. Method of Compensation

All measurement of payment will be based on the actual amount of work completed and approved by the Contract Manager in accordance with the specifications. Work completed under this Contract shall be measured according to the methods outlined in the basis of payment and shall be paid at the Contract unit price for such activity.

#### 3.1 Compensation

The Vendor shall be paid, per the compensation details in this Exhibit and price schedule in the Exhibit "C" for the work accomplished and accepted by the Contract Manager. The total payment made to the Vendor shall not exceed the maximum amount of the face value of the contract, without Supplemental Agreement being processed. Funding must be approved by the Department for any additional work that would result in exceeding the Contract dollar amount, prior to undertaking such additional work. Compensation shall be made only for actual work performed at the unit measure, quantity and unit cost specified in Exhibit "C".

#### 3.2 Method of Payment

Partial payments shall be allowed for this project. The Department reserves the right to withhold full payment or partial payment of the Vendor's invoice when less than the services listed on the invoice were performed or services were inadequate, not authorized, or not completed.

#### 3.3 Invoicing

A. Payment will be made following receipt and approval of a monthly invoice package for all work performed and accepted by the Department's Contract Manager. The invoice package shall include an itemized monthly invoice and all contract maintenance work documents, as specified in item B and C immediately below. The Vendor's monthly invoice package shall be submitted to the Contract Manager by no later than the 15th of each month. Failure to submit timely invoices could affect the Vendor's performance rating.

The "LABOR HOURS" are the total number of expended hours times the number of employees assigned to perform the work. The information is required for entry into the Department's Maintenance Management System (MMS) only, and not intended as a basis of payment.

- C. A contract maintenance work document issued by the Department for all authorized work must be provided. The Vendor shall include the following information within the submitted work document:
  - 1. Date Received (verified by initials)
  - 2. Date Work Began (verified by initials)
  - 3. Date of Completion (verified by initials)
  - 4. Actual Quantity for each pay item
  - 5. Total cost of the work document

  - 7. Signature of authorized representative
  - 8. Copies of all receipts for parts purchased must be attached

- 3.4 The Vendor shall provide a statement, with all but the first pay request, to the Department which certifies that the Vendor has disbursed to all sub-vendors, laborers, and materials suppliers, having an interest in the Contract, their pro-rata shares of the payment, out of the previous payments received by the Vendor for all work completed and materials furnished in the previous period. This certification shall be in the form designated by the Department (see Attachment "D"). The Department shall not make any payments after the initial payment until the Vendor furnishes said certification, unless the Vendor demonstrates good cause for not making any such required payment and provides written notification of any such good cause to the Department and the affected sub-vendors, laborers, and material suppliers.
- 3.5 Any work performed by unlicensed or unapproved personnel shall result in non-payment.
- 3.6 No compensation shall be paid separately for travel time, expenses, or tolls. Therefore, all the anticipated travel time and travel expenses incurred by the Vendor shall be included in the Vendor's unit bid prices. This should also include charges for the use of Florida's Turnpike, Beachline, Seminole Expressway I and II, Southern Connector Extension or the Daniel Webster Expressway. The Vendor and any subvendor shall pay toll charges for all vehicles and equipment at the standard rate applicable to the general public.
- 3.7 The Vendor shall submit all the outstanding invoices or issues pertaining to the contract within forty-five (45) calendar days of the termination date/last day of the term of the contract. Failure to timely submit the outstanding invoices or issues by the Vendor may be grounds for the Department to close the Contract. The Department shall not be obligated to reimburse the Vendor for any invoice submitted thereafter unless the Vendor has obtained a written exception to the time limit from the Department.
