Duties may include highway patrol and marine patrol. [F.S. 943.10(1)]</p>
B	<p style="text-align: center;">Law Enforcement Officer: Investigator or Inspector</p> <p>Employees of the state who are vested with the authority to bear arms and make arrests and whose primary responsibility is the prevention and detection of crime or the enforcement of the penal, criminal, traffic, boating, or highway laws of the State. Duties may include wildlife and environmental protection and enforcement. Covered occupations include: investigators, inspectors, state park patrol officers, and public defender investigators.</p>
C	<p style="text-align: center;">Pilots</p> <p>Employees of the state who are vested with the authority to bear arms and make arrests; and whose primary responsibility is the prevention and detection of crime or the enforcement of the penal, criminal laws of the state. This classification includes employees who are certified by the Federal Aviation Agency and have been approved as state pilots.</p>
D	<p style="text-align: center;">Reserve, Volunteer, Auxiliary</p> <p>Individuals appointed without compensation, who aid or assist a full-time or part-time law enforcement officers and who, while under the direct supervision of full-time or part-time law enforcement officers, have the authority to arrest and perform law enforcement functions.</p>
E	<p style="text-align: center;">Patrol Officers</p> <p>Employees of the state who are vested with the authority to bear arms and make arrests and whose primary responsibility is the prevention and detection of crime or the enforcement of the penal, criminal, traffic, or highway laws of the State while on the premises of a school or university.</p>
F	<p style="text-align: center;">Firefighter</p> <p>Employees of the state whose primary responsibility is the prevention and extinguishment of fires, the protection of life and property therefrom, the enforcement of state fire prevention codes, and the enforcement of any law pertaining to the prevention and control of fires.</p>
G	<p style="text-align: center;">Militia</p> <p>Active military service of the state. This number is determined by audit at each policy expiration.</p>
H	<p style="text-align: center;">Certified Correctional Officers, Security Officers, Bailiff or Process Servers</p> <p>Employees of the state whose primary responsibility is the protection of personnel, visitors, and facilities or the supervision, protection, care, custody, control, or investigation of inmates within a correctional institution or of persons who are charged with, suspected of committing, or have been convicted of a crime.</p>
