Written notices, formal requests and proceedings must conform with the requirements set forth in Chapter 28-110, Florida Administrative Code (F.A.C.). Protests must be filed with the Purchasing Office, Fish and Wildlife Conservation Commission, Suite 100, 2590 Executive Center Circle, Tallahassee, Florida 32301 within the time prescribed in Section 120.57(3), Florida Statutes and Chapter 28-110, Florida Administrative Code.

**Item #1: Questions and Answers** 

Question #1: Is there an estimated cost or budget for this project?

Answer #1: The estimated budget is \$200,000.

Question #2: Is there an approximate start date for when work will begin?

Answer #2: The approximate start date is January 22. Work may not be performed

during the following dates due to Hilochee WMA hunting seasons: January 5-21, February 8-11, February 15-18, March 9-11, March 22-25

and April 5-8.

Question #3: Will equipment be permitted to be kept on-site during construction?

Answer #3: Yes. The safeguarding of all Contractor equipment left at job sites

(overnight or weekends) shall be the sole responsibility of the Contractor. The FWC does not take any responsibility for damage to

Contractor's equipment left at job sites.

Question #4: What is the duration of the project?

Answer #4: Work must be completed by May 1, 2018.

Question #5: FDOT road base material or only lime rock?

Answer #5: Shell base rock must be Florida Department of Transportation (DOT)

certified shell base rock.

in the Vendor Bid System.
