 - a. The building is approximately 340 feet from north to south, 115 feet from east to west.
 - b. There are approximately 130 user offices/cubicles, 98% currently cabled.
- 2. List of additional equipment that we must purchase to complete the project.
- Scope should include removal of existing wiring.
