#### ARCHITECT/ENGINEER/PROJECT MANAGER:

The Design Professional (architect-engineer, architect, engineer or other professional consultant) identified within these documents (see Section A-1, "Invitation То Bid"), and commissioned by the OWNER, acting directly or through a duly authorized representative.

## **Bidder:**

Any individual, firm, partnership or corporation submitting a proposal for the work contemplated.

## Surety:

The corporate body which is bound with and for the CONTRACTOR, which is primarily liable, and which guarantees the faithful performance of the Agreement.

#### Proposal:

A bid for the work contemplated, which the Bidder shall submit on prescribed forms. (See Exhibit 1, "Bid Proposal Form".)

#### Agreement:

"Agreement" shall mean the document entitled "Agreement Between OWNER and CONTRACTOR." (See Exhibit 3 for prescribed form of agreement.)

## Threshold Building:

As defined in Section 553.71, Florida Statutes, a Threshold Building is any building greater than three stories or 50 feet in height, or which has an assembly occupancy classification that exceeds 5,000 square feet in area and an occupant content of greater than 500 persons. Special inspection requirements apply to such buildings under Section 553.79(5), Florida Statutes.

# **B-2 BIDDER'S QUALIFICATION REQUIREMENTS AND PROCEDURES**

Bidder qualification requirements are established herein in accordance with the Owner's established procedures (CFOP 70-7), and the standard "General Instructions to Respondents" Form PUR 1001 (10/06) is hereby incorporated into this ITB by reference as if fully recited herein.
