This addendum is to provide all potential bidders with answers to questions received in reference to Invitation to Bid ITB/FFS-17/18-05. **Deletions are struck through, and additions are highlighted.**

Questions/Answers

1. Could we get a copy of this documentation, "The completed machine must meet all safety requirements and regulations related to FFS equipment/fire service at the time of manufacturing".

2. Would you consider extending the bid date an extra week?

At this time, the bid opening date and time will not be extended.

3. Would you consider a Caterpillar D4K LGP?

No. The D4K LGP is not an approved equivalent.

4. Your specification asks for 6 "D" rings; you only give mounting locations for 4

To clarify, there are two (2) roller frames. There shall be two (2) "D" rings attached to each roller frame securing the crawler dozer during transport. This is a total of four (4) "D" rings on the roller frames. There shall be two (2), "D" rings for rear pull points.

To the extent this addendum gives rise to a protest, failure to file a protest within the time prescribed in Section 120.57(3), Florida Statutes, shall constitute a waiver of proceedings under Chapter 120, Florida Statutes. All other terms, conditions and specifications of this Invitation to Bid will remain the same.
