QUESTIONS AND ANSWERS

- Question 1:** In filling out the paperwork for Proposal #2020C-13. In section 5.102 what does the term C/JV mean?
Response 1: *C/JV means Joint Venture: Identified when two independent companies legally joint together to form a third company solely to perform the scope of work in which proposing/contracting for.*
- Question 2:** Is the parent company referring to my company?
Response 2: *A "Parent Company" is a company in which owns a company "Subsidiary Company". Company type definitions can be located on the Federal Internal Revenue Service's web-site.*
- Question 3:** What are the current price for pressure washing? Based on the current RFQ pricing sheet?
Response 3: *Refer to Addendum #1, current contract previous prices is attached as Attachment "E" titled "RFP 2014C-22 Section 5.40 Total Cost/Value Matrix." Refer to paragraph 2.03 of the solicitation for the contract cost history.*
- Question 4:** If our company currently has an application pending for a Minority Business Enterprise (MBE) designation with the State of Florida, may we submit the Section 5.10 Attachment B (MBE Enterprise Certificate) with the proposal? This would be based on known State approval/designation prior to contract selection/award but possibly not prior to deadline to submit the proposal.
Response 4: *Section 5.10 Attachment B (MBE Enterprise Certificate) MUST BE SUBMITTED with the proposal whether claiming Minority Business Status OR not. Your firm may "Self Identify" your firms' minority type on the form until application completion.*
